There are a dozen "favorites," the highest being Billy Fitzgibbons, conductor on the Brookfield branch, with about 7,000 votes. LEGISLATIVE NOTES.

In continuation of the personal notes furnished by our Special Correspondent at Hartford, the first instalment of which appeared in our yesterday's Daily, the following items of local interest are given :

Mr. A. W. Merwin, of Wilton, who published his resignation recently, commanded the attention of the House when he rose and read the statement that although his opponent in the last election had a plurality, it was obtained through bribery, and he would retain his seat against corruption.

The sequel to this is a rumor in circulation, that he has procured, for fifteen dollars, the affidavit of a man at Gilbert & Bennett's Wire Works, who swears he was paid a dollar to vote for Chichester. Such audacious corruption as this Mr. Merwin will not condone, but will contest to his last drop of blood. Mr. Chichester says he knows nothing of the case, and as for the man who thus blackens his own character and exposes himself to a conviction and term in states-prison, Mr. Chichester says, he don't think he has spoken to him in ten years. No one, however, seems to doubt the ultimate seating of Mr. Chichester.

The democrats got a slight advantage of the republicans in the House on Wednesday, in the shuttle-cock game of examining the returns, thus carrying the first strategic position.

Big-headed and big-hearted Sam. Fessenden was ubiquitous, and as 'childlike and bland" as ever. Lynde Harrison and "Doc." Coolidge wore that far-away look of "parallel railroad anxiety" that is making both of them prematurely old. Those who awaited the presentation of Senator Seymour's promised State R. R. building schemes, among his multitudinous resolves submitted to the Senate, were doomed to disappointment. It had been expected that this peculiar scheme, so near our Senator's heart, would have been the first one for him to eject from his sys-

Ex-Senator Hill was dashing about, here, there and everywhere, like Henry of Navarre, the intensest anxiety and solicitude depicted in his dilated eyes and nostrils, but when he assured his friends that he should stand by, as long as there was a republican plank to float upon, all felt sure that our good Commonwealth was safe.

Mr. Maples was universally around, and wore his usual sardonic smile, but when the House convened, he quietly seated himself at a table in the southeast corner of the lobby, saying in every feature, that he was resolved that, with entire impartiality, not a particle of wreckage should escape his drag-net, in the event of a general smash-up, or going down, of old Connecticut's ship of State.

The House took a recess yesterday till the 20th, when it will reconvene and proceed to re-elect Senator Platt. At the date of departure, the House was a few points ahead, with the Senate in a hole, and the future big with possibilities.

Norwalk's prompt and clear headed Representative, Gen. Charles Olmstead, has occupied the presiding officer's chair more during the week than any one else. Young Speaker Paige, has thus far shown himself an easy master of the situation.

During a lull in the Senate proceedings yesterday morning, Senator Ed. S. Cleveland was seen with both arms clasped around the rotund form of Editor Byington of the GAZETTE, and giving him a most vigorous bear-hug before all the Senate. When fire and water was seen to so affectionately mix, every one seemed to experience a feeling of relief in the conviction that if such "brotherly fove was to continue" there would soon be an end to the political deadlock. They must have been a long time, warm personal friends, despite their political differences.

The Senate has declared the Democratic state officers elected as shown by the face of the returns, while the House has referred the returns to a House committee for an investigation. After the House has amended its rules so that a recess for any length of time might be taken without concurrent action by the Senate, a motion to During the recess the committee will canvass the returns. When the House meets again on the 20th it will still be in its first legislative day.

To-day was the Senate's second legislative day, and it was ended by adjourning until Tuesday. The day in the Senate was mostly spent in taking recesses.

Gov. Bulkeley remains governor, and it looks as if he would be, for an indefinite period. The House committee of inquiry into the canvass of votes for state offices held a session this afternoon. All the members, republicans and democrats, were present. They

discussed the scope of their inquiry, and without final action adjourned to Wednesday at 10 a.m. The democrats of the House held a caucus immediately after recess to consider a nomination for United States Senator, but decided not to hold caucus until the evening of Jan. 19th, so up to date the country is safe.

MR. HILL'S SPEECH.

The following is the able and eloquent speech made by Ex-Senator Hill, before Buckingham Post, G. A. R., Wednesday evening:-

Gentlemen:-I cannot talk to you tonight as a member of the Grand Army of the Republic, for though I was with you nearly three years in the field and again and again saw the brave acts and soldierly deeds of the Boys in Blue, it was in the capacity of a military clerk, and not as an enlisted soldier, but I know whereof I speak, when I say that every faithful soldier of the Union army deserves all of the credit, all of the honor and all of the reward that a grateful nation can bestow. But as a member of the Sons of the American Revolution, as a descendant of a Revolutionary patriot, who fought to secure the freedom and found the Nation, which, by your valor you have saved, I can speak to you and wish you God speed in your efforts to promote the spirit of patriotism, to inspire your children a love for the old flag, and to hand down to them a heritage that will be more precious than gold—the splendid memory of a father who fought to save the land where they will dwell. I am glad that your organization exists, glad that it is so strong and flourishing, for in it and through it, you are doing the work of preserving the mementoes and registering the deeds of the men who stood for the right in the grandest struggle of the world's history. See to it that the humblest name is not forgotten or overlooked, for bye and bye in the generations to come, many a young man's heart will swell with pride as he points to the muster roll of the Grand Army and proves his kinship to the hero gone. There is something more to life than dollars and cents. Think you, which was the greater? Paul, the prisoner at Jerusalem, a freeborn Roman citizen, or his captor, the man who purchased the honor with

We are yet too near the events in which you participated to understand their importance or appreciate their results. In one thing, we can all rejoice to-day, that nowhere in this broad land, can the foot-fall of a slave be heard, but if this were all, the price that the nation paid was none too great.

As men of Connecticut, as citizens of this Republic, living in the last decade of the nineteenth century, you can look back upon the deeds of the men who founded a state two hundred and fifty years ago, and in 1776 builded a nation and know that when the twentieth century shall have rolled its course, you too will be ranked with them.

And that record is a glorious one. Pardon me if I briefly review it.

As citizens of Connecticut we may well be proud of our state. On the 14th of January, 1639. she adopted the first written constitution ever made, wherein 'all civil affairs were to be guided and governed by laws, rules and orders, which the people themselves might make."

At that time, Charles the First reigned in England, an absolute monarch without a parliament for the preceding eleven years, the thirty year's war was raging on the continent of Europe, and Louis the Thirteenth was sitting on the thrown of France while Richelien was doing his thinking for him.

At such a time when liberty seemed to be dying out of the world, the Rev. Thomas Hooker, of Hartford, declared (and the men of Connecticut ratified the declaration) that "the foundation of authority was laid in the free consent of the people." To that declaration thus made, the descendants of these men have ever since been true.

In that constitution, though made by an English Colony, no allegiance is expressed to the English king, no acknowledgment of authority is given, except to Almighty God and the suffrage of the people. That authority and that only, Connecticut acknowledges to-day.

When in 1764 a stupid king and a stubborn prime minister announced their purpose to tax the colonies, Connecticut was first to protest and "to firmly insist on the exclusive right of the colonies to tax themselves," and when the injustice of England could be no longer borne, the first aggressive, action of the Revolution was planned by her citizens, paid for from her treasury, and Ticonderoga was taken in the name of Jehovah and the Continental Congress.

In the war that followed, Connecticut bore no laggard's part. She furnished more men in proportion to her population and more aid in proportion to her wealth, than any other colony.

In 1775 her entire population numbered but 198,010, and yet thirty thousand of her sons fought for liberty, and the muster rolls of the Revolution, at the close of the war, contained the names of more Connecticut citizens than she had able bodied men at home at its beginning.

But not in numbers only, did she

easily excel. The names of her soldier heroes are precious memories to the nation still, and from her school of freedom, then more than a century old, she gave to

bassadors and financiers, who did a work so grand and strong that we are enjoying its fruits to-day.

Their deeds are written clear and bright on every page of our country's history and as long as the Republic shall endure, the names of Putnam and Trumbull, Wolcott and Sherman, Wooster and Hale, shall bring honor and glory to their native state.

Brothers, you and I can add no laurels to the crowns of men like these. But of that vast throng unnumbered

and almost forgotten who in the words of the Apostle Paul "through faith subdued kingdoms, wrought righteousness out of weakness were made strong, waxed valiant in fight, and turned to flight the armies of the aliens, men of whom the world was not worthy," has not "God provided some better things for us" that in and through us their names and memories may be cherished and preserved?

They fought in faith for that which we enjoy, little dreaming of the greatness of their work. It is yours to hand down to your sons, the heritage bequeathed to you, grander, greater and purer still, because in your lives and actions you have shown that their deeds and names were not forgotten.

They fought for liberty, but it was liberty under law. Let us see to it that that liberty is not turned to license and that our laws are honestly adminis-

They hoped for equality but it was not an equality of station and surroundings. Their hopes will be fulfilled only when we give to every man in this whole land equal privilege, equal opportunity and an equal chance to prove himself a man.

Oppressed by a tyrant, robbed by unjust taxation, with no voice in the determination of their own affairs, they rebelled to secure self-govern-

Are we doing our duty as citizens and desendants of those men, when we shut our eyes and calmly submit at the polls and in our legislative halls to bribery and corruption which practically disfranchises the honest intelligent and educated voter, or makes his vote of no effect.

You may not have to fight again the battles which the Grand Army fought and won, but brothers, so long as false counting and fraud in one part of this land and vote selling and vote buying in another are determining factors in the elections of this nation, so long is the republic in danger and we the victims of a worse tyranny than that which our fathers struggled to over-

We measure the life of man by years, of a Nation by centuries. As a republic we are yet in our infancy. If at the very foundation of our politics we put an honest count of an honest vote cast in the fear of God, we shall flourish and be strong among the peoples of the

and be strong among the peoples of the earth, for "Righteousness exalteth a nation but sin is a reproach to any people."

May the time soon come through our efforts as individuals and our influence as organizations when every voter shall be intelligent and patriotic and every vote a free and honest one.

Root Pruning of Fruit Trees.

An English pomologist gives his ideas as follows on the subject of root pruning: The operation should be performed as soon after the crops have been gathered as possible. Open a trench about eighteen inches wide at from two to three feet from the stem of the tree, giving more or less distance according to the age and size, and about the same depth, working the soil out pretty well from underneath the roots, with a view of severing any top or perpendicular ones that may be there, and cutting all those in the prescribed space clean away in the operation. If the trees are vigorous and the natural soil in which they are growing is good, it may be returned to fill up the trenches without additions of any kind being made. But, on the other hand, should both trees and soil show signs of debility, the trenches should be filled in with good, fertile loam, and the improvement in the crops in succeeding years will well pay for the trouble and labor. Really fruitful trees are often benefited as much by not pruning as by the pruning of the shoots. The slight check in growth leads to the production of short jointed limbs and the formation of strong, healthy fruit buds.

SAVAGES BURN A TOWN.

The Idaho Bannocks Now Take Their Turn on the Warpath.

ALL QUIET AT PINE BIDGE.

The Military Now Exercising a General Supervision Over Everything, and the Situation Looks Favorable for a Peaceful Settlement.

POCATELLO, Idaho, Jan. 9.—The Indians on the Fort Hall reserve are on the warpath and have taken possession of this town. They have already set fire to a number of buildings, and have announced their determination to complete the destruction of the place.

BOISE CITY, Idaho, Jan. 8.-Advices received from Pocatello, Idaho, state that the Indians on the Fort Hall reserve have been dancing, and 200 in war paint have taken to the mountains with arms, causing great excitement. Governor Wiley has been asked to order the militia to Pocatello, and probably a company of United States cavalry at Boise barracks will be sent there.

The Indians on the reserve number 1,200 or 1.500, more than half of whom are Bannocks, who caused the prolonged war twelve years ago. The people of Pocatello have almost no arms, and the towns of Blackfoot and Eagle Rock are on the border of the reserve. The Indians who took to the mountains are working eastward toward Wyoming. The belief is expressed that if the Indians at Pocatello go on the warpath they will be joined by the tribes on Lemhi reservation, who number 500, embracing 125 able bodied bucks.

An Attack of the Craze.

WATERLOO, Ia., Jan. 9.—It is reported here that the Musquake Indians, located in the southern part of Taman county, have an attack of the Messiah craze, and there is apt to be an outbreak at any time. There are about 300 of them. The Government Greys, the Muscatine Rifles and two companies I. N. G. have been ordered in readiness, and it is expected that the company here will receive orders very soon.

"We Are All Hostiles Now."

SPRINGVIEW, Neb., Jan. 9.—Chief Yellow Horse, formerly lieutenant of the Indian police at Rosebud agency, passed through this town with considerable following. When asked if he was not afraid to meet the warring element of his tribe he replied: "No; we are all hostiles now."

Yellow Horse was supposed to be friendly. Switt Bear and his band, formerly of the same agency, also declared for war. Both chiefs are supposed to be bearing for the hostile camp near Pine Ridge.

Peaceful at Pine Ridge.

PINE RIDGE, S. D., Jan. 9.-A much needed change has taken place in the management of affairs at this agency. In accordance with the instruc-tions received from President Harrison, to have the control of the Indian campaign trnsferred to the jurisdiction of the war department, Capt. Ewers, of the Fifth infantry, has taken hold, and from now on will exercise a general supervision over everything. Royer will retain his position as civil agent, but will really have nothing whatever to do with the management of the agency, the position which he will occupy being merely a clerical one. The change gives satisfaction to every one, and restores confidence among the residents

The situation looks more favorable for a peaceful settlement. Runners from the hostile camps and prominent chiefs from the Ogallalas, who, with their people, have been forced to remain at that place, have been into the agency and have held a conference with Gen. Miles. They all declare that it never had been the intention of the Pine Ridge Sioux to take up arms against the whites, and that such a step was the last thing contemplated by them.

Miles Will Make Short Work of It. Numerous small bands kept slipping away from the hostile camp and reporting at the agency, and soon there will be none left at that camp but the Brules, the Indians who first precipitated the trouble. Red Cloud and his band will in all probability arrive at the agency Friday. Little Wound, one of the best and most powerful of the Pine Ridge Sioux, will also come in.

Later reports are to the effect that all the Sioux will come in. Brules and all. Gen. Miles expects to close the campaign within the next few days.

The court of inquiry which was to have been convened Wednesday in the case of Col. Forsythe, of the Seventh regiment, did not meet, and it is not thought it will for some time to come.

BUFFALO, N.Y., Jan. 9.—Mr. A. J. Wright, of the firm of A. P. Wright & Co., was asked Thursday morning what he had to say to the charge of the assignee of Bate man & Co., to the effect that his firm ob tained certain stocks in an irregular manner. Mr. Wright replied that the statement published is full of inaccuracies. have not taken anything but what belonged to us. Bateman & Co. on Monday of this week owed us \$54,000. THE ALLIANCE WORSTED.

The Supreme Court Issues a Mandamus Compelling the Speaker to Canvass the Returns, Which is a Point in Favor of Governor-elect Boyd.

LINCOLN, Neb., Jan. 9.—The proceedings n the Nebraska legislature Wednesday afternoon were of a most extraordinary character. At 3 o'clock the senate and house assembled in joint session for the purpose of canvassing the vote on state officers as prescribed by the constitution. Trouble was precipitated at the outset by a misunderstanding as to which officer should preside over the joint convention. Lieutenant Governor Mickleiohn advanced to the chair to preside, claiming his right under the constitution, the statutes, and the uniform practice of the state. Speaker Elder, of the house, refused to vacate, and the two officers occupied chairs side by side, claiming the gavel.

The speaker attempted to call the body to order, but was himself called to order by the lieutenant governor. The hall was crowded and the excitement was intense, but no demonstration was made beyond some loud talking and a number of motions to change the plan of proceeding to the canvass. These motions were declared out of order. The official returns were brought in by the secretary of state and laid before the body.

A Deadlock. The speaker was directed by the lieutenant governor to open the package and read the returns. He began the work, but was advised by the attorney for the independent party not to do so. He then refused to go on with the work. The lieutenant governor ruled that no business could be transacted until the returns were canvassed, and this brought on a deadlock. The joint convention sat for nearly four hours, the time being taken up by oratorical fencing and labored argument from each side to prove that the other side was in the wrong. At 7 o'clock a recess was taken until Thursday morning.

The point involved is this: The inde-

pendent or Alliance party is contesting the election of the Democratic governor and the remaining state officers, who are Republicans. They wish to prevent the announcement of the election of these officers, evidently preferring to seat the contestants directly. Lieutenant Governor Meikeljohn, who is a Republican, holds that it is his duty to declare the officers having a majority on the face of the re-turns elected, and if there is to be a contest it must be begun in the regular way after this announcement of election is made. That was the point of contention in the struggle.

An Appeal to the Courts.

Thursday morning all the doors of the representative hall were closely guarded, and none but members of the legislature, state officers and persons having business inside were adminted. All members were on hand promptly, although they found great difficulty in pushing their way through the crowds that filled the corri dors and besieged the Capitol at all points. The Alliance members had taken posses sion of the house at 5 o'clock in the morning. They placed the speaker in the chair, four adults severely, if not mortally, and put a cordon of assistant sergeants-atarms around him. President Miller, of the St. Paul, called the meeting to order in one of the hotel parlors. The doors were closed, and the board proceeded to organize by the adoption of bylaws and rules to govern their future actions. The general expression previous to the meeting was that the proceedings would be harmonious, and would accomplish all that was called for.

DIED IN ITS INFANCY.

The Window Glass Trust Goes to Pieces. Another Combine Formed.

PITTSBURG. Pa., Jan. 9.—The American Window Glass company, of Chicago, which was chartered in Illinois some months ago with a capital stock of \$400,000, and was designed to act as a cover for a huge window glass trust, now exists in name only. It leaked out yesterday that at the meeting of the executive committee of the concern, held in this city last Tuesday, action was taken which practically dissolves the company. At the committee meeting it was decided to notify all the subscribers that their subscriptions to the stock would not be considered binding if they desired to withdraw. A well posted member said that the trouble was caused by the non-payment of subscriptions.

It was learned on good authority yester-day that nineteen of the leading glass ta-bleware manufacturers of Ohio, Pennsyl-vania and West Virginia have formed a combine, the object being to avoid waste of money during dull seasons.

CAROLINE ISLANDERS REVOLT.

Three Hundred Foreigners Killed and More Massacres Expected.

SAN FRANCISCO, Jan. 9.—The recently appointed American consul to the Caroline islands, Mr. Herbert L. Rand, of Carthage, Ills., is here on his way to the scene of his duties. He has just received letters from his brother, who has been a missionary on the islands for eighteen years, giving an account of outrages committed by natives.

In their revolt against the Spaniards the natives have killed 300 foreigners, including 190 Spanish soldiers. They have looted and burned the houses of all the missionaries at Ponopi. Rev. Mr. Rand lost his library, worth \$1,000, and all his personal and household effects.

The missionaries have been transferred

to a neighboring island for safety, but the natives of the whole group are excited and more massacres are feared.

Cattle That Will Sell.

A firm of cattle brokers that have been in the business twenty-six years in a large city report one certain week last October to have been about the dullest they have ever known. The cause of the dullness was partly that there were brought to the city in that week 88,000 head of beeves to be disposed of. But the prime cause was that the cattle sent in were not fit to sell. They were not fat enough. The dealers recommended their customers near home to keep their beeves a couple of months longer and feed them heavily, so that when the far western cattle had all come in and been disposed of the home beeves could be brought in and their owners "get something for them."

The kind of cattle that are a drug in the market, that pull the price of all down, that are always with us and yet that nobody wants, are described thus:

"The hardest to sell are and the greatest decline is on steers of eleven hundred to fourteen hundred pounds average, half to three-quarters fat-what a good many shippers call fat before shipping. There has been just one load of prime cattle on the market this week out of 88,000 cattle, and they brought 51 cents."

Cattle raisers will learn from the above what kind of cattle not to ship.

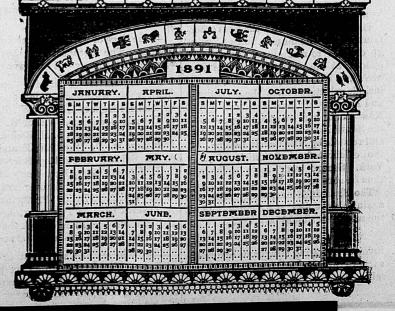

THE WEATHER.

AN ECCLESIASTICAL TRIAL.

The Rev. Howard MacQueary of Canton, Ohio, is being tried this week by the Episcopal diocese in which he resides, on a charge of heresy. The counts of the indictment are two: One is that he doubts or disbelieves the article of the Apostles' creed which says that Jesus Christ was "born of the Virgin Mary;" the other, a similar constructive rejection of the latter article of the same creed, "the resurrection of the body." The real issue, however, as now appears, is not whether Mr. MacQueary is within the limits of orthodoxy in interpreting the Hebrew word for "virgin" (as used in the Old Testament prophecy translated "a virgin shall be with child") as meaning merely "young woman;" nor is it whether "the resurrection of the body" necessarily means the actual re-collection of the particles of matter that constitute a man's body as buried at his funeral. For the real question is the Protestant claim to the right of private judgment.

Hundreds if not thousands of the over 4,000 Episcopal clergymen in the United States, and thousands of ministers in other Protestant denominations who utterly reject his interpretation of these two doctrines of the most concise creed of orthodoxy, are heartily with him in affirming his right to interpret them in that way if he chooses, and still to remain in good standing as a minister of a Protestant sect. They claim that the one principal which Protestant sects have in common is the right of private judgment, exercised in the light of intelligent reading of the Bible. For this reason Mr. MacQueary's trial rises above the comparative unimportance of a mere church prosecution for heresy, and becomes an event of importance to the whole religious world.

EMMA ABBOTT.

We will never more see poor Emma Abbott's smile or hear her resonant stage kiss. It can be said of her that she was as highly respected as she was popular, and the pleasure she has given to many thousands by the melody of her voice will not be forgotten until her last hearer has followed her to the grave. And the dramatic profession owes her a debt of gratitude as well as the public. It was Emma Abbott who rose and spoke out in a Tennessee prayer meeting in protest against the sweeping charge of a bigot that all the women of the stage are immoral. That speech opened the eyes of a good many who had been blind from prejudice, and made the country at large a little more just to those who stand and a little more charitable to those who fall before the temptations of a most exacting life.

A BRUTE USES VITRIOL.

He Blung a Bottle of It in the Face of His Father-in-Law.

A FIENDISH SON OF ITALY.

He Abused His Young Wife Till She Fled to Her Parents' Home-Then He Shot at Her and Attacked Her Father-A Villainous Career.

NEW YORK, Jan. 9.-Pretty little Rosie, the 16-year-old daughter of Louis Martra gelo, an Italian street sweeper, went out from under her father's roof less than twelve months ago the blushing bride of Alfonso Braggo, her countryman, who had wooed her for a year and won by sheer persistence. He was more than twice the age of Rosie, ugly of looks and deeply scarred by smallpox. His reputation was not of the best, and he was known to be quarrelsome to boot. There was no lack of croakers at the wedding to predict that the union would come to no good in spite of Braggo's soda water factory that promised to Rosie a better support than she could have got by marrying on her own level—the level of the dump.

That was the consideration that had per suaded the old street sweeper to give his daughter to Braggo, and as he sat talking it over by the stove with her mother in their tenement, that seemed lonely without Rosie, they agreed between pulls at their black clay pipes that she was a good girl and that it would come out all right.

But it did not come out all right, though Rosie tried her best to be a good wife to her master, to whom she had been thus sold, body and soul. Before many days he began to growl at her and then to beat her Then She Left Him.

He has a little boy of an earliar mar riage that filled his new mother's ears with stories of his villainous cruelty. When at last she was told, too, that Braggo had another wife in town whom he did not beat or abuse she left him, and went back to the street sweeper's home in Twelfth street In a family council over the stove, after she had told her story, it was agreed that Braggo was a bad man and that she should stay.

And stay she did, not with her hus-band's consent, though. He came, not once but many times, to demand that she should return to him, threatening all manner of things if she did not, but she steadily refused. It had become current talk in the neighborhood that Braggo had beaten and abused his first wife until she died, and Rosie did not hanker after her fate. The bad blood in Braggo grew hot-ter, and at last it boiled over when he met Rosie one afternoon coming home from the sweater's shop where she sewed. He grabbed her by the arm and insisted that she should go with him then and there.

Attempted to Shoot Her. When she broke away from him and ran shricking down the street he pulled a pistol and shot at her three or four times It was well that his rage made his aim unsteady so that he could not hit, and she escaped unhurt into a neighboring tene ment, while the neighbors drove Braggo

He was not arrested, though he should have been. No one made any charge against him, and the police probably never heard of the shooting. The neighborhood is filled with Italians, who everywhere pursue the policy of non-interference in private quarrels that is characteristic of the swarthy southerners. It is only when somebody is killed that the police are called in.

Locking out of the window, Rosie saw her father go down the street with Braggo, who had probably been waiting for him below, and now seemed to be arguing her case with him. She saw them almost reach the corner, but she did not see her husband suddenly raise his hand and dash something from a bottle he held in the face of her father. Some of the bystanders saw Braggo run down the avenue as the old street sweeper fell moaning piteously on the icy pavement.

They picked him up, writhing in fearful pain, and carried him to his house, while some one ran for a policeman. When the latter had procured an ambulance Martragelo was taken to Bellevue hospital. The stuff Braggo had thrown in his face was vitriol-he used it in his business and had it handy, evidently-and it had burned him awfully, in places clear down to the bone, and the flesh dropped off in great chunks. The eyes had escaped, the sur-geon said, but even so his wounds are

Worse Than Jack the Ripper. The police caught Braggo, and the Ital-

ian colony was greatly excited over the news when it was brought up by a re-porter. Selecting an Irish tenant as their spokesman, they charged him with the message to the authorities that Braggo ought to be kept locked up for life, for "he is worse," added the woman on her own account, "than Jack the Ripper." If half the stories they tell of him in the

colony are true he certainly is. They say that he killed a man in Italy and fled across the sea, for which reason he can never go back. They further assert upon the authority,

they say, of his own son, that he is responsible for the death of his grandfather well as his first wife through neglect and abuse. Two months ago, they say, he shot a man in Mott street in a quarrel, wounding him in the arm, and that twice the police came near getting him. If that is so he will get the benefit of that little escapade, too, now that they have got him at last.

Brought About by a Long Struggle Between the President and Congress.

LONDON, Jan. 9.-Cable messages received here from Buenos Avres Thursday announced that a revolution has broken out in Chili. The revolution is the result of the long strugble between President Balmaseda, on the one hand, and the ma-

jority of congress on the other.

It has been feared that the president would throw the influence of the government into the presidential election this year, and thus secure the succession to the presidency of one of his own creatures, he himself being ineligible. Congress has repeatedly demanded the resignation or dismissal of obnoxious ministers, but the president has refused to comply.

may come to is to be enforced. After saying that the American delegate has not the slightest authority to propose or accept the resignation of Mr. McCarthy The News adds: "Mr. O'Brien's appeal to the press for reticence is touching, but he cannot complain of us for saying that we are glad that these parleys have ceased."

DUBLIN, Jan. 8.—According to a statement in United Ireland, Mr. Parnell is now on his way here, and will make his first public appearance at the Limerick meeting on Sunday next. It adds:

"He will make an important statement. Until then we ask our people to possess their souls in patience. Whatever the result of the conference may have been, of this we all feel assured, that if there be any way out of the present difficulty which can save the honor of the country and restore the unity of the Irish party it will be discovered by these two men, whose first and only thought is what is best for Ireland.

GLASGOW, Jan. 9.-Six thousand railroad men are still on strike in Scotland. There is no improvement in the movement of goods trains. Outside subscriptions for the relief of the strikers are coming in so rapidly and freely as to render the men competent to care for their families and prolong the trouble.
