### DREW A KNIFE.

An Enraged Italian Threatens to Do Some Bloody Work.

Last evening, about 5 o'clock, a row began on Harbor avenue, near the gas tank, between two Irishmen and an Italian, which for a time promised serious results. From what could be gleaned this morning by a GAZETTE representative in the vicinity of the fracas and elsewhere, the facts seem to be about as follows:

Included in a gang of workmen, mostly Italians, were two Irishmen. Last evening one of the latter approached an Italian and asked him for some money, presumably to be expended for liquor. The Italian replied that he had none, whereupon very vituperative language was hurled at him, resulting in a clinch. Seeing this the other Irishman ran to the relief of his countryman and between them they contrived to hurl the Italian down the bank, hurting his leg badly. He pulled himself together, however, and gave chase to his chief assailant, who took refuge in the Allen House, corner of Harbor avenue and Chapel street, where he was supplied with an empty bottle as a weapon of defense and ran down Water street closely pursued by the Italian, who drew his knife and threatened to "do him up." Near the corner of Main and Wall streets Officer Adams captured the Italian and locked him up. A few hours later it was discovered that the Italian was quite ill and by direction of the officials he was removed to his house under bail of \$50. If well enough his trial will take place this evening before Justice Mead.

### Calumet Club Reception.

On Thursday, the 21st inst., the no ted Calumet Club, of Chicago, will have its thirteenth annual reception to the Old Settlers of Chicago, who were residents and of age prior to the year 1840. Included in this number is ex-Deputy Sheriff Charles Adams, of Norwalk, who was one of the early settlers -practically one of the founders of Chicago. 

To offset this, Dr. Birch, the first signer of the majority report, gave notice that if Dr. Briggs appealed to the synod, he would personally charge him with heresy, a proceeding which would have the effect of negativing his appeal and procuring his immediate trial

Whether or not Dr. Briggs gets what is practically a stay of proceedings, there is apparently little likelihood that anything further will be done in the matter until autumn. Professor Briggs' case, however, will come before the general assembly, be cause that body has the right of veto over appointments in the Union Theological seminary. The Center of Population. Our Hoosier friends have an undoubted right to point with pride to the fact that within the borders of Indiana is the center of population of the United States, and so they have put up a monument of stone 15 feet high to commemorate the fact, and have had the monument formally unveiled with the usual oratorical pyrotechnics, a brass band, etc. It is said that 10,000 people were present to hear the orations of Judges Miller and Cumback, despite the fact that the monument is twenty miles from a town.

The various spots that have been the officially ascertained centers of population in the United States during the century of our national existence have been indicated from time to time in the newspapers. This, however, is only the second time that a monument has been reared to mark the center. The other monument is a few miles northwest of Washington, and marks the population center of 1810. The present monument in Decatur County, Ind., is about twenty miles east of Columbus, and the nearest point with a name is a little railroad station called Westport.

It is a good idea to put up a monument in the new center in Decatur County, and a good idea to celebrate its erection, but they ought to have taken some other day than Sunday for the celebration.

THE CHASE OF THE ITATA.

The Cruiser Charleston in Hot Pursuit of the Chilian Vessel.

SAN DIEGO, Cal., May 14.—Passengers on the steamer Crescent City, which arrived at Cedros island last night, report that when about ten miles below Ensenada on Monday night the cruiser Charleston was sighted far out to sea. As soon as the of-ficers on the war ship caught sight of the Crescent City they changed their course and made direct for her. As soon as the cruiser approached, the captain of the Crescent City raised the American flag and saluted. The Charleston immediately turned at right angles and steamed away to the southwest, and soon disappeared beyond the horizon. The Crescent City's officers report seeing nothing of the Itata.

Mexico May Seize Her.

SAN FRANCISCO, May 14.—The Call has an interview with A. K. Coney, Mexican consul general at this port, in regard to the probable action of the Mexican government if the Itata enters the port of Acapulco. He says Acapulco is a neutral port, and he is confident that the Charleston will not be permitted to seize the Itata there, but if the Itata enters with contrabrand goods on board it is probable that the Mexican officers will train the guns of the fort on her and seize her themselves. The fort is not very powerful, but is strong enough to capture the Itata.

### EDISON'S LATEST WONDER.

A Novel Arrangement That the Great Inventor Will Have on Exhibition. Another Protest Against W. S. Maxwell's Appointment.

SPRINGFIELD, Ills., May 14.—Before the house committee on the World's fair appeared J. G. Ogden, of Chicago, who said he represented the laboring men of the country. He brought with him the minimum scale of wages which labor organizations have been endeavoring to induce the Chicago directory to concede without success. He wanted a provision inserted in the World's Fair bill fixing the minimum rate. The laboring men, however, did not want a maximum rate fixed, he said, as that would work injury to them. It was the general sentiment of the committee that the proposed amendment would be

special legislation, which is forbidden by

the constitution. Ogden assumed that the committees were showing antagonism to labor interests, and told them so. He finally threatened that if any man presumed to hire men at less than the regular prices there would be a strike. This threat did not tend to the success of his mission, and when he demanded that the money should be expended to workmen in Chicago, and that no one outside its limits should be allowed to go there, his cause was lost. The committee insisted that any one who wanted work had a right to go there and get it if they could.

The house committee on appropriations by nearly a party vote reduced the appro-priation necessary for the National Guard encampment from \$132,000 to \$100,000. This reduction, Adjutant General Vance says, will not only prevent holding the en-campment in 1892, but will make the appearance of the Illinois state troops at the opening exercises of the World's fair in October of that year unworthy of a great state by contrast with commonwealths which handsomely support a much larger number of men.

### EDISON'S LATEST WONDER.

The "Wizard" Explains His New Inven-tion, the "Kinetograph."

CHICAGO, May 14.—Thomas A. Edison has arrived in this city. When asked what he would exhibit at the World's fair he replied: "The kinetograph. What does that mean? The first half of the word means 'motion' and the other half 'write.'
That is the portrayal of motion. This instrument or result is a combination of photography and phonography. By means of it I shall be able to reproduce an opera, prize fight or a drama—anything which human beings enact that may be photo graphed or heard. Facial expressions, the twitching of the muscles, the modulation of the voice may be reproduced. The latter feature is the phonograph. The former and the combination of the two is the burden of my work."

"What success are you having with ex periments?"

"I can reproduce a prize fight without much difficulty. The varying expressions of the face, the gathering and relaxation of the muscles, are as yet a little hazy in reproduction, but I shall bring them out distinctly in the end."

Mr. Edison has leased the Strong block, in which all the goods used in construc-tion work in the west will be kept.

### Sore Over New York's Action.

CHICAGO, May 14.—The failure of the New York legislature to make any appropriation for a World's fair exhibit was the theme of several uncomplimentary and re-gretful speeches at last night's monthly meeting and supper of the Sons of New York, held at the Sherman House. At the close of addresses resolutions were unani-mously adopted appointing the officers and directors of the association a committee to take under advisement the best means for securing a proper exhibit from the Empire

Another Maxwell Protest.

INTERLACHEN, Fla., May 14.—At the examining session of the Florida Horticulture society, now in annual session here, a resolution was passed expressing the greatest indignation of its members at the recent appointment of Walter S. Maxwell, of California, as superintendent of the horticultural department of the World's fair, and protesting strongly against his confirmation by the board of directors.

Labor Leader Ogden and the Di- Austrian Jews Rejoice Over the Attack on the Czarewitch.

### EXCITEMENT IN BELGIUM.

A Conflict Possible Between the Workmen and the Authorities-Westphalian Miners Starving in the Midst of Plenty-Portugal's Crisis.

St. Petersburg, May 14.—Official dispatches from Tokio say that when the assault upon his life was made the czarewitch had crossed Lake Biwa, near Kioto, and had landed at Otsuo, on that lake, whence he proposed continuing his journey to Kioto, about twelve miles distant. Shortly after the landing of the czarewitch a native policeman named Tsuda Sanzo, a member of the sect of Samiria, noted for their uncompromising and fanatical hostility to foreigners, approached the Russian prince, and drawing his saber aimed a savage thrust at the head of the heir to the throne of Russia.

Fortunately the helmet worn by the czarewitch was so thick that the blade of the weapon only inflicted a scalp wound some three inches in length and of insignificant depth. Before the fanatic could renew the attack he was seized by those about the person of the prince and was speedily placed in confinement. Surgeons at once dressed the wound, and with but little delay the distinguished traveler took his seat in a special train and departed for

Rejoicing Over the Attack. VIENNA, May 14.-Many of the Jews in this city are not slow to evince their satis-

faction at the distress of the Russian imperial family, owing to the attack on the czarewitch, and aver that it is just retri-bution for the frightful calamities inflicted on the Jews by the czar's government. In Warsaw the police arrested several men who were disseminating the news in an exaggerated form to the effect that the czarewitch was dead.

The Austrian emperor has telegraphed his condolence to the czar, with an anxious inquiry as to the latest news of the czarwitch's condition. The Austrian authorities in Galicia have been ordered to repress sternly any exhibition of satisfaction with the occurrence, but groups of people in Cracow lined the streets last night, talking over the event with evident pleasure. Cracow is full of Jewish refugees, and there was no concealment of delight at the blow which had fallen on the household of the autocrat.

This feeling is not so strange when it is remembered that, according to the latest reports set afloat, the roads from Moscow to the frontier and the Pale, were strewn in some places last week with the remains of the aged and of infants who had perished from hardships.

### Excitement in Belgium. LONDON, May 14.—Dispatches received

here state that great excitement exists in Brussels. The workingmen are determined to hold their parade in spite of the city authorities, and the burgomaster is equally stubborn. The troops are in readiness to suppress any outbreak, the gen-darmes having spent all night under arms.

The working people of Ghent are out in force, and similar demonstrations are re ported in various cities of Belgium. The troops on the Belgian frontier adjoining France have captured a large quantity of circulars printed, it is thought, in England. These circulars appeal to the people to strike a blow for liberty and not be any longer the slaves of an oligarchy.

The leaders of the strike at the West phalia mines, who were put under arrest when the strike movement began, have been released without a trial. The mines are in such a dilapidated condition that production in large quantities will not be possible for several days to come. Government inspectors are busy examining the mines and ascertaining what, if any danger exists.

The workingmen of Bochum not en gaged in coal mining have subscribed a sum of money for the benefit of the poorer miners, who in the midst of plenty are actually starving. The surrender of the miners is due to this fact. Dr. Brassert, who is charged with the administration of mines is quoted as saying that the tion of mines, is quoted as saying that the safety of the mines is nowhere more care fully attended to than in Germany, which is the reason that the country is comparatively free from great mining calamities.

Portugal is virtually driven, for the present, from the great stock markets of Europe, and her best securities are without an offer of purchase.

It is said that King Charles has offered for the present to give up his income from national sources until such time as Portugal shall be better able to pay. As the queen is wealthy both by descent and bequest, the king's offer, should it be accepted, would not involve him in poverty.

The Cologne Gazette's St. Petersburg correspondent says that all the Jews are being expelled from Russian territories beyond the Caspian sea.

Grand Duke Nicholas' Funeral. LONDON, May 14.—The funeral of the Grand Duke Nicholas was one of the most splendid exhibitions of the kind ever witnessed in Russia. The body was saluted by 100,000 troops on the way to St. Peters burg. The czar's court is now in double mourning. The remains of Nicholas are interred in the Cathedral of St. Peter and nterred in the Cathedral of St. Peter and St. Paul. The natural children of the late grand duke, four in number, have been taken under the special protection of the imperial house, and will be trained accordingly.


