Masonic.

A copy of the Alexandria Gazette sent Mr. G. Ward Selleck gives a long and interesting account of the novel masonic event to which the DAILY GAzette devoted a paragraph recently and to which Mr. Selleck was cordially and fraternally invited. This was the lodge of which Washington was once Master. The report says:

About a year ago an official communication was received by Alexandria-Washington Lodge of Masons from Liberty Lodge, of Beverly Mass., in which the latter asked the former if it were possible to procure for them a piece of wood from a tree rendered piece of wood from a tree rendered sacred by having in some way been connected with the history of General Washington. The lodge in Alexandria soon procured a suitable piece of wood from a magnolia tree believed to have been the last planted at Mt. Vernon by the father of his country, and sent it to Liberty Lodge. The latter forthwith concluded to reciprocate the favor by presenting something to Washington Lodge equally as interesting, and last night was designated as the time at which to carry out their intention. Nearly all the Masons belonging to the two lodges in Alexandria were present, two lodges in Alexandria were present, together with a large number from Washington, including grand and sub-ordinate officers. Wor. Bro. Kemper in an appropriate speech announced that Wor. Bro. Woodbury of Liberty Lodge Beverly, Mass., who had also been received with honors, had something of interest to communicate to the craft. Bro. Woodbury, then in a neat, well timed and eloquent speech, which was frequently applauded, in the name of the lodge he represented, presented an artistically wrought gavel enclosed in a tastefully constructed case, the for-mer made from wood of the elm tree under which Washington took command of the armies of the revolution. At the conclusion of his speech of presof Washington Lodge arose and received the gavel in the name of his lodge and made a short and appropriate speech, which was interspersed with beautiful, touching and pathetic references.

The case contained the gavel sent by Liberty Lodge shows cunning handiwork. It is made from a solid piece of oak and bears the following inscription:

"Liberty Lodge, Beverly, Massachu-setts, to Alexandria-Washington Lodge No. 22, Alexandria, Virginia."

The gavel is also a specimen of artistic woodwork, and has the following on a silver plate upon it:

"By this gavel, made of wood from the elm tree under which Washington took command of the armies of his country, sons of the Puritan Commonwealth, venerating the memory of him whose character cemented this greet their brothers of the Old Dominion in Masonic amity."

Mr. Woodbury also presented the lodge with a handsomely framed photograph of the elm tree from the wood of which the gavel was made.

OUR SOJER BOYS.

A Large and Delighted Audience Witness Their Evolutions Last Night

Long before 8 o'clock last evening every bit of available space at the Armory was occupied by sitting and standing humanity, the occasion being the battalion and company movements of Companies C, D, and F. In addition to the gallery sittings there were two rows of chairs on the north side of the room on the main floor, with as many other chairs in other sections of the room as could be made use of without interfering with the movements of the

At 8 o'clock the Companies named formed for inspection and review, Lieut.-Col. Crowe being the inspecting officer, and town, city and borough officials the board of review. This part of the programme went off quite smoothly, and all concerned acquitted themselves with credit. Company F, of Norwalk, turned out about forty strong, Captain Rose in command, and its part of the evening's work was particularly complimented.

After the inspection and review, battalion movements were in order and were executed with rare precision when it is considered that a battalion drill is scarcely more than a memory with most of the militiamen who took part. Making due allowance for the rust consequent upon these by far too infrequent battalion drills, it was the judgment of various competent military men present that the boys came up to the mark in good form. One company excelled in a particular movement, and another in something else, but in general great credit is due all of them.

After the battalion drill, dress parade was in order, with the advantage of brass music and drum corps in combination, the musicians numbering about 25 men. There were about 100 muskets in line, and the various orders of Lieutenant-Col. Crowe were well executed and provoked hearty applause. Second Lieutenant Oakes, of Company C, acted as adjutant with credit to himself.

After dress parade, which ended at 9.30 or thereabouts, the Stamford boys made preparations for an early return home, but before leaving the Armory they were escorted to "an upper chamber" where, after cake, lemonade and cigars, they heartily cheered their en-

tertainers and departed in high spirits. All things considered, last evening's military performance was fully equal to the most sanguine expectation.

STATE EXPENDITURES.

Senator Seymour and His Associates Met Yesterday.

The Senate committee on State expenditures, met at the Capitol yesterday for the purpose of considering the subject of State appropriations. The committee consists of Senators Seymour, Cleveland and Robertson, Democrats, and Shumway and Palmer, Republicans. All were present save Mr. Shumway.

Treasurer Henry's estimate of. the expenditures for the two fiscal years beginning July 1, 1891, is \$3,697,221.20, and of the receipts for the same period, \$3,641,000, a deficiency of \$56,221.20. In its examination the committee decided that the same should be of a nonpartisan character and that the question of the abolition of useless offices and salaries should be looked into. It was also deemed best to ascertain whether there isn't a bad policy in vogue respecting the manner in which certain salaries are paid, relating particularly to those of the Railroad Commissioners. In view of the belief that the law of 1885 requiring all appropriations to be specific worked in the direction of extravagance, the committee will make careful and thorough investigation. After having, in a general way, marked out the course to be pursued the committee adjourned subject to the call of the chairman.

BIG FIRE IN GREENWICH. A fire broke cut at an early hour this

morning at Mianus, Greenwich, in the store of W. L. Field, who also runs the post office, which was soon consumed. At one time it seemed as if the entire place would have to go, and engines were telegraphed for to Stamford. The owner of the building was Mrs. Mary W. Hawes, who with her three children occupied the stories above the store, and who were gotten out of the burning building with difficulty, and with the loss of everything, including \$200 in money. The adjoining store and meat market of Richard Cox, who also lived above his store, was next consumed. Chief Bowman hurried a steamer down from Stamford, but it got there too late to be of service, the citizens by superhuman exertions having gotten the fire under control. SERVIA EXPELS NATALIE.

The Unfortunate Ex-Queen Yields to Force, Counsels Her Supporters to Avoid Bloodshed and Is Marched Off by Armed Guards.

LISBON, May 20.-A revolutionary out break has just been barely averted here by the payment of arrears to the troops of the garrison, who have been showing signs of discontent and incipient mutiny. King Charles himself advanced money for the payment of the palace guards and employes out of his own purse, and Queen Amelia did the same for the females of the royal household. Considerable excitement was caused throughout the city by a report that the king and queen had started

incognito for Madrid.

For the time there was much hurrying For the time there was much hurrying to and fro in the streets, and groups gathered in a menacing manner in the Pradd o commercio and the public promenade. The speedy and authoritative denial

of the report prevented mischief. There is no con-cealment of the fact that the army would be with the people in the event of trouble. The operatives in the cotton and woolen

QUEEN AMELIA. factories have been showing much un easiness for several days past, and the police not on the streets are kept in reserve for anything that might occur.

A Madrid dispatch says that a large body of Spanish troops is being massed at Bada jos, near the Portuguese frontier, and that a Spanish squadron is cruising near Lisbon. The Spanish government makes no secret of its intention to intervene should a republic be declared in Portugal.

Ex-Queen Natalie Expelled. BELGRADE, May 20.—The Servian authorities made an attempt Monday to expel ex-Queen Natalie from this city and country by force, but the students and citizens arose en masse, captured the exqueen's carriage from the gendarmes and restored her to her palace. In the conflict two of Natalie's supporters were killed. After restoring the unfortunate woman to

They then entered the palace, and the officer in command summoned Queer Natalie, who was still resting in her private apartments, to arise and instantly quit the palace and the country. To this demand the queen replied that in comply ing with the orders of the regents sho yielded to force alone.

Natalie's Appeal.

On leaving the palace to step into a wait ing carriage Queen Natalie, who was surrounded by gendarmes with loaded muskets, urgently appealed to the citizens and students, who menacingly pressed about her escort, to no further resist the officers It was, she said, her first desire to averithe spilling of the blood of the people. The escort then closed in about the carriage, which the ex-queen entered, and it was rapidly driven to the railway station where a train was awaiting the arrival o the gendarmes with their royal prisoner The ex-queen was at once placed on board and the train immediately started for the Hungarian frontier.

From the moment of her leaving the palace until she took her seat in the rail way carriage no further demonstrations on behalf of the ex-queen were made by the populace. 

Frightful Explosion of a Carload of Dynamite.

THIRTY KILLED OUTRIGHT.

And Over a Score of Others Reported to Be Missing.

The Accident Occurred on the New York Central Road Near Tarrytown, and Was Caused by Laborers Exploding a Blast Too Near the Dynamite Car, Which Resulted in the Disaster by Concussion-Some of the Wounded Had Their Limbs Torn from the Sockets and Were Otherwise Fearfully Muti-

TARRYTOWN, N. Y., May 20.-A car laden with dynamite to be used in blasting along the Hudson River railroad suddenly exploded a few miles below here Tuesday morning, wrecking everything in the vicinity, tearing up all the tracks of the road and blowing to atoms thirty men. The Shock Felt for Miles.

Some were hurled dead to a great distance into the river. The fireman of the locomotive of the train was blown with the tender of the locomotive into the

All traffic on the Hudson River road was stopped. The shock of the explosion was felt for miles in all directions, and it is impossible to indicate the extent of the damage.

The load of dynamite was on a flat car in a construction train, and was to be used in the construction of a third track. This was the cause of the disaster.

Over Twenty Missing. At 2 o'clock the remains of nine Italians and two Americans who were killed outright were lying at the station here, where they had been carried by the crowd engaged in moving the wounded and dead. Four other Italians died after being taken

to the station, and twenty-three badly instation. More than twenty are still miss-Literally Blown to Pieces.

Those killed outright were literally blown to pieces, and were horribly muti lated. Some of the wounded men had their arms blown away, others are minus their legs, while others were dismembered in equally horrible manner.

The Italian laborers working on the road are generally known by numbers, and it is impossible at present time to give any names. A large number of physicians from Tarrytown, Irvington, Dobbs' Ferry and Yonkers attended to the wounded.

Exploded by Concussion. The explosion occurred midway between Irvington and Tarrytown. The Italians who were employed in extending the roadbed, had removed the dynamite from the car and placed it alongside of the track. They set a blast, and the concussion of the blast exploded the dynamite.

Travel was entirely suspended between Irvington and Tarrytown. All trains were forced to come to a standstill each side of the accident, as the track and part of the road had is an entire week. road bed is an entire wreck.

A Romance of the Late War.

RICHMOND, Ind., May 20.—A rather romantic incident in connection with the late war has come to light here. Martin Farrell, who lived at a small village in western New York, enlisted in Company F, One Hundred and Forty-sixth regiment, New York Volunteer infantry, in 1861, and went to the front. He left behind a wife and a son five years old. The mother soon sickened and died, and the son was adopted by a family named McCabe. He took the name of George Farrell McCabe. The father was never afterward heard from Young George fought the battle of life for himself after reaching the age of fourteen. He finally came west. He has for several years been agent for the Ohio Farmers Insurance company, in this city. Last week he was at Dayton on business, and, missing the train, he paid a visit to the Soldiers' home, thinking that his father might possibly be among the inmates. He visited the office and found that his name was on the roll. He at once hastened to the designated quarters, and here he again met his father, whom he had not seen for twenty-eight years. The meeting was a joyful one, as each believed the other dead for years. Mr. Farrell will come to this city soon on a visit to his son and family.

Think He Is in a Trance. BIDDEFORD, Me., May 20.—The body of Captain Wakefield, of Cape Porpoise, who was drowned three weeks ago, has not yet been interred, but is in the receiving tomb at Laurel Hill cemetery awaiting the orders of the widow, who thinks her hus-band is in a trance. On Sunday two physicians, after visiting the tomb, tried unavailingly to convince Mrs. Wakefield that the man was dead. The body is wonderfully preserved, and the face has not shown the slightest discoloration. This is due, the doctors say, to the action of salt water. Captain Wakefield always had a horror of being buried alive.

She brought back with her about 700 utterly destitute Italian emigrants, driven home by suffering and cruel treatment. 


