YESTERDAY'S BOROUGH MEETING.

Water Supply Voted to Spring Hill and Elmcrest People-Sewer Ordered for Cross Street.

The borough meeting was called to order yesterday afternoon at 3.05 by Warden Keeler. Twenty-seven people were present. Clerk Montgomery read the call for the meeting after which the matter of laving water pipes on Elmcrest bouelvard, Stewart avenue and Spring Hill road came up. Water Commissioner Street reported that the estimated cost of the same would be \$2,400. Attorney Hurlbutt thereupon offered the following resolution: 'Voted, that the water commissioners of the borough be, and hereby are, authorized and directed to cause to be laid a six (6) inch iron pipe of such number of lineal feet as they may deem advisable in Elmcrest boulevard, "Connecticut turnpike" and Stewart avenue, together with such number of fire hydrants, branches and specials and connections as may in their judgment be needed. Also

Voted, that the Court of Burgesses be authorized to borrow in the name and on the credit of the borough, the sum of twenty-five hundred dollars, or so much of said sum as shall be necessary to carry into effect the aforesaid vote, and to give the obligation or note of the borough therefor, and to pay the money over to said water commissioners on the completion of the work, said amount to be chargeable to the water fund of the borough.

Ex-Water Commissioner Moody favored a four inch pipe, claiming that it would be sufficient for all purposes, and moved to amend the resolution to that

Chief Engineer Prowitt favored the esolution as read, and gave his reasons therefor. He didn't think we could afford to put in anything less than a six inch pipe in view of the prospective growth of that section of the borough. He gave the opinion of Borough Engineer Wood, as an expert in such matters. The original resolution was adopted with but one dissenting vote, that of Mr. Moody, who explained that he was not opposed to the water project but favored a smaller pipe.

The following resolution was read by Warden Keeler: "Voted, that the Water Commissioners of the borough be, and hereby are, authorized and directed to cause to be laid a six (6) inchiron pipe of such number of lineal feet as they may deem advisable in Spring Hill road together with such number of fire hydrants, branches and specials and connections as may in their judgment be needed. Also

Voted, that the Court of Burgesses he authorized to borrow in the name Yale College four years ago, a poor boy and on the credit of the borough, the sum of two thousand dollars, or so much of said sum as shall be necessary to carry into effect the aforesaid vote and to give the note of the borough therefor, and to pay the money over to said Water Commissioners on the completion of the work, said amount to be chargeable to the water fund of the borough."

Attorney Hurlbutt opposed the resolution on the ground, principally, that as planned, the additional pressure upon our water mains would be greater than they could bear. He moved to amend by substituting four inch pipe for the six inch pipe named in the resolution.

Water Commissioner Street advocated the adoption of the original resolution, as he considered a double hydrant on Spring hill a necessity.

Messrs. Moody and Hurlbutt continued their remarks in favor of a four inch pipe, Mr. Moody favoring it on the ground of economy almost solely, whereas Mr. Hurlbutt considered the question in the light of prudence and safety, as heretofore outlined.

Water Commissioner Street explained that it was not the purpose of the commissioners to connect with the

main pipe. Permission was accorded Mr. Hurlbutt to withdraw his amendment and the resolution was adopted.

On motion of Mr. Hurlbutt the Burgesses were authorized to construct a ewer on Cross street, the resolution being adopted unanimously.

On motion of Clerk Montgomery the meeting, at 3.30, adjourned.

EDITOR GAZETTE.—As a tax payer I would like to occupy a few lines of your widely circulated paper to call our court of burgesses to a halt in their reckless expenditure of the borrowed public money, and their incompetent management of affairs in general. If they do not stop this everlasting borrowing and apply economical methods, it is only a question of time when we will be in the condition of Elizabeth, N. J., and other bankrupt municipalities. Dr. Alsop Dies Suddenly.

Dr. Joseph W. Alsop, the democratic candidate for lieutenant governor in the last campaign in Connecticut, died suddenly at noon yesterday at his home in Middletown. The deceased was born in New York in August, 1838. He was educated at Yale and graduated as a physician. He never practiced to any great extent and followed agricultural pursuits. He was always active in politics. He was a candidate for lieutenant governor on the democratic state ticket, in November last, against Dr. George Austin Bowen of Woodstock, and received a majority. He took the oath of office on January 13 last. He officiated at a brief session of the senate, as its presiding officer, and then handed the gavel over to the president pro tem, the Hon. David M. Read, of Bridgeport. Senator Read succeeds to the position made vacant by the death of Dr. Alsop, and becomes acting lieutenant governor of Connecticut, should the gubernatorial muddle be settled in favor of the democrats.

BULKELEY'S RIGHT TO OFFICE.

Judge Hull Says He Is Defacto Gov-

ernor and His Title Must Stand. HARTFORD, June 24.—Judge J. M. Hall, in the Superior Court to-day handed down a decision in the suit of

Austin Brainard, Executive Secretary to Gov. Bulkeley, against Comptroller Staub for the payment of salary. The decision was on the motion of Brainard's counsel to expunge parts of the answer filed by Staub's counsel to the bill of complaint. Judge Hall's opinion is that parts of the answer

should be expunged. The parts referred to cite the facts of the State election last fall, and claim that Morgan G. Bulkeley is not Governor, and has not the right to appoint

an executive secretary. Judge Hall says in his opinion that the question of whether Bulkeley is de jure Governor cannot be determined in a mandamus suit to which Bulkeley is not a party; that he is de facto Governor, and that his acts as such must stand as regards a third party until his bills have been overthrown by a contest, or by quo warranto proceedings. This is in effect a recognition of Bulkeleys' right to the office.

A Tragedy in New Orleans. New Orleans, June 25.—A terrible tragedy occurred at the West End summer resort last night. The Freemasons were celebrating St. John's day and 15,000 had assembled at the grounds to witness the display of fireworks. At 9:15 the display was begun. A bomb struck among several hundred horses which were hitched on the grounds. All reared and plunged wildly but only one succeeded in getting loose. The Negro driver was asleep when the horse started to run but awoke and jumped for his life. The terrified horse. dashed among the crowd knocking down a dozen persons.

The Previous Tragedy. One day about twenty-five Woodsdale men armed themselves and marched in the direction of Hugotown. They were met by Sheriff Cross, of Hugotown, with a posse. In a parley which ensued the Woodsdale people said they had no belligerent intentions and were only going down to the Indian Territory hunting. They marched down to the Indian Territory, and Sheriff Cross and his posse followed them.

That same night a battle ensued between the two parties in which the sheriff and five of his posse were killed. Most of the Woodsdale party were arrested on a warrant issued from the United States court at Paris, Tex., in the criminal jurisdiction of which is the Indian Territory. The trial resulted in a conviction. The case was appealed to the supreme court, there the verdict was reversed and the case remanded for trial. It is still pending.

Swore Revenge and Got It. During the trial at Paris, Tex., Brennan was one of the principal witnesses for the state, and S. N. Wood, one of the defendant's counsel, handled him without gloves. Brennan swore revenge, and when he heard yesterday that Wood was in town he armed himself, and after a search found Wood standing on the court house

Without warning he drew his revolver and fired four shots into his victim. Wood expired without uttering a word. 

The City of Churches' Noble Tribute to Its Famous Preacher.

THE WORK OF ART UNVEILED

daughter of the Noted Divine, Casts Off the Silken Shroud-The Site, and Why It Was Selected.

BROOKLYN, June 25.—A tiny hand outstretched, a gentle pull on a dangling cord and a silken spread of stars and stripes fluttered to the ground, exposing to the thousands of upturned and expectant eyes the heroic statue in bronze of Henry Ward Beecher, the noble tribute of this city to the memory of its most famous citizen, patriot and preacher. The ceremony took place at 4 o'clock Wednesday afternoon in the triangular plot of grass in front of the city hall, which the statue faces.



STATUE OF HENRY WARD BEECHER. Long before the time for the unveiling every foot of ground available was packed with a solid phalanx of humanity, and the temporary stand which had been erected was a vision of pretty feminine faces and bright costumes. When the hour of 4 ar rived the Rev. S. B. Halliday offered up a prayer, and then Rev. Charles H. Hall, D. D., of Trinity Episcopal church, introduced Mayor Chapin, who presided. The mayor made a short speech, in which he paid a glowing tribute to the life work of the dead minister, and praised the citizens for the spirit manifested in thus honoring his memory.

Unveiled by His Granddaughter. After the mayor had concluded Gertrude Roxana Beecher, the granddaughter of Henry Ward Beecher, accompanied by the sculptor, John Quincy Adams Ward, advanced to the front of the platform and pulled the spring which cast off the drapery, and amid a prolonged outburst of applause exposed the beautiful work of art to view. Then 300 children from the Sunday school of Plymouth church and the Bethel and Mayflower missions, who were stationed by the pedestal, led in the singing to the music of the band of the Thirteenth regiment, the full command being present, of the hymn, "Love divine all love excelling," which has been called

'Beecher' from his preference for it.

Dr. Hall, at the close of the hymn, presented the statue, as chairman of the executive committee and on behalf of the subscribers, to the city. Mayor Chapin, after a reply of acceptance, turned it over to President George W. Brower, of the park department. The band then played phony," which Mr. Beecher loved. The oration, by President Seth Low, of Columbia college, ex-mayor of Brooklyn, fol-lowed, and after the singing of the national hymn, "America," Rabbi Gottheil, of the Temple Emmanu-El, of New York city, pronounced the closing benediction.

The Memorial. This work, which has cost the admirers of that great man of all creeds and nationalities the handsome amount of \$35,000, has been under way for three years in the studio of its sculptor, J. Q. A. Ward, and in the bronze foundry of the Henry-Bon-

nard company. The movement for the erection of a me morial—which it was at first intended should be placed in Prospect park, but which was placed where it now is in accordance with the desire of Mrs. Beecher, that it should be near the place of his trial—was begun shortly after his death, and resulted in a subscription of extreme ly popular character, the smallest amounts being welcomed. At the Art Association building, in Montague street, the first citizens' meeting was held in March, 1887. Of the executive committee Dr. Hall is chairman, F. W. Hinrichs vice chairman, R. B. Moffatt secretary, and the late Rip-ley Ropes was the first treasurer of the

The memorial is one of the most important and one of the best works of the sculptor. The statue of Mr. Beecher stands on a simple polished pedestal of dark Quincy granite with rounded sides and heavy cap and base, designed by Richard M. Hunt, the architect. This has on the left the figure of a negro girl in coarse slave costume, and on the right those of two children, a boy and a girl, humbly clad. Mr. Beecher is shown with overcoat on and soft felt hat in hand, as if stopped for a moment in a walk or about to address an out of door assemblage.

As the Public Man. It is as the public man and not as the

preacher that the sculptor, in view of the widely popular nature of the movement which resulted in the erection of the statue, has represented his subject. The pose is natural, the modeling strong and realistic and the expression of the face turned to the right, and excellent as a portrait, is

More graceful in its lines is the group of the two children, both barefooted, the boy seated on his coat placed on the base and with his hands placed in support on the back of the girl standing where he sits and looking gratefully down at him as she strives to push

height of the pedestal, which is considerably broader than it is deep, is 10 feet, thus giving to the monument a total height of 18 feet 6 inches. The figure of Mr. Beecher weighs some 2,600 pounds, and those on the right and left below about 1,500 pounds each, giving a total weight of about 5,600 pounds for the

bronze.

The sculptor has endeavored, with success, to represent not alone a man of courage, of boldness and of intellect, but one of broad sympathy with humanity, the figures of the children testifying of his sympathy with young life as that of the girl does with the oppressed.

The Site.

In reference to the suggestion that it was not proper to have Mr. Beecher almost, if not actually, facing the building where the famous trial took place, Mr. Ward says that in the first place it faces the city hall and not the court house, and in the second that it was better that he should face the building rather than turn his back to it, the former position being de cidedly more in character.

In reference to the artistic questions in volved in placing the statue facing the city hall, Mr. Ward says that he does not want to put up any of his statues facing the north, where it would be almost always in shadow. Again, if it faced north it could not be properly seen on account of the fountain at the smaller end of the plot of ground, which the city did not care to remove. Besides, at that end there are electric light and other poles and the structure of the elevated railway, and few people pass by the fountain, most of them going up or down Fulton and Court

Again, argues Mr. Ward, the statue intended for familiar and close inspection and people can get that where it now Also, if it were placed facing north, where the fountain is, it would look like a pigmy against the huge facade of the city hall. And in all this the sculptor

The pedestal bears on the front the name and the dates of birth and death and at the back an inscription.

ARCHBISHOP HUGHES' STATUE. Unveiled on the Golden Jubilee of St

The presentation of the statue was made by Judge Morgan J. O'Brien. Rev. John Scully, S. J., the rector of the college, delivered the speech of acceptance. The statue was then unveiled by Archbishop Ryan, of Philadelphia, who delivered the oration. At night a dinner was given to the subscribers to the fund and the invited

DOLLIE DAVIS' DOUBLE.

Futile Efforts to Discover the Identity of the Dead Woman.

THE MARKS ON HER THROAT

That the Unfortunate One, Who Was Evidently a Person of Refinement. Was a Victim of Foul Play.

TARRYTOWN, N. Y., June 25. All day Wednesday an almost endless stream of persons trooped in and out of Vanderbilt's undertaking establishment here. Some came out of mere curiosity, while others again were actuated by a motive more worthy. They examined the features with the hope of discovering the identity of the dead woman. Now that it has been definitely estab-

lished that the remains are not those of the little actress Dollie Davis the interest that was manifested in the case here has in no way abated. On the contrary, it has increased threefold, for the inhabitants fully realize that they have before them a mystery which it will be hard to unravel, no matter what turn the case may take. Even if the case is one of suicide, they

say, establishing the identity of the dead woman will be a big undertaking in itself, unless some one appears, and that soon, to settle the question. If the case is one of suicide, the inhabitants argue with much reason there must have been a motive unusually strong, because the suicide. if such she be, was not of the class who usually resort to such measures. A Woman of Refinement.

Everything about her indicates that she has been a woman of refinement. The small, delicate features are sufficient indication of that, leaving out of considera tion altogether the fact that her hands are small, well shaped, white and soft, and her feet are small and prettily formed.

The delicate, small knuckled hands have never been accustomed to work, a fact which doesn't require the eye of an expert to determine, consequently the theory that has been advanced that the dead woman had been a domestic somewhere further up the river is ridiculed here.

The statement also is ridiculed that the woman reached Croton via the steamboat Chrystenah. The boat does not reach Peekskill until almost 8 o'clock in the evening, and after that hour no trains leave Peekskill which stop at Croton Landing. Consequently, in order to reach Croton and be seen there at 9:30 on Friday night, the woman would have been obliged to walk from Peekskill to Croton, which is between some and eight miles, in a pelt-

ing rate
No one hired a carriage in which to b driven to Croton Landing, a fact which has been established by a canvass of the livery stables of Peekskill. Having satisfied themselves that the woman is not o the class which finds an end of all trouble in self destruction, the townsfolk, not at all decided as to its having been a suicide, want to know the motive if it has been

The Bruises on Her Neck. Some think it can be found in the state ment attributed to Dr. Coutant, of this place, who is reported to have said vester day that the young woman had mother within a month. That would have been a motive for suicide, the townsfolk say, though at the same time it could as easily be a motive for murder. What makes them believe that the wom

an has been foully dealt with is the fact that bruises have been found on one side of her throat. Mrs. Vanderbilt, the mother of the undertaker, and one who has closely examined the remains, said this morning that the bruises were there, and that she had seen them with her own eyes. The marks are on the left side of the

neck. One bruise is down on the jugular vein. Another bruise is a trifle less than two inches above the first and also on a line with the jugular. Further to the front, under the rear of the jawbone, are two more bruises. All are on the left side, and what caused them has not been determined. That is one of the points which it is expected will be cleared up by the au-

Mrs. Vanderbilt said that she called the attention of Dr. Coutant to the marks on the throat of the dead woman. He exam ined them very carefully, and came to the conclusion that they had been inflicted be-fore death. That sets at rest the supposition that the injuries were received when the woman either jumped or was thrown overboard. The question is naturally asked, "Who inflicted the bruises?"

The Footprints in the Mud. Either the woman or the one who caused her death was more or less familiar with the place, but neither would have known anything about the Sleepy Hollow ceme tery. Consequently it is considered strange that no one appears to identify the young woman, even if she be a sui-cide. The inhabitants try to explain that by the supposition that the young woman belonged to one of the wealthy families which dwell along the Hudson river; that she had been turned away from home, and that in disgrace and despair she plunged into the river to have it all over

The theory is advanced that her relatives don't care to have the disgrace of such a thing attached to the family name, and for that reason don't come forward and

claim the body.

As for the note which was found on Schnell's dock, not much importance is attached to that. Anybody could have written that, and the initials M. E. J. don't lead to anything. That the woman was seen in Croton at 9:30 on Friday night but little doubt remains. One man swears positively that he saw her there. The footprints of more than one person lead down to Schnell's wharf. The dead woman's shoes fit some of the marks. Who made the others is an interesting question. Much is expected to result from the autopsy.

The Stockholders Must Lose It. AYER, Mass., June 25.—The comptroller of the currency has levied an assessment of 35 per cent. on the stock of the First National bank. Through its ex-cashier, Spaulding, the bank suffered a loss of \$52,000. This assessment, together with the amount of bond furnished by the defaulting cashier, will make up the short-age in the capital of the bank.

How To Regain Public Confidence There's but one way to restore the public confidence in our inculpated borough officials and that is to make an open, frank and honest statement of the reasons why such apparent reluctance was shown to make prompt arrests of law breakers.

Senator George's Change of Front. CANTON, Miss., June 25.—The Mississippian, the leading state Democratic organ, published Wednesday a seven column letter from Senator George, in which he comes out squarely in favor of the Ocala platform, excepting as to the subtreasury and land loan features and government ownership of railroad and telegraph lines. With these exceptions he takes advance guard in advocacy of the Alliance de-mands, and his letter will cause a sensation throughout the state. It was submitted to Colonel Livingston of Georgia, the leading southern Alliance man, who said it was a wonderful exposition of the Ocala demands, and would place Senator George in strong light before the Alliance.

Killed by a College Trainer. HARTFORD, June 25.—Steve Daly shot and killed John McCarthy at Trinity col-lege. Daly is a well known athlete, and the trainer at the college. The commencement ball was going on and Daly had been put on guard, as many valuable ar-ticles had been stolen in the last few weeks. He heard a noise outside, and going out found a gang of toughs there. He claimed that they attacked him, and that he shot in self defense. McCarthy rai about 200 feet and dropped dead. Daly gave himself up.

Killed by a Cable Car. CHICAGO, June 25.—Hamilton Spencer, one of the most respected and noted law-yers of Bloomington, Ills., was knocked down by a cable car, and he died a few hours later at the county hospital. The wheels of an entire train passed over the unfortunate man, and when he was picked up his body was bruised in a frightful manner. Mr. Spencer was seventy-eight years old, and was known all through central Illinois.

Terrorized by a Gang of Criminals. Uniontown, Pa., June 25 .- A band of robbers headed by Frank Cooley, an escaped convict, is terrorizing the southern part of Fayette county. Many houses have been robbed, and nearly every day some one is "held up" on the highway. Cooley a desperate criminal, and declares that he will never be taken alive. His gang numbers about twenty desperate men, and they have many abettors.

To Be Buried in Sweden

NEW YORK, June 25.—The remains of Count Lewenhaupt, the late husband of the daughter of ex-Secretary of State Bayard, were shipped on the steamship Werra Wednesday morning. They will be taken to Sweden for interment. The body was accompanied by Countess Lew enhaupt, the widow, and her brother, Thomas F. Bayard, Jr.

McCarthy's Leadership Doomed. Dublin, June 25.—The retirement of Justin McCarthy, M. P., from the leadership of the Irish party is expected to immediately follow the release from jail of John Dillon. There appears to be sensus of opinion that Mr. McCarthy, as leader of the Irish parliament party, has proved a complete failure.




