A Letter From Buchholz.

The following letter from Wm. Buchholz, who is in the Wethersfield prison under a life sentence for the murder of Wm. Schultze in this city, was written to Alvin Neukerchner, also of South Norwalk, which was interpreted and transcribed for us by Editor Ellen-

WETHERSFIELD, July 26, 1891. DEAR FRIEND:-

I have read your letter with much emotion and with tears of profoundest gratitude. The contents of the box were very acceptable, indeed, and I am at loss how to thank the Pitzer's family and the other good friends for their kiudness. You cannot imagine what consolation these tokens of love and friendship are to me in the midst of my sufferings, compelled, as I am to live in a place where all the joys of intercourse with one's friends are wholly wanting, and the restraints to which are so detrimental to my well being. Still, I trace all this back to the hand of an inscrutable Providence, which doubtless, has shaped my fate for some hidden purpose of its own.

I have received a letter from Mr. Bollman in which he advises me to engage a first class and influential lawyer, who should petition the Board of Pardons in my behalf, explaning fully my case and the reasons existing for pardoning me and who should act as my attorney at the hearing. He suggested to me the name of W. C. Case, of Hartford, and I have written to my friend Rosentretu in Philadelphia, to communicate with you on this matter. understand that Mr. Bollman has ceased to be Chief of Police and has returned to his law practice.

May God bless all your endeavors to restore to me my liberty. Accept, together with all other friends for all the kindness and generosity shown to me in the past, my most heartfelt grati-

> The Elm Tree's Foes. The insects that are working such

damage to the elms, this season, are de-

scribed at length by Prof. C. V. Riley in the July Agriculturalist. It is a European beetle and is especially fond of European elms, the common American elms not being so popular with it. It came here about 1837 and is a pale yellow beetle, marked with black. The larva or worm is what does most damage and there are two crops each season. They are hatched from eggs of a straw color, deposited by a beetle on the under side of a leaf, in groups of from five to twenty eggs. The eggs hatch out in a week and the larva or worms do their worst in about two weeks, after which they go in to the ground and are transformed into beeyears of age, committed suicide at his tles. Prof. Riley says that the best way to destroy the pest is to spray the trees, the last of May or first of June, with a solution of Paris green or London purple, one pound to 150 gallons of water, with a pint of kerosene emulsion added for every twenty gallons of water. Another way is to build a tight box about the base of the tree, so constructed that it will catch and hold the larvæ or worms as they descend the trunk to reach the earth.

TO DISBAND A REGIMENT.

Reduction of the Connecticut National Guard Proposed.

From the Hartford Post.

A fact has just come to light that will ause considerable talk in Connecticut militia circles, and cause no end of speculation.

The Post is in a position to state positively that last February, even in the midst of the state officers' muddle at Capitol hill, the country members of the House of Representatives met together and proceeded to get after the Connecticut national guard. An impromptu caucus was held, at which was present a large majority of the members representing the smaller towns of bers representing the smaller towns of the state. The national guard was very thoroughly discussed, and several speeches were made declaring that the worth from the militia. Several members were in favor of disbanding the entire brigade, but more conservative counsel prevailed, and after a rather informal but not the length of the countries. informal, but none the less thorough discussion, the country members de-

discussion, the country members decided to unite in voting to disband one regiment of the brigade. This measure will be advocated so soon as the legislature gets down to business.

The Post relates this story on the authority of one of the leaders among the rural members. DETROIT, July 30.—Some time ago agents of the Jenney Electrical Light company, of Fort Wayne, Ind., secured the Edison people's big plant, paying \$1,000,000, and under the name of the Peninsular Electric Light company went on doing business. Yesterday they secured the Brush company and will consolidate it with the Peninsular. The price paid was \$1,100,000, and is said to have been in cash.

The Keystone Bank Got the Money. PHILADELPHIA, July 30.—The books of the Keystone bank show that the \$945,000 represented by the due bills actually went into that bank. This fact has been estab-lished beyond a doubt by Experts Heins and Wheeler, who have been working at the books for the council's committee. The experts will not talk. The committeemen say that they hope to see where this cash went after it got into the bank.

A Captain Charged with Cruelty. New York, July 30.—Captain J. A. Thompson, of the clipper ship J. F. Chapman, just returned from a voyage around the world, has been arrested, charged with cruel treatment by Eric Axel, one of his crew. Commissioner Shields held Captain Thompson in \$2,500 for examination.

Slashed to Death with a Bazor. GLEN COVE, L. I., July 30.—Two negroes employed by Richard Underhill, of Great Head, got into a fight. Razors were drawn and the men cut and slashed each other until one of them fell down and expired. The survivor has been arrested.

A Jewish Lad's Suicide. NEW HAVEN, July 30.-Louis Robinson itz, a Russian Jew, aged sixteen years, committed suicide at his boarding house in this city. Robinanitz was despondent over his failure to procure work.

Ripened Tobacco Ruined. LANCASTER, Pa., July 30.—Over three inches of rain fell in this section, completely ruining the ripened tobacco and causing great loss.

TWO KILLED AND MANY INJURED.

A Building in Course of Erection Col lapses with Fatal Results.

PITTSBURG, July 30.—The heavy iron and steel framework of the new finishing department of the Elba Iron works, owned by the Oil Well Supply company, on Second avenue, collapsed, killing B. Corkin and an unknown Hungarian laborer and seriously injuring J. Parker, George Ba-ker, George Lemon, F. Stamidt and J. Cobra. Several other workmen were painfully injured. One of the injured men,

an unknown Hungarian laborer, died shortly after his arrival at the hospital. The building was 193 feet long and 106 feet wide. The upright frame was just finished, and the workmen were placing the roof stringers in position. Forty-two men in the employ of Riter & Conley, the contractors for the building, were working at the time of the accident. About thirty employes of the Elba iron mills were standing below watching the progress of the work. Without any warning the massive structure came down with a frightful crash, carrying with it several furnace

stacks, heavy iron stringers and braces. A falling beam snapped a large steam pipe, and in less than a second a tremendous volume of steam was pouring out upon the men imprisoned in the wreck. The workmen in the mills rushed to the rescue of their companions. When the steam was shut off the dead and injured were quickly removed. That so few were killed and injured is remarkable.

A Fearful Cloudburst. AUSTIN, Nev., July 30.—This town was visited by a cloudburst and great damage was done. Clouds had overhung the mountain tops for several days, and when the burst came the water rushing from the summits of the mountains came wave over wave, carrying everything before it, including bowlders weighing over a ton. The city railway was torn from its bed, awnings were torn down and water mains were uprooted from three feet under ground. The majority of the business houses are filled with mud to the depth of three or four feet. The water roared terrifically as it came down the canyon. 

Reed's Brilliant Idea. Reed's idea was that he would thus keep her from marrying any one else, and that in time she would learn to love him. They were married by a justice of the peace, who assisted in keeping the announcement of the fact out of the papers.

It soon became known, however, and at the appeals of the young lady, who was in a constant state of hysterics, and the importunities of her family Reed signed the following remarkable statement:

"I will state that I forced Mary S. Mc-Kinney by threats to marry me, on the condition that it should be kept a secret. The marriage license has been published in the papers, therefore I make this state

The Marriage Dissolved. On the other side of the paper the wife had written: "I promise not to use this paper in any way to injure C. E. Reed." Even this paper the girl signed with her maiden name. When last April she filed a bill in the equity court praying for an annulment of the marriage the husband made no fight, and yesterday Justice Hagner granted a decree dissolving the mar riage and giving the girl the right to resume her maiden name.
She is very well known in Washington,

having been a teacher in the high school a short while until ill health compelled her to resign.

A Bloody Human Hand. NORRISTOWN. Pa., July 30. — Farmer Isaiah C. Gouldey, who resides a few miles above this place, was emptying a bag of feed which he had just purchased when he noticed an immense object drop out with the grain, which, upon investigation, proved to be a bloody human hand. It had been cut off from the arm at the wrist and was in fairly good condition, although somewhat mangled. One finger was missing, but the others were all solid with the exception of bruises, and the remainder of the member was in almost per fect condition, even the hair on the back of the hand being still preserved. From its general appearance it was of course im-possible to tell how long it had been in the feed, which had kept in good condition. Inquiry at the Michigan mill where the feed had been purchased elicited the information that the hand had been cut from an employe and lost in the meal.

Two Girls Missing, BENTON HARBOR, Mich., July 30,-St, Joseph is in a state of excitement over the mysterious disappearance of Nellie Ledge and Grace Belden, aged fourteen and seventeen years. The girls went boat riding Sunday night with two young men of Chicago, Louis Berg and Thomas Waxfield, and have not returned home. The young men say they left the girls on the boat dock at 11:30 p. m. It is feared the girls were kidnapped or foully dealt with. Berg and Maxfield have been arrested and held under bonds for examination next Tuesday. They declare they are innocent. The girls' parents are grazed with grief.

Decidedly Muscular Christianity. MILO, Ia., July 30.—Rev. J. E. Stewart and Elder T. D. Wilson fought to a finish in the United Presbyterian church here, Elders H. F. Schaader and T. P. Spear acting as seconds, gate keepers and audience. A dispute had arisen which led to unpleasant, unchristianlike words, then to force and later to blows. Stewart, being a younger man and with more science on had the elder beaten. All the participants were arrested.

The Dreaded Cotton Worms Uniontown, Ala., July 30.—Great fears are now entertained for the eotten crop throughout this state, as cotton worms which have not been seen for years, are now reported in all directions. If they increase a panic in the farming districts will ensue. The cause is constant rains.

Claudio Vicuna Gets the Unanimous Vote of the Electoral College.

BALMACEDA'S ALTER EGO.

He Will Be but a Puppet in the Hands of the Retiring President and Will Do His Bidding—Government Troops Massing at Coquimbo.

VALPARAISO, July 30. — The electoral college of the Chilian government, repreresenting all the provinces under control of Balmaceda, assembled in this city and unanimously elected Claudio Vicuna his successor as president of the republic. This is simply the confirmation of the popular vote on June 27, when Vicuna was chosen the new chief magistrate of the country.
Vicuna is Balmaceda's own choice as

his successor. He will carry on whatever policy Balmaceda should wish, so that there is very slight consolation for the insurgents in his election. He will take office on Sept. 18 next. The term of office is five years and the salary \$18,000 a year. He will have the naming of five ministers and of

That trouble is looked for at Coquimbo within a short time is evidenced, not only by the fact of the massing of 10,000 to 12,000 government troops at that port and the sending of the Balmaceda fleet north some days since, but also by the news that the American, English. German and French squadrons are now assembled in Coquimbo bay to see that the rights of the citizens of their respective

countries are not infringed upon,

Movements of the Insurgenta, The Esmeralda and Aconoagua, of the insurgent fleet, are hovering off the port also, and it is said the Amazone and Coch-

rane are not far away.
It is reported here that the insurgent army has recently been supplied with arms and ammunition, and it is believed that some of these have been smuggled out of the United States in the steamships plying between San Francisco and the Chilian insurgent ports, and that the rest have been brought into the Chilian insurgent terri-tory through Peru and Bolivia, which are very willing to add all in their power to their old foe's discomfiture. It is also thought that arms and ammunition have come across the ocean in British vessels, It is given out here that Vicuna's election means that energy, honor and patriotism will mark the government's future conduct. There are some 25,000 of Balmaceda's troops at Santiago, Valparaiso and Concepcion. It is said that they can be massed together within one day.

Using Pill Box Lids for Money. Los Angeles, Cal., July 30.—An officer of the Charleston gives it as his opinion that if Balmaceda succeeds in getting his three ships from France the war will be practically ended. Their appearance on the Chilian coast is regarded with horror

by the insurgent party.

The officer also states that Balmaceda held the southern part of Chili, which is the food producing part of the country; that the Congressional party had the northern part, where the nitrate mines lay, which are unyielding and profitless at

Balmaceda has money, is feeding his troops and paying them, and can prolong the war. The Congressionalists have no money and little food, and are having a very hard time. The officers state that the dispatches sent over the wires by both parties are very unreliable. They are doctored and colored by both sides, which-ever side has control of the wires, so it is impossible to get much truth from the

The officer stated that there is no money in Iquique. Every firm issues its own currency. The currency of the country is paper, and it has depreciated to twenty-five cents on the dollar from a gold standard. Pill box lids are a medium of circulation in Iquique. A round lid is good for twenty-five cents, an oval lid goes for fifty cents. The mercantile firm issuing these stamps its name upon them and is supposed to redeem them in gold coin some time in the future, meanwhile honoring them with their face value in goods,

Will Search the Errazuriz. LONDON, July 30.—The Times' Lisbon correspondent says: "The Spanish consul here has been informed that there are Spaniards imprisoned on board the Chilan cruiser Errazuriz. It is also known that several Portuguese were smuggled aboard the cruiser. It is believed the gov-ernment will order that the cruiser be earched before she departs.

Food for the Arkansas River. PINE BLUFF, Ark., July 30.—With a crash another strip, sixty feet in length and extending twenty-five feet toward Barrack street, of Pine Bluff's most valuable real estate was precipitated into the Arkansas river yesterday morning, and the waters are now almost undermining the walls of the Hotel Trulock. As has been feared for several years past, Barrack street, the prominent business thorough-fare of the city, threatens to vanish from the earth in the near future, unless the next congress takes prompt action to protect \$1,000,000 worth of property that is in danger of being swept away by the swift


