State July Death Record.

Dr. C. A. Lindsley has issued the report of the state board of health for July. The mortality report has been received from 166 towns in Connecticut. There were 1,297 deaths reported in the state during the month. This was 322 more than in June, it was only one less than in July, 1880 and 13 less than the average number of deaths in July for the five years preceding the present. Norwalk had 32 deaths, 19 of which, were under 5 years and the death rate was 21.6.

The two cities having the highest death rate were Waterbury, 42.2 and Hartford 28.1. The two cities having the smallest death rate were Middletown 11.8, and New Haven 18.1.

How to use Hot Water Boilers.

Plumbing Engineer Burritt furnishes the DAILY GAZETTE with the following useful hints as to the way our house boilers and hot water backed ranges should be used in the frequent occurrence of shutting off the public water.

"I am often asked by people, what they are to do with their hot water boilers whenever the borough water is shut off. I tell them to do nothing but leave one hot water faucet open at the sink or some convenient point so as to allow any expansion of water to escape or any over-pressure of steam that may be generated by a very hot fire. By simply doing this there will be no danger. Some people think that when the water pressure is off, the fire must be put out in the range. This is all unnecessary and puts the household to great inconvenience. A thirty gallon boiler, full of water, when the outside water is shut off, will last an indefinite learth of time in the heiler if the length of time in the boiler, if not drawn out, as it will take a very loug time for it to boil away. I have known of one to be connected with a range for two months and with a hot fire in it down into the water, while his legs were sticking above the surface.

The line and hook were attached to a barrel, and at about half-past seven the monster took the bait just as the steamer Northam made bait just as the steamer Northam made her landing. The search light of the steamer was brought into service, and with a long boat, manned with half a dozen men, the shark was dragged onto the mud flat and shot. It is the largest shark caught in the harbor in twenty vears.

Fell 65 Feet and Alive.

Simon O'Keefe, aged 21, one of the gangs of painters who are at work on the bridges of the Air Line railroad, at Middletown. fell from a staging to the ground, a distance of 65 feet. "SHOEBOX" MILLER.

The Lover of General Mosby's Daughter

PITTSBURG, Aug. 17.—The history of James M. Miller, the hero of the "shoebox" escapade during his confinement in the Western penitentiary and his escape and return to that institution, where he served out his time, and the Washington city love romance are well known. The unwritten history of the young man is even more remarkable than that published. The child was deserted by the father. His mother died and he was thrown on the mercies of the world. Since that time he has borne a bitter hatred for his father. That these circumstances are true and that Miller's

father is yet a very prominent and wealthy New Yorker is all that I know of the man's early history.
"I have positive proof that Miller was in Cleveland, O., the night of the Connor robbery, and he never held one of the stolen bonds. At Miller's request I have written a letter to Miss Mosby, his flancee, telling her the facts. The man who committed the Connor crime confessed and paid me the money to defend Miller. I

know he is an innocent man." Colonel Moore would not give the name of Miller's parents. A clew has been obtained, however, and will be investigated.

ARRESTED ON A SERIOUS CHARGE. A Thirteen-Year-Old Boy Implicated in a Murder.

THEY CHARGE FRAUD.

Creditors of William E. Schmertz Say He Was Solvent.

PITTSBURG, Aug. 17.-In the United States circuit court Attorneys J. A. Langfitt and S. C. McCandless, representing C. M. Lee and W. F. Moore, of Massachusetts; Myer Rubber company, of New Jersey; the New Jersey Rubber company, of New York city; the Fourth National bank, of New York city, and other creditors, filed a bill in equity against William E. Schmertz, William Loeffler, Amelia Schmertz, E. M. Quimby, S. Severance, W. H. McCleery, sheriff of Allegheny county, and W. E. Schmertz & Co. After setting forth their claims they state they believe the total indebtedness of W. E. Schmertz & Co. exceeds the sum of \$700, 000, while the known assets will not exceed \$325,000. The plaintiffs charge that the confessed judgments are greatly in excess of any actual indebtedness owning by Schmertz to his relatives or friends, and that the same are collusive and fraudulent and for the purpose of hindering and de-laying creditors. The plaintiffs also say that Mr. Schmertz has been insolvent for a long time and has been obtaining goods and money on false pretenses and by fraudulent connivance and assistance of the other defendants. They ask the court to appoint a receiver and decree that W. schmertz was solvent when he executed warrants to confess the judgments, and also that the judgments were collusive and fraudulent. A hearing will be had on Wednesday.

HE IS A PRETTY VILLAIN

A Man with Many Aliases in Prison

in New York.

CHARGED WITH ABDUCTION

Years and Over a Large Part of the Country-Arrested Over One Hundred Times.

NEW YORK, Aug. 17.—Sylvester F. Wilson, or Christian Wilson, or W. S. Franklin, manager of female baseballists, is behind the bars of the Harlem police court prison charged with abducting Lydia Sunderland. Wilson has been arrested on any number of charges in every part of the United States, but so far as known has never been convicted. No clumsy rascal is he, for, though his tastes be deprayed, there is a sort of fineness in his artful dodging from a convict's cell.

He has been arrested over 100 times and always escaped. Among the offenses charged are abduction, forgery, swindling, blackmail, sending obscene matter through the mail and assault.

He Is a Smooth Talker. Wilson is about forty years of age. He is a big man with broad shoulders and an imposing appearance. He wears long, black side whiskers that sweep over his shoulders. A smooth, oily talker, pushing, energetic, tireless, with the most consummate assurance, he fears nothing, always relying upon his wonderful mental re sources to get him out of every difficulty.

Bankrupted His Benefactor. Over thirty years ago he was adopted into the family of the Rev. Hugh Atkinson, a struggling minister in the small town of Humboldt, Neb. About the time reached his majority he was smart enough to get possession of a weekly news paper of that town. He had already gained an unenviable notoriety among the people of the village. His new venture suited his abnormal craving after fame of some

He was arrested for libel and then the more serious one of blackmail was laid against him, and the sheriff closed up the office. His foster father went on his bond for \$2,000, mortgaging his house to secure the bond. The precocious youth jumped his bail and the poor old man was made

Beginning His Career.

Then began a career of offenses against every law. In 1873 Wilson was arrested in Cincinnati for sending an obscene paper through the mails. His record in Cincinnati was very checkered. He defrauded printers, shouted anarchy, and published matter of a blackmailing character. During that year he was three times before the police courts on serious charges.

In 1875 he swindled a man named Robert Keith. He took Mr. Keith in hand and before they parted company the \$10,000 the latter had taken to the city had disappeared. Keith was never able to get the man in his clutches.

No more daring piece of work is on record than Wilson's operations in Philadelphia. He had been so thoroughly ex posed by the newspapers of Cincinnati that he left that city. When the Centennial exposition opened in 1876 the ever smiling Wilson decided to go there and prey on the country visitors. He nov changed his name from Christian to Syl vester F.

"If I do not clear \$10,000 at least," he declared, "I will be sadly disappointed." Made Money Rapidly.

That he made money there can be no doubt, but he also had a great deal of difficulty in keeping out of jail. Opening a ticket scalping office on Chestnut street, he was apparently carrying things with a high head. The ell stranged in the course high hand. That all stopped in the course of a few weeks, for he was arrested on a charge of forging passes and tickets over the Pennsylvania railroad.

The following May he was again arrested on the same charge. He was doing business in Camden, N. J., and the railway detectives broke open his trunks and found five passes that had undoubtedly been stolen from the office. They were signed properly, but a careful investigation proved that the names were forgeries. Wilson had flown to New York. Officers followed and he was arrested and taken to Camden Wilson engaged counsel and made a mos vigorous defense. The case was a notori ous one, and when the jury disagreed everybody in Camden was astonished. Twice afterward was he put to trial, but both times there was a disagreement. so disgusted the railway officials that they dropped the matter and Wilson returned to New York, and was soon afterward ar rested on the charge of attempted abduc

His Last Victim.

His last victim, Lydia Sunderland, i bright, pretty and smart. She said that she was glad that Mr. Gerry's society had got her, for she wanted to be good again.

To a reporter who saw Wilson he said that he was a much persecuted person.



A Lady Aeronaut Dashed to Death from a Dizzy Height.

CINCINNATI, Aug. 17.-Annie Harkes, aged twenty-two years, an aeronaut and parachutist, professionally known as Frankie Lavell, was instantly killed by falling from her trapeze at Coney island, a summer resort twenty miles above this city. The unfortunate young girl had gone up in a balloon for a distance of perhaps 2,000 feet, and was coming down safely by the aid of her parachute.

In order to give some gymnastic per-formances on the trapeze of the parachute she unloosened the snaffle and ring which held her to the trapeze and had gone through but a few acts before the onlooks ers were horrified to see her holy tumb-ling at a fearful rate to the ground from a height of at least 500 feet.
