BIG BOROUGH BOLT.

Tax-Payers in Mass Convention.

Largest Meeting on Record Last Night.

The largest meeting of the Borough of Norwalk, within the memory of ye oldest inhabitant, packed the Town House last night. Every seat was filled and two-thirds of all the aisle space was densely packed with a standing mass of voters, while other crowds unable to gain entrance even upon the outside steps, left the place in disgust. It was evident that something of far more than ordinary interest had awakened the tax-payers of our Borough and packed them within the walls of our Patagonian town edifice. As it was to be a Borough meeting, pure and simple, Warden Keeler acted as chairman and Clerk Hubbell as secretary. The meeting started off by Engineer Wood giving a detailed account of the leaky condition of the Grupe dam and the estimated cost of its effectual repair, which he thought could not be done for less than \$12,000. He made clear statement of the causes of the present season's scarcity of water, which primarily, was the unprecedented drought and the fact that many new streets and houses had been piped and that our storage capacity had proven inadequate to all these unusual demands. He thought a thorough repair of the leaking dam at Grupe's reservoir, would in ordinary conditions of rain, etc., serve to temporarily supply the Borough demand for water, but that in the near future, more storage

its growing needs. There was an abundance of the best of spring and living water in the Borough's sources of supply, but it needed more storage capacity than we now have to be secure against the contingencies of accidents and the severe dry spell experienced this summer. He was questioned and catechised by Attorney Hurlbutt and others, and promptly responded to all such demands with candor and good temper.

capacity must be provided to supply all

Mr. Byington stated that several years before our present water system had been built, he had secured the pas sage through the legislature, of a charter for such a system and had employed the water engineer of the Hartford system to visit the Silver Mine brook and that he had designated the large valley between two very high hills, a little above the Daniels place, as the best spot for a storage reservoir anywhere on the Silver Mine stream. He stated it as his opinion that a short, and not expensive dam could be put cross there that would flow from two to three hundred acres and store all the water Norwalk would be likely to need for twenty years and that by extending the dam at this point, a sufficient storage for 50,000 people could easily be secured. He felt confident there was elevation enough there to flow into a distributing reservoir at the highest point on the hill west of the Borough. Subsequent events have shown at what a high cost to the Borough, Engineer Bissell's judgment was departed from. Mr. B. thought it would have been vastly cheaper, to have constructed the second dam and reservoir at this point than to have gone four miles further up into Lewisboro to build our second storage reservoir. In this view, Engineer Wood fully concurred. In Mr. Byington's opinion, it would have been wiser to have, last summer, placed a third reservoir at the Daniels locality than to have spent \$25,000 in laying the new iron pipe main from this point to the Grupe reservoir.

And now to pay \$12,000 additional to repair the leaks in that dam, would eat up as much as it would cost to have built a new reservoir at this point, although land damages would, no doubt, be much more now than they would have been had the flowag e rights been purchased twenty years ago.

On a vote being reached to appropriate the \$12,000 for repairing the Grupe dam, it was overwhelmingly voted down and the adverse temper of a large majority of those present made emphatically manifest.

Next came the highway improvement questions. There were three distinct propositions and all dove-tailed into the one vote, viz. to pave with granite blocks, Wall street, from the railroad tunnel to the foot of Mill Hill, and up Main street, from Wall street to Hoyt street, then to M'Adam Main street from Hoyt to the Wm. R. Nash home. cussion followed as to dividing these three propositions, Mr. Hurlbutt charging that they had evidently been thus grouped for the purpose of killing the entire project of road repair, and that Main street from Hoyt street to its head was in a disgraceful, if not

Then, as fast as the votes could be put on the three paving propositions they were promptly voted down, and the meeting adjourned.

There was deep and earnest feeling prevading the meeting, but remarkably good order and good natured feeling maintained throughout.

TILL TAPPER CAUGHT.

A Private Detective Brings a Well known Young Man to Grief.

The Thief was to have been Married To day.

The facts of a very interesting tilltapping case leaked out this morning for the first time.

Ever since Butcher Avison moved into his new store at 158 Main street, two years ago, and in fact, for a year before that, he has missed small sums of money from his money drawer.

The source of the leak could not be determined and the clerks and attaches of the store were watched, in turn, but to no avail, and the leakage continued. Some time ago a private detective from New York was employed, and the result of his labors were, that William G. Hubbs, a clerk in the store, who has been in Mr. Avison's employ for nearly three years, was accused of the thefts, and Saturday evening confessed and was arrested

When the detective first took hold of the case a thorough investigation was made, and the old trick of sending some one into the store to purchase goods while Hubbs was there alone, and then count the cash in the drawer, was played, and worked to a charm.

This was the first intimation that Hubbs was the guilty party, and after this trick was played and worked so successfully, marked bills were resorted to, to make sure of the man, and these were afterward found on Hubbs.

Saturday evening when the climax came, and Hubbs was arrested, he begged piteously to be given a chance to settle up, and promised to go to Long Island and get the money from his grandfather to settle with.

This opportunity was given him and he was to have met Mr. Avison in Lawyer Lockwood's office, in the Gazette building, last evening, but did not do so, and up to this writing he has not returned.

He was to have been married to a young lady at Chestnut Ridge, N. Y., to-day, and on this account Hubbs was not taken to the lock-up, but was placed in the custody of the detective until Monday morning, when he was brought before Justice Coolidge and the case continued for two weeks and as little publicity as posssible given to the affair, but everything was done by Mr. Avison to hush the matter up, and give Hubbs a

A BIG FIRE IN NEW YORK.

The Old Commercial Advertiser Build ing Swept Away-Loss \$400,000.

NEW YORK, Sept. 16.—Fire was discovered on the second floor of the old Commercial Advertiser building, on the south west corner of Fulton and Nassau streets and in fifteen minutes the flames had gained such headway that they were practically beyond control. Four alarms were sent out, but the streams from the engines were weak, the pressure of water being so poor that the flames rapidly spread to the adjoining buildings, and for a time even threatening the buildings on the opposite

side of the street. The people employed in The Advertiser building, of which there were several hundred, all made their escape by means of the fire escapes on the front of the build ing. The building, which was old, is said to have been condemned by the fire department twenty-five years ago, burned fiercely, and before the firemen were able to obtain a much greater pressure of water the flames burned and spread with the rapidity of a forest fire until the building was a mass of ruins. A DARING JAILBREAKER

Detective Gilkinson's Assassin Makes Good His Escape.

TIES PILED ON THE TRACK

A Bold Attempt to Wreck the Cannon Ball Express on the Pittsburg, Fort Wayne and Chicago Road-A Story That Wasn't Believed.

PITTSBURG, Sept. 16.—Frederick C. Fitzsimmons, the murderer of Detective Gilkinson and a desperate thief, escaped from the county jail about 2 o'clock in the morning. The escape is the most daring ever effected in this part of the country. He was incarcerated in a cell in Murderer's row on the first tier awaiting his trial for murder, which was to begin next week. Fitzsimmons had already been convicted on several charges of robbery.

The prisoner gained the jail corridor by sawing the bars on his cell door. He then scaled the walls, reaching the top of the building, where he used his saw on the bars of a window overlooking the warden's house. By a most desperate leap he ning rod, and then scaled the high stone wall by means of a rope that could have been secured only by means of outside assistance. From the top of the jail wall he jumped to the roof of the shed on the Old avenue side of the jail.

Not a Trace of Him. tier to Murderer's row says that at 2 o'clock he saw a man pass his cell door, but at latter's horsewhip from his hands at that time supposed it to be the night tempted to strike him with it. Last Saturday Detectives Murphy and Beltzhoover warned the authorities that Fitzsimmons would try to escape. A special guard was placed over the prisoner Saturday and Sunday nights, but last night the precaution was omitted.

THE TRACK PILED WITH TIES. The Cannon Ball Express Has a Narrow

Escape from Being Wrecked. CHICAGO, Sept. 16.—A bold attempt was made to wreck the Cannon Ball express on the Pittsburg, Fort Wayne and Chicago railroad last night. The train was two miles east of Whiting, Ind., when Engineer Pierson saw an obstruction on the track, and, reversing the lever, brought the engine to a stop against a barrier of railroad ties. While the passengers and trainmen were standing about the engine discussing their narrow escape from death, Charles Howard, of Whiting, an employe of the Standard Oil company, came run ning up and said he knew all about the attempt to wreck the train.

"There were five of them," Howard said excitedly, "and it was their intention to wreck the train and then rob the express messenger and the passengers."

His Story Not Believed. Howard then told how he met the five men at Whiting during the afternoon, and that they invited him to walk down the Pittsburg, Fort Wayne and Chicago tracks after darkness had set in. It was about 7:10 o'clock when the party reached the spot where the ties were placed on the



The State Convention Holds a Short Session at Saratoga.

AND ADJOURNS FOR THE DAY

ored, Not the Least of Which Is That of the County Demacracy Against Tammany Hall.

SARATOGA, Sept. 16 .- Before the Demo cratic state convention opened, the only bit of political gossip of any importance that floated about the lobbies was the announcement that Maynard had withdrawn from the contest for attorney general in favor of Rosendale. This seemed to assimplify further the work cut out for the convention. There were a number of delegation meetings held for the purpose of selecting state committeemen chiefly. The County Democracy met and decided not to carry its contests for seats in the convention before the committee, but to go before the full convention with the demand that their thirty-six delegates be admitted. They refuse to go before the committee on the ground that they are not contestants. They are particularly sore over the action of the state committee in refusing them representation in that exodus from the hall. body, and are full of fight toward Tammany.

The Convention. The rink in which the convention was held was decorated simply. Stripes of red, white and blue cloth covered the beams. A single row of flags and banners hung from the beams, alternating with Chinese lanterns. The chairman's desk was draped in bunting and the back of the stage was curtained with large flags. There was a number of ladies on the platform. The delegates, as they took their seats, found spread out before them a big circular setting forth the claims of Alfred

C. Chapin to the nomination of governor.
On the second page was a fine photoengraving of Mr. Chapin.

The Eric county Sheehan delegation
entered the hall, headed by a brass band
and carrying a banner with Sheehan's picture. There was some cheering, but the enthusiasm was not marked.

C. Chapin to the nomination of governor.

At exactly noon Ed Murphy, Jr., chairman of the state committee, accompanied by D. G. Griffin and Commissioner Ridgvay, passed up the center aisle and mount ed the platform. They were greeted with applause. Hugh McLaughlin's entrance a minute later aroused some enthusiasm among the Chapin men. Mr. McLaughlin shook hands with John R. Fellows and

Bourke Cockran. Chairman Murphy called the convention to order and announced the action of the state committee in choosing the Hon. George Raines for temporary chairman. The action was ratified without dissent, and Mr. Murphy appointed D. Cady Herrick, of Albany, and J. W. Hinckley, of Poughkeepsie, a committee to conduct Chairman Raines to the platform. After the applause which greeted his appearance had subsided Mr. Raines addressed the convention. He said in part:

Chairman Raines' Address.

GENTLEMEN OF THE CONVENTION-The duty GENTLEMEN OF THE CONVENTION—The duty we here discharge demands that the purest patriotism enlighten judgment. The discussions of preliminary assemblies must here yield their sharp antagonisms. The trust of power is an invocation to duty. Rivalries for representation in local or state organization are expressions of opinion of value in guiding party sentiment to the masterful issues in the thought of the people, but the embittered words of faction are hateful to the true Democrat. It is tion are hateful to the true Democrat. It is the glory of our organization that its conten-tions destroy none of the elements of its power-ful support in the affections and convictions of

its partisans.

The campaign which draws upon us is to be fought upon the records of parties in state administration. It will reassure the confidence of the people in their actual leadership. We are no longer left to conjecture as to Repubare no longer left to conjecture as to Republican leadership. Plattism stalks in midday for popular view and judgment. Exile Miller is silent. Belden is indifferent. Wadsworth is sullen. Becker has a genuine German fit of indignation. The cultured White, who gathered to his candidacy the moral force and pure conviction of his party, expressed his thanks for "the honor eyen of a serious mention," and withdrew by a letter written the day previous to the convention.

Fassett's leadership has been enforced upon his associates by every appliance of machine politics. He has held by the throat the largest interests of the state until they gave up a bribe of place or subservience to the ambition of Platt. Its worthy leaders have stepped aside to await his culmination. The hour of that assembly was the signal for the surrender by Mr. Platt of his senatorial blockade. The hour had passed and the senatorial block-ade had been effective.

pire state. The speech was greeted with applause at intervals. While Mr. Raines was speak ing, the hall had filled slowly, until every inch of space was occupied. The center aisle was packed, and movement up and down the side aisles was almost impossi-ble. Mr. Raines concludes his speech amid great applause. Bourke Cockrap

then moved the election of the temporary NEW YORK'S DEMOCRATS then moved the election of the temporary secretaries chosen at the meeting of the state committee last night. The motion was carried. The secretary then began to call the roll of the convention for changes. As the roll call proceeded notices of contests were filed and received for reference to the committee on contested seats when

The Contests. When the name of Hugh McLaughlin was reached in the list of Kings county delegates the Chapin men cheered loudly. The names of John R. Fellows, George Raines, General H. W. Sloeum, Hugh J. Grant, Bourke Cockran, Menry D. Purroy, Thomas J. Gilroy and Edward Murphy, Jr., were cheered also. Three rousing cheers were given for Richard Croker. R. L. Veenking sevented notice of contest in J. Voorhis presented notice of contest in twenty-four New York districts amid cheering and applause.

At the conclusion of the roll call the

rules of the assembly were adopted for the convention. On motion of Mr. McMahon, a resolution for the appointment of a com mittee on contested seats was adopted. sure the nomination of Rosendale and to Resolutions were adopted also for the appointment of committees on permanent organization and platform.

J. W. Ridgway, of Kings, offered a resolution for reference, commending the work of the Democrats in congress in op-posing the "revolutionary and despotic legislation known as the force bill," and commending especially Senator Gorman, of Maryland. The resolution was received with cheers.

The convention then took a recess of five minutes to permit the delegations to confer on the appointment of the members of the committees. The announcement of this recess was the signal for a general



THE MIMIC WAR MANEUVER

The German Army Has Mastered the Use of Smokeless Powder-The French General Saussier's Bad Blunder-Human Heads on Posts-Russian Misery.

LONDON, Sept. 16.-A dispatch just received here from Constantinople says there is no other foundation for the story of a well a low priced shoe Sigri, on the Island of Mitylene, than is found in the fact that a party of British leather; no sham. A neat naval officers on Saturday last left their looking shoe, comfort also. ship for the purpose of picknicking on a deserted isle off Cape Sigri. The party embarked the same evening, and on Sunday their vessel sailed.

BERLIN, Sept. 16.—From Constantinople there comes an official denial that Sigr has been occupied by a British force.

Saussier's Tactical Blunder. PARIS, Sept. 16.—The Temps today says that General Saussier, the commander in chief of the French army maneuvers, and the officer who was considered to be the man best fitted to assume supreme command of the French army in the event o war with Germany, allowed himself to be surprised and hemmed in by the cavalry of the enemy on Sunday last. The pape adds that General Boisdeffre, who com manded the mock enemy, not being de sirous of capturing General Saussier, per mitted his cavalry to give way before General Saussier's escort.

The Kaiser Well Satisfied.

London, Sept. 16.—The Germany army maneuvers have proved more successful than those of last year, for the reason that the troops are more accustomed to their novel weapons and to the smokeless powder. At first it required the utmost care and watchfulness on the part of the officers to prevent the men from being demoralized by the smokeless powder, which they were unable to understand. But now this peculiar feeling is generally overcome, and the new recruits are steadied by the example of the older men. The kaiser has expressed his entire satisfaction with the conduct of the troops.

A Ghastly Exhibition. A dispatch from Aden, Arabia, says that the heads of the conquered Yemen rebels have been distributed about the various Turkish ports in Arabia and stuck on posts for the edification of the inhabitants. At Sana, which is a great trading center, no less than fifteen heads are on exhibition in various stages of decay. It appears that Ahmed Rushdi, the Turkish commander, surprised a large rebel force while they were asleep and keeping a poor watch. He slaughtered them without mercy, taking no male prisoners, and the dead who had been leaders in the revolt were decapi-tated. The interior tribes remain unsubdued, but the inhabitants of Yemen have

Shrieking for Food.

all submitted to the sultan.

St. Petersburg, Sept. 18.—The distress in the Volga provinces is intense. In Penza women and children wander about almost utterly exhausted, shricking for food in the market places. The governor of Saratov especially remarks that children are the worst factor in such a crisis as this. All existing charities and Red Cross so cieties are paralyzed. Russian corn mer-chants on the frontier are despondent over the idea that the German trade will find fresh channels and never return to Russia

General Logan's Monument.

DETROIT, Sept. 16.—Mrs. John A. Logan, who is visiting General Alger's family here, said last evening: "I am here to see General Alger in regard to the monument to be erected to General Logan in Washington. I should like to have this monument ready for unveiling when the Grand Army meets in Washington next year, but I fear there is not time enough now to do it. General Alger has promised me to ask the committee to meet in Washington at an early day to ask for designs. The location has already been chosen by congress in the Iowa circle in line with the statues of General Thomas and General McPherson. I want the monument to be of bronze and granite. I think nearly enough money has been raised for the pur-

More Legacies Than Money. BOSTON, Sept. 16.-A bill in equity came up in the supreme court today against Charles Babbidge and others, executors of the will of Thomas Wentworth Pierce The object is to decide whether the children of the testator are entitled to priorit; over other legacies, the assets being insuf ficient to pay all legacies in full. The estate is valued at \$1,250,000, and the total legacies about \$2,000,000. If the court decides in the children's favor the other lega tees will get little or nothing. A suit is also pending for the removal of the trus-

A Town in Great Danger. St. Mary's, O., Sept. 16.—Much excitement prevails here over the burning of a large tank in the upper oil fields. The oil is running through the heart of the city, the river being covered with the fluid. If the oil should catch fire nothing could save the greater part of the town. The loss in oil is enormous. Nothing definite has yet been learned as to where the great quantity of oil comes from.
