#### HARVEY M. WATTERSON DEAD.

Editor Watterson's Father and Sole Survivor of the Twenty-sixth Congress. Louisville, Oct. 3.—Hon. Harvey Ma gee Watterson, father of the editor of The Courier-Journal, died at the home of his son in this city. He had been sick three weeks. Harvey Magee Watterson was born at Beech Grove, the family home-stead, Bedford, Tenn., Nov. 23, 1811. Harvey Watterson received a classical education, and before he was of age had married and began the practice of law at Shelbyville, Tenn.

He was elected in 1885 to the Tennesse legislature. He was elected by the Democrats, and served in the Twenty-sixth and Twenty-seventh congresses. In 1847 he bought and edited the Nashville Union, and in 1851 was called to be editor of the Washington Union. His devotion to the Union was the master passion of his political life. In 1861 he was elected to the convention to consider the secession of Tennessee.

At the convention, finding all efforts for union futile, he retired to his home at Beech Grove. On Johnson's coming to the presidency he was called to Washington and became a trusted adviser. From 1869 to 1879 he practiced law. The last twelve years he has spent partly in Washington and partly with his son here. Mr. Watterson was the sole survivor of the Twenty-sixth congress.

#### PRESIDENT DILL REARRESTED. The Bank Official Was Released on Bail,

but at Once Rejailed. CLEARFIELD, Pa., Oct. 3.—President Dill, of the suspended First National bank of this place, and of the private bank at Houtzdale, which also suspended, and John B. McGuath, cashier of the latter bank, who were arrested on the charge of

embezzlement, entered bail. Mr. Dill was at once rearrested on a warrant sworn out by National Bank Examiner Miller who is in charge of the First National bank, and held in \$25,000 bail. He has as yet been unable to obtain bonds-

The report that Mr. Dill has made an assignment is incorrect, but judgments aggregating \$30,000 have been entered against him. Twenty-six thousand dolagainst him. Twenty-six thousand dollars of these judgments are held in trust for his wife.

President Ezeta declares that the Guatemalans are ripe for a plan of consolidating all Central America into one republic, and he will not lose the opportunity of bringing about this result.

BOULANGER WAS WELL OFF.

Mme. Bonnemain at Her Death Left Him Three Million Francs.

BRUSSELS, Oct. 3.—Several photographs of the body of General Boulanger have been taken as it rests in the coffin. The coffin is composed of three cases. The innermost one is of lead, lined with white satin. On the lid is a large mahogany cross, and a copper plate upon which is inscribed, "General Boulanger."

A chambermaid, on entering General Boulanger's room a fortnight ago, surprised him on the point of committing suicide.

All on board escaped to the shore, and after much exposure and suffering reached Apia in safety and left on the Monowaii for San Francisco. The Pennonia was a total wreck.

Dead in His Cell.

NEW YORK, Oct. 3.—Daniel Thompson aged forty-five, a laborer, who was arrested on suspicion of being implicated in some recent burglaries, was found dead in his cell in the police station. It is said that at one time Thompson was quite prominent in theatrical circles, but of late years had been much addicted to drink.

A Conflagration That for a Time Threathened the Whole City.

THE MILITARY CALLED OUT

Buildings Were Blown Up to Stay the Spread of the Flames and the Fire Got Under Control with a Loss of Only Half a Million Dollars.

HALIFAX, N. S., Oct. 3.—The most disastrous fire that has visited Halifax in years started in Merlin's planing mill on Taylor's wharf, near the Cunard wharves. In a few minutes the place was all ablaze and the fire spread rapidly. A gentle breeze from the north carried showers of live sparks to the buildings, vessels and wharves south of the fire. The whole department was called out and engines from Dartmouth came over to render assistance.

Within an hour Merlin's mill, Wilson's blacksmith shop, John Taylor & Co.'s big fish warehouse, filled with pickled fish; Brookfield Bros.' lumber warehouse and yards, all on the Taylor and Brookfield wharves, were destroyed. By this time the fire had spread to Liverpool wharf on the north and burned out Butler's sparyard, B. Swenerton, Miller's agent, the Halifax broom factory, J. B. Neills & Co., commission merchants, and Shatford Bros., oil dealers.

Oil Dumped Overboard.

Large quantities of petroleum were stored on this wharf, and there were great fears of an explosion. This was prevented by rolling the oil into the dock. The fire also spread simultaneously to the South wharf, and soon the immense fish ware-houses of John Taylor & Co. were a prey to the flames.

The firemen then directed their efforts to prevent the spread of the fiames to the big fish warehouse of Daniel Cronin on the south and De Wolf & Sons, agents of the Anchor line, on the north. A score of schooners at the burning wharves were quickly moved out into the harbor.

In less than an hour the whole block from John Cronin's on the south to the north side of Hamilton's wharf on the north, almost adjoining the Cunard wharves, had been destroyed. The city is crowded with visitors attending the exhibition and 10,000 spectators lined the wharves in the vicinity of the conflagra-

The oil was mostly importations of the Standard Oil company and the Eastern Oil company.

The City Threatened. The flames spread with such frightful rapidity that the whole city was threat ened and the military was called out, and the admiral ordered out all the men-ofwar sailors with their hand engines and The Royal Engineers blew up a number of buildings to prevent the spread

of the fire. After another hour of hard fighting the flames were got under control and the danger to the rest of the city averted. The loss will be over half a million. No loss

of life is reported. Sketch of Halifax.

Halifax is the chief naval station of British North America. It is protected by eleven different fortifications and contains a royal dock yard. This is one of the largest and finest in the British colonies, cov ering fourteen acres.

Halifax is the commercial as well as political capital of Nova Scotia. It has regular steam communication with Newfoundland, the United States, the West Indies and Great Britain. Railroads run from Halifax to Pictou, Annapolis, St. John, the United States and the provinces of Quebec and Ontario. It is the southeastern terminus of the Intercolonial railway. The harbor is six miles long and one mile wide, with good anchorage in every

part. A large amount of shipping is owned there. The city has also important manufacturing interests and a number of fine public buildings.

In 1881 Halifax had 36,100 inhabitants It supports twenty-four churches, four daily and eleven other newspapers, forty policemen, six banks, two members of the Canadian house of commons and two in the provincial legislature. It is the seat of an Episcopal bishop and a Catholic archbishop. The city received its present name in 1749, when it was proclaimed the capital of Acadia. Before this time it was called Chebucto.

An Orphan Asylum Burned. CINCINNATI, Oct. 3.—The main building of the St. Aloysius orphan asylum, north of this city, burned to the ground. When the flames were discovered the school was in session, 192 children being distributed

throughout the building. When the alarm was given a panic en sued, the frightened cries of the nurses and children adding to the terror of the occasion. The children were all removed from the burning building in safety, however, owing to the faithful work of the nurses and sisters. The building is a total loss, but is fully insured. Three men were injured, though not fatally, by a falling

Alliance Cotton in Flames. BIRMINGHAM, Ala., Oct. 3.—Fire at Alexander City burned the Alliance warehouse and 500 bales of cotton. The loss is \$25, 000, partially insured. The cause of the

fire is unknown. BRIEF MENTION.

The New York chamber of commerce passed a resolution opposing the monthly purchase by the government of 4,500,000 ounces of silver.

The Irish National League of America is in session in Chicago.

In addition to the Yorktown, it was said that the Boston and Atlanta had also been ordered to go to Chili. The Boston is being fitted for a long cruise at the Brooklyn navy yard as rapidly as possible, and the Atlanta is expected to arrive and receive her outfit very shortly. The Yorktown may be gotten ready to sail by Sunday.

A revolutionary plot was discovered in Barcelona, and several conspirators were arrested. Arrangements had been made to seize the prisons and liberate the prisoners when a republic would have been proclaimed.

Superintendent of the Census Robert P. Porter, in reply to the criticisms made by the National Civil Service Reform league, says that the eleventh census has been well, honestly and acurately taken.

The city authorities of Greencastle, Pa., have been unable to discover the cause of the typhoid fever epidemic in that town.

Who that man was is what cannot be ascertained, but the detectives are doing their best to find him. If he is found, the way would seem clear to the key of the mysterious gloom which is now so impenetrable. He may have been a friend. He may now be his mur-

Confident of Foul Play.

NEW YORK, Oct. 3.-Colonel R. Wayne Wilson, who has known Mr. Monaghan intimately for years, is impressed with the belief that his friend has met with foul play. "I am positive," Colonel Wilson told a reporter, "that Mr. Monaghan is not missing of his own accord. It seems strange that such a prominent man should disappear in New York in this mysterious manner without a trace of him being found. Mr. Monaghan had few friends in New York, and if he had been convivially inclined some of us would have met him. If nothing had happened to him I am sure he would have called upon me. Not one of his friends has seen him. Mr. Monaghan takes a drink when he feels like it, but he never drinks alone. If he had been drinking at all he would have gone to some place where he could find friends-at the Southern society's house or somewhere else. He has not been to any of the places where he could meet friends.

"I think he has fallen into the hands of thieves and maybe murderers. We have searched nearly all the hospitals where he might be taken if an accident had befallen him, but can find no trace. He has never left home without advising his wife of his intention and letting her know when he would return. Whenever he was delayed he immediately informed her. There is no doubt in my mind that he is restrained of his liberty by force, if he is still living. He is a sociable man and readily enters into conversation with strangers. Some 'steerer' may have accosted him and lured him to some dive, where he was probably assaulted and robbed. He usually carried considerable money about his person. It is certainly a strange case. This talk about his being on a spree is preposterous."

A Wealthy Man's Son a Forger. CHICAGO, Oct. 3.-Forgeries against the International Packing company that may reach \$10,000 and involve the son of a wealthy and influential citizen of Engle-wood, who is exerting every artifice to effect a compromise, have just come to light. Detective Madden said to a reporter that a number of persons were involved in the forgeries. He admitted that he knew the name of the leader and that he was the son of wealthy parents at Englewood, but he would not furnish the name for publication.

DAYTON, O., Oct. 3.-A Big Four working train crashed into a hand car at Carrolton station, six miles south of here, and Samuel Morris, conductor, of Miamisburg, O., was instantly killed, and all of the crew of seven men who were with him in the caboose, were injured, several seriously. The conductor's body was taken to Miamisburg, and the injured were brought here and placed in St. Elizabeth's Hospital.

JAY GOULD'S CONDITION.

Conflicting Reports About the Health of

the Wall Street Magnate. NEW YORK, Oct. 3.—Alarming reports published concerning Jay Gould's health had it that at the meeting of the Missouri Pacific directors Wednesday Mr. Gould broke down, became incoherent in his utterances and suddenly burst into tears. The attack, it was declared, was of an hysterical character, to which he was lia-ble, and resulted from an extreme mental

strain and imperfect digestion. It was also asserted that Mr. Gould had been

similarly affected at a meeting of the Union Pacific directors a week or ten days At Mr. Gould's office in the Western Union building Friday it was stated that Mr. Gould was at Irvington. Regarding the story of Mr. Gould's ill health it was said that Mr. Gould had been at his office every day this week until Friday, and that he was there when there was no special necessity for his being there. This, it was

claimed, did not look as if he was very ill. Notwithstanding that statement, however, it was learned by a reporter that the story of Mr. Gould having been attacked while at the Missouri Pacific meeting is substantially true. It is stated on the authority of one of directors who was present at the meeting that Mr. Gould broke down completely, "went to pieces," as he expressed it, and had a hysterical fit of weeping while explaining the situation of the company to his fellow directors.

CIVIL WAR IN TANNA.

Two Villages Wiped Out by the Strife and a Cyclone Sweeps the Island. SAN FRANCISCO, Oct. 8.—Advices by steamship Monowaii say that the island of Tanna has been visited by a huricane and devastated by a civil war. Fierce fighting is now going on, and two villages have been wiped out of existence. In the midst of the fighting came the fearful hurricane. The German ship J. W. Gil-dermersten was wrecked in Dianirua bay. The cutter Hilda was driven ashore, and canoe containing nineteen natives lost.

Tanna is one of the principal islands in the New Hebrides group in the Pacific ocean, north of New Caledonia and west of the islands of the Feejees group. are 10,000 inhabitants of the island of Tanna, who belong to the Papuan race. The island is eight miles broad and eighteen in length.

Three Men Instantly Killed. LEOMINSTER, Mass., Oct. 3.—Fred Miller, a slater, of Grafton; Simon Warden, a stable keeper; George Quint, a barber, and J. Frank Gallagher, a barber, were re-turning from the Pepperell cattle show in a two seated carriage drawn by a span of horses. As they approached a railroad crossing the gateman waved his red lan tern to warn them of the approach of a train, but the horses became frightened. and, running away, dashed upon the track directly in the face of the engine. Gal-lagher, seeing the danger, managed to jump from the wagon and escaped unhurt, but the other three men were killed instantly, as was one of the horses. The victims were terribly disfigured and their remains were taken to Shirley Station.

Hanged by Masked Men.

BIRMINGHAM, Ala., Oct. 3.—Masked white men visited the house of John Brown, a well to do negro farmer, near Childersburg, Ala., and carried him off on a pretext that they were officers and had a warrant for his arrest. Brown's body was afterward found in a creek with a rope around his neck. He had been hanged to a bridge, and when dead the body had been cut down and thrown in the water. No cause for the deed is known excepting that Brown was a witness against two white men charged with burning a barn

Serious Row at a Circus.

TENNESSEE, Ills., Oct. 3.—At E. C. Rogers' show an employee got into a row with Allan James. James stabbed the show man, who will die. The attaches of the circus would have lynched James but for the interference of citizens, who rescued the man and locked him up. The sheriff will endeavor to bring the prisoner to Macomb, but the showmen swear they will never allow James to leave the place alive.

SIOUX CITY, Ia., Oct. 3.—The fifth an nual Sioux City corn palace was opened with impressive ceremonies. Owing to severe rainstorm the street parade and elaborate out of door exercises planned for the occasion were postponed. The corn palace has been built and adorned on a scale far surpassing all previous designs.

Attempted Murder and Suicide. FREMONT, O., Oct. 3.-Joseph Hobe, German, from Toledo, made an attempt to murder his wife, who had left him and was living in this city. He then shot him self through the head with a revolver and died almost instantly. Mrs. Hobe was not seriously injured, the bullet cutting through the forefinger of her right hand.

Disappeared After the Failure. PARIS, Ills., Oct. 3.—The Standiford Bros.' bank failure at Chrisman is get-ting worse. The depositors will lose everything they had in the bank, and there is a long list of them. One farmer alone loses \$15,000. The Standifords have disappeared, and it is alleged that they tool \$75,000 with them when they left.

Spain Wants Satisfaction. MADRID, Oct. 3.—Moorish tribesmen attacked a Spanish fort at Cablerizas, near Melitla, Africa. The fort replied with cannon and musketry. The fighting lasted for three hours, when the Moors retired. The Spanish government has made a de mand upon the sultan of Morocco for

reparation. Monbars Breaks His Own Record. RICHMOND, Ind., Oct. 3.—Monbars made a successful attempt to beat his own 2year-old stallion record. He was driven a very even mile by Budd Doble, the quarters being made in 341/2, 1:08, 1:441/2, 2:183/4. Nelson failed to break his record, his mile being made in 2:111/4.

Married His Aunt and Got Arrested. PITTSBURG, Oct. 3.—Jeremiah Traver, 8 soldier of the regular army, while on a furlough married his aunt, twenty years his senior. He basked in her smiles be vond his time, and Friday was taken to Columbus as a deserter.

Mrs. Harrison's Movements. Boston, Oct. 3.—Mrs. Harrison and Mrs McKee were the guests of ex-Governor Oliver Ames at Easton. They returned to Auburndale after lunching with the fam ily and visiting the points of interest in the town.

A Montana Town Snowed Under. RED LODGE, Oct. 3.—It has been snow ing and drifting incessantly for the last forty-eight hours. There are three feet of snow on the level. Business is practically

The Uprising Quickly Subdued and No Further Trouble Is Feared.

TWAS A WAR AMONG CHIEFS

The Ringleaders Arrested and Imprisoned-Malaafa Is Still Treated as King and He Is Inclined to Be Restless. A Mixed State of Affairs.

SAN FRANCISCO, Oct. 3.—Advices from Apia, Samoa, under date of Sept. 16 say: Natives on the island of Monona have been trying for some time to upset the present government, and a few weeks ago some of the chiefs who expressed their intention of going to Mulinuu to join the government had their houses pulled down and their plantations destroyed by order of the other chiefs. As soon as news of the outrage was received here Baron Von Senft, president of the municipal council, who is also adviser to the king, and United States Vice Consul Blacklock went to Monona on the United States steamer Iroquois, arrested, tried and found them guilty, and sentenced them to six months' imprisonment.

The people of Manona at first threatened to rebel, but afterward returned to their islands, promising to obey the government. No further trouble is feared. In order to frustrate any attempt at rescue, the prisoners were taken to Union Gasut, about 300 miles from here. The natives say that this action savors strongly of the methods of ex-Consul Brandcie, of Germany. The chief justice is absent on a trip to Sydney, having left just be-fore the trouble started, against the wishes of the king and government and with the disapproval of the consuls. Mataafa Still King.

Mataafa is still at Malie with about 300 men, and is treated as king. He is keeping the country in a state of unrest. A story has been circulated that the United States would help in the event of war, and this has had the effect of keeping a number of discontented chiefs about Mataafa. Consul General Sewall wrote Mataafa that he should not think of being king, and that he would forfeit the good will of the United States if he persisted. This letter was suppressed by Mataafa, but copies have now been circulated among natives with good effect.

Chief Justice Cedarkrantz gives great dissatisfaction here. He has limited knowledge of the English language, and cannot conduct supreme court cases or transact ordinary government business. He refuses to have anything to do with the governing country, and although he has been nine months in Samoa he has not framed a single law for the guidance of the Samoan magistrates, as he was ex pressly directed to do by the treaty. refuses to pay duty on liquors, etc., which he imported for his own use, and there is no appeal from his decision.

The German land commissioner and English consulsay that if the chief justice does not pay, neither will they, on the ground that they are representatives of foreign powers. There is nothing in the treaty to show that the government officials should be allowed this privilege. Couldn't Coerce the Government.

The president of the council has lost the confidence of the king and the government. The president, not content with being adviser, attempted to become dicta-tor. He tried to force old German silver marks in at par after the government had decided against it, ordering them to reconsider their judgment and threatening that Germany would be very angry if her money was not accepted.

Owing to the geographical position of the islands, American and English money is the only one of any use, except at heavy discount. However, the government would not be coerced, so the money used now is American gold and silver, sovereigns, German gold (twenty marks), and Chilian silver dollars.

The municipal council is completely under the president's thumb. He sent all the funds to a bank at Sydney, and it is believed that he has deposited the money in his own name. Although information on the subject was asked a month ago by a tax payer it is not forthcoming. He is about to take a government residence at Mulenuu to cost about \$4,000. He called for bids for the jail without consulting the council, but the council refused to consent

Munro's Yacht Disabled.

BRIDGEPORT, Conn., Oct. 3.—Norman Munro's steam yacht Norwood ran upon Penfield reef, off this harbor, and one of the blades of her propeller was twisted. The Norwood put into this harbor for re-pairs and is still tied up here. C. S. Eaves, the pilot, lost his bearings completely and ran her head on the reef. Captain W. A. Seaman says that the race with the Vamoose will be delayed until a new wheel is procured. The yacht will be here until re paired and will then proceed to New Lon don. The pilot left immediately for New York and refused to be interviewed.

Serious for North Dakota. JAMESTOWN, Oct. 3.—All over North Dakota there is disappointment. The big crops are lying in the fields about as they were tossed from the binders. Rain has been pouring steadily on the unprotected crop for the last twenty-four hours. Fifty millions of bushels of wheat are out in the wet shocks, and there is no telling when they will be thrashed. Thrashing outfits are making from \$50 to \$150 a day, and not half enough machines can be had. It is indeed a serious state of affairs.

Assassin Fitzsimmons Heard From. PITTSBURG, Oct. 3.—The murderer Fitzsimmons, who shot Detective Gilkinson and who recently escaped from the county jail here, was heard from yesterday. He sent \$1,000 to his attorney, Thomas M. Marshall, to obtain a new trial for his wife, who was indicted with him, and, after his escape, found guilty of murder in the second degree.

Jewelry Thieves Jailed. NEW YORK, Oct. 3.-Robert Howe and

Nellie Hamburg, convicted of stealing jewelry, valued \$7,000, from Carl Wer necke, were sentenced. Howe was sent to state prison for eight years and six months, and the woman to five years and six months.

Vedder Sues Sessions for Slander. JAMESTOWN, N. Y., Oct. 3.—Commodore P. Vedder has begun an action for slander against Hon. W. L. Sessions. Mr. Ses sions charged that Mr. Vedder had pro-cured his last three nominations for sena tor from this district by bribery.




