Annual Report of the State Board of School Visitors.

The above just issued report (which includes the annual report of the secretary of the board,) does Gen. Olmstead, of the Norwalk Board of School Visitors, the honor of making four distinct quotations from his returns to the state board. Two of these extracts, which are given a place in the state report, are of such serious local interest that we re-copy them entire, as follows: Attendance, Irregular.—This school [Winnipauk] suffers from irregular attendance, and the withdrawal of pupils immediately after they have passed the compulsory age. There is no excuse for much of the first-named evil. If parents would but awake to the value of constant attendance on school work, this cate of things would seem to a this state of things would cease to exist. Much is done in this school by the ist. Much is done in this school by the teachers, in making school attendance interesting and profitable, only to be neutralized by the indifference of parents. The loss to the child by this unpunctual and irregular attendance is not to be measured by the school work thus omitted, but by his failure to learn at the proper time in life the all-important lessons of punctuality and application. It is also to be recretted application. It is also to be regretted that the older pupils are so early with drawn to assist in the expenses incident to their homes. Doubtless, in some cases this seems a necessity, but before resorting to this means of augmenting the family tracerum pupils should rethe family treasury, parents should reflect that in keeping their children from school they are doing them an irreparable injury.—Norwalk, Charles Olmstead, School Visitor.

Ventilation.—[At Over River School.]

Four large heaters, or stoves, are distributed in the four lower rooms, employed not only to furnish heat for their respective rooms, but to take the vitiated air in each room, heating and sending it (by means of registers in the floor,), with its death-dealing properties, into the rooms above, there to be used over again. In this enlightened age this is suicidal, and should be immediately remedied, either by introducing the three by the control of the control ducing into these heaters fresh air from outside the building and excluding that in the room where the heater is placed, or, what would be infinitely better, superceding these ancient land-marks in the spinors of heating by marks in the science of heating by modern and health-conducive methods. -Norwalk, Charles Olmstead, Acting Visitor.

Here is a revelation as to the mode of heating the Over River School that should shock and alarm every parent whose children attend that school. No wonder that diphtheria, scarlet fever and kindred diseases are bred and fostered when such scandalous conditions are permitted to exist. Pure air, of phere, is by this outrageous method of heating, turned into the most deadly of poisons. If these school rooms are to be heated by hot air from iron furnaces at all, then a current of fresh air should be constantly poured in from the outside, on the heated surfaces of these furnaces and independent pipes from them conveying heated air intro-duced into every separate room. EX-PRESIDENT GUZMAN DEAD.

He Was One of Nicaragua's Most Distinguished Citizens.

MANAGUA, Nicaragua, Oct. 21. - Dor Fernando Guzman, the ex-president of the republic, is dead. His death is universally regretted.

Very few men in Nicaragua were held in so high and general esteem as ex-Presi-dent Guzman, who was nearly four score at the time of his death. He was born in Grenada, Nicaragua, of a distinguished Spanish family, the American founder of which came over with the conqueror, Cor-tez, and which has helped to frame the political history of Central America in no

small degree. Fernando Guzman was eminent in affairs of the state for half a century, as a representative in the lower house, as a senator, as secretary of state, as president (1867-71), and as diplomatist. He first came to this country officially in 1863. In 1879 he was minister to England, and was

also minister to Spain and to France. He leaves a widow and four sons. A fifth son, recently dead, was a graduate of Harvard. One, Senor Horacio Guzman, has been minister to the United States since 1887. Another, Don Henrico Guzman, married in 1882 an American lady, Miss Mae Ewing.

INDIANAPOLIS, Oct. 21.—The German Evangelical conference adopted the plan presented by Bishop Breyfogle, by which the names of all seceders will be marked upon the church records and noted as having withdrawn irregularly. The Rev. William Yost has been scored by the Philadelphia conference for the part he took in the investigation of Bishop Imbbs for al-leged immorality. "The stories are all false," said he, "I never even saw Miss Nagle yesterday, having last seen her on Sunday. I was away yesterday on private business. I am not married to her but hope to be soon. Miss Nagle was not at my boarding house on Sun-

day as has been reported."

Mr. Van Alstyne, the assistant general freight agent corroborated Brennan's statement that he was away on business. Mr. Van Alstyne said that the stories were instigated by malice on the part of certain persons, who might shortly realize that they had made a serious mistake.—Bridgeport Farmer.

ACCIDENTLY KILLED.

The Careless Handling of a Shot-Gun Causes the Death of a Cuban Student at Wilton.

The Parents of Deceased in Cuba.

Filippe Gutierrz, a Spaniard and a student at Charles Whitlock's boarding school in Wilton, was killed yesterday atternoon by the discharge of a gun

Gutierrz, who was about 21 years of age, came to this country about two years ago from Cienfuego, Cuba, and has been a pupil at Whitlock's school ever since. He was passionately fond of hunting and shooting and was permitted to hunt at will.

which he was handling at the time.

Yesterday afternoon he started out in company with two younger scholars of the school, about 1.30 o'clock, after game. He carried an old double-barrel shot-gun of French make and peculiar design, which he had brought

with him from Cuba. They were absent about two hours, and when returning home and near the house of Irad Morgan, Gutierrz stopped to light his pipe.

He placed the muzzle of the gun against his abdomen and was about to fill the pipe with tobacco, when one of the younger boys called his attention to the fact that the gun was cocked, and he had better be careful.

He made some reply, jokingly, that

he was not afraid and reached over to lower the hammer of the gun, still keeping the muzzle against his body. He had drawn the hammer of the right barrel part way back, when his

finger slipped, and the hammer re-

bounded against the cartridge, discharging the gun, the full contents of which entered his body. With a groan he fell to the ground,

and the younger boys ran to Morgan's house after help. A crowd soon collected and the injured man was carried in an unconscious condition to the residence of Charles Mann, near by and Dr. Gor-

ham, of Wilton, and Dr. Huntington. of Norwalk, summoned. Here everything was done for him that was possible, but he never regained

consciousness and at 4.05 o'clock, he died. The wound made by the charge from the gun was a peculiar one, having the appearance of being made by a ball cartridge, rather than shot, but this was caused by the muzzle of the gun being so near the body when the discharge occurred. The wound was not larger than the bottom of a small bottle and the course of the shot was upward,

causing excessive laceration of the intestines, which produced death. After death the body was removed to Taylor's undertaking shop where it was viewed by coroner's physician Huntington, and a certificate of accidental

death given. As Gutierrz had no friends in this country and both of his parents being in Cienfuego, Cuba, his banker, J. M. Ceballos, of Wall street, was notified of his sudden death and is expected to arrive to-day, when some arrangements will be made for transmitting the body

to Cuba. Gutierrz was a favorite among the scholars at the school and very popular with the Wilton people, and his sudden

death is a great shock to that quiet town. Governor Bulkeley's Position

NEW HAVEN, Oct. 21.-Governor Bulkeley defines his position in a newspapor in-terview. He says he is of the opinion, and always has been, that the constitution provides that the legislature shall declare his successor, and that whatever the supreme court may do in the way of deciding law points and in advising the legislature on the latter's position the court has no right to declare a governor elected, nor can the legislature, a co-ordinate power, part with its authority to so declare to the supreme court or to any one else. Governor Bulkeley is ready and anxious, he says, to sur-render the executive chair to the rightful claimant whenever some one in authority shall tell him who that one is.

A Chance of Reconciliation Under the Leadership of Dillon.

REUNION IS A NECESSITY,

If the Proposed Liberal Home Rule Meas ure Proves Inadequate Coercion Must Be Reserted to and That Demands an Undivided Party.

London, Oct. 21.-John Dillon's speech eulogizing Paraell has considerably softened the feelings of the Parnellites toward him, especially as it was coupled with a repudiation of the attacks in the Dublin Catholic on Parnell's memory. No one doubts the observations taken the mountain is betruth of Dillon's takement, that he loved truth of Dillon's statement that he loved Parnell, and there is only one speech of Dillon's on record in which he antagonized Parnell strongly, and that was on the subject of the Paris fund. It was delivered a few days before Parnell's death.

Dillon May Lead. Before going to jail Dillon had been careful to keep a moderate course. He hoped that dissension would come to an end before his release. Upon being liberated he threw his lot in with the Mc-Carthyites, but he never used personally abusive terms regarding Parnell, and the utmost charged against him by the Par-nellites is that when an offensive term was used in his presence he failed to rebuke it. There is no proof that he heard it, and if he did he probably thought it best to ignore it. Dillon is, undoubtedly, con-sidered by the Tories the strongest man of the two factions, and the most positive and commanding character.

Favoring a United Party. The Dublin Freeman's Journal says that a strong feeling in favor of a determined effort in the direction of reconciliation exists throughout the country. The Journal adds that if the measure of home rule granted by the Liberals is inadequate it will again become necessary to coerce them into submission. This could only be done by a united party.

Hungary Burning for Revenge. An incident is reported from Buda, Hungary, which illustrates the bitterness which remains in the Hungarian heart regarding the events of 1848, and the burning desire for revenge on Russia which then intervened to quench the revolution in Hungary. The Hungarian minister of public instruction, Count Csaky, has been compelled by popular pressure to rebuke and suspend one Lutter, the head master of the state gymnasium at Buda, because he had forbidden boys at his school to take part in celebrating Oct. 6, the anniversary of the day in 1848 when thirteen generals of the Hungarian army, who surendered to the Russian Marshal Paskevitch, were cruelly hanged. The master had not acted from any unpatriotic motive, but popular feeling was greatly aroused against him.

Eating Dogs in Russia. Advices from southeastern Russia state that extraordinary measures are being taken everywhere by the local authorities to deal with the distress, and that systematic personal application is being made to all the well to do for aid. The appeals do not bring in as much as was hoped, on account of the stagnant condition of trade. From the district of Jetinchef comes a peculiar story to the effect that the dogs of that region, which are noted for sagacity and which are used largely for carrying burdens and other domestic duties by the peasantry, have nearly all disappeared, having been killed by their owners and others for food.

Glaz unoff Ordered to Leave. M. Glazounoff, the Russian musical composer in whose house was found a trunk containing revolutionary pamphlets, the trunk having been left there by a female nihilist, has been ordered to quit to Glazounoff, that being the amount of bail which he placed in the hands of the police when first accused in connection with the matter. Nobody seems to doubt the composer's innocence and, it is be-lieved that he was sent out of the country so that the police might keep the bail he had deposited.

To Tax Deer Forests. Professor Bryce, M. P., has made a sensation in Scotland by his advocacy of a special tax on the owners of deer forests, on the ground that the forests are a luxury of the wealthiest class and can well bear the burden. Professor Bryce also advocated the enactment of a law prohib-

iting the creation of new deer forests.

Freight Trains in Collision. ONEIDA, N. Y., Oct. 21.—A freight wreck occurred on the New York Central railroad west of here. A freight train east bound was standing on track No. 4, near a curve, waiting for a train ahead to get out of the way. Another long train came around the bend, but could not stop in time to prevent a collision. Four cars of the first train were demolished, turned upside down in a ditch below They were loaded with nails, flour and other articles. Luckily there was no loss of life. The engineer and fireman of the wrecked train made their escape by jump-

Looked for a Gas Leak with a Light. PITTSBURG, Oct. 21.—An explosion of natural gas occurred in Snaman's large carpet store on Federal street, Alleghany City, setting fire to the building and seriously injuring three persons. The building was entirely destroyed. The explosion was caused by hunting for a gas leak with a light. The injured are F. G. Hilliard, an employee of the Alleghany Heat-ing company; William A. Snaman and an unknown woman. Hilliard was so badly burned, the physicians think he will not

Insulted the Mayor.

A Row Between the Associated Press and the Western Union.

ABOUT A MATTER OF \$25,000

The Associated Press Refused to Pay the Western Union's Charges, Claiming an Offset, and the Telegraph Company Turned It Down.

NEW YORK, Oct. 21.—Much interest has been excited in journalistic circles by the announcement of a serious misunderstanding between the Western Union Telegraph company and the Associated Press, and many wild rumors are in circuation. The following statement from Mr. W. B. Somerville, press agent of the Western Union Telegraph company, tells the situation. The Cause of the Trouble.

The difficulty is about alleged obligations to the Western Union Telegraph company for leased wires, and the wires bout which the difference arose are leased by the New York Associated Press. The wires leased for the use of the Western Associated Press have been paid for, those for the New York Associated Press have not been settled for and the obligation counts from June last to the present time, the amount being about \$25,000. Refused to Pay.

The joint committee of the New York and Western Associated Press first took the matter in hand. That committee consists of representatives of the New York Herald, New York Tribune, New York Sun, Louisville Courier-Journal and the Cincinnati Commercial Gazette. The the members of the joint committee representing the New York Associated Press. The latter concluded not to pay the Western Union company on the ground that it was offset by overcharges.

The Wires Cut Off.
The Western Union accordingly notified the New York Associated Press yesterday that its leased wires would be cut off at once, and it was done. The wires in ques-tion are one wire from New York to Chicago, two wires from New York to Washington, one wire from Washington to Richmond and Norfolk, and one wire from Memphis to New Orleans.

Benson Says He Is Innocent. LEAVENWORTH, Kan., Oct. 21.-Charles . Benson, convicted of the murder of Mrs. Mettman, whose mutilated body was found in a sack in the river at the government reservation near here, will be executed Nov. 4. He has written a letter in which he accuses John Mettman, thevictim's husband, and Mary Rantzoh, the victim's daughter, of having committed the crime. He says the murder was committed in the Mettman house and that he witnessed it from the outside through a window. Mary Rantzoh, he says, gave him money to go away with, so that he would not turn up as a witness against herself and father. It is generally believed that this alleged confession contains no truth.

Colonel Joseph Lowery Dead. UTICA, N. Y., Oct. 21.—Colonel Joseph Stewart Lowery, aged forty-nine years, a native of Oriskany, this county, died here ast evening. He organized Company D, of the One Hundred and Forty-sixth regiment, N. Y. S. V., and for bravery in the field was promoted from sergeant to colonel. He was wounded in such a peculiar manner that his case was one of the only two in which the victims have been known

The Speer New Jersey Wine Company and Passaic Item Burned Out. PASSAIC, N. Y., Oct. 21.—The great ware-house of the Speer New Jersey Wine company caught fire, and it burned so rapidly that in two hours it was totally destroyed. The firemen did good work, but were unable to save the building, as great quantities of spirits stored made the place burn like tinder. With the exception of a few papers, nothing was saved. The office and plant of the Passaic Item, which were in the building, were also destroyed. The brigin of the fire is not known.

A stranger passing along the street first iscovered the fire. He sent out an alarm, and the entire fire department responde In a short time a great crowd assembled to look at the flames. It was feared at one time that the First Reformed church would be burned, but this was saved. That part of the warehouse which stood on the west shore of the Passaic river has been standing for thirty years. The warehouse was four stories high and was built of brick. Between 500 and 1,000 barrels of wine were consumed by the flames. The loss will reach \$100,000. There was some insurance on the place, the precise amount of which is not known.

Set on Fire by Tramps. NEW BRUNSWICK, N. J., Oct. 21.—The large brewery of Joseph Schneider, in Highland park, opposite this city, was set on fire by tramps. Six buildings, including a dwelling house, were burned with their contents. The loss is \$80,000. The property was insured for \$27,000.

ing in his room. He broke it open and found his wife's clothing packed in it. While examining the trunk Whalen came in. Whalen asked Coy what he was doing with his trunk, and a quarrel followed. According to the story told by Coy, Whalen stepped out and returned, armed with an ax and club, and struck Coy with his fist, knocking him into a corner. Whalen subsequently struck at Coy twice with the ax. The latter grappled with him, and after a severe struggle succeeded

in wresting the ax from him. Whalen then made an onslaught on Coy with the club, and the latter in self defense struck Whalen on the head with the ax, smashing his skull and killing him

RAUM HAS NOT RESIGNED.

That His Retirement Has Not Been Demanded by the President. The Loss of the Despatch.

WASHINGTON, Oct. 21.-Major General

Oliver O. Howard, commanding the military department of the east, devotes much space in his annual report to the war department to the discussion of coast defenses. He says that at New York, San-Francisco and Boston new guns and mortars are needed. Many fixed torpedoes or submarine mines have, however, been aleady constructed for use at these points. General Howard calls special attention o the necessity of having fortified points as a basis of a proper defense of our national interests, and recommends that a complete defense of the combined harbors of Savannah and Port Royal, S. C., by works on Tybee, Hilton Head, Parry and St. Helena islands be established, as the nost available points for that purpose.

Increased pay for noncommissioned oficers is also recommended. General Howard gives but a half hearted indorsement of the canteen system, and says that no oldier should be permitted to act as a barkeeper in a canteen.

No 2 was today awarded by the navy department to the Iowa iron works of Dubuque, Ia., at their bid of \$113,500. The boat is to be of 120 tons displacement, and s to be finished within one year. Raum Hasn't Resigned.

At the White House neither confirmaion nor denial could be obtained concerning the rumors that ex-Governor Steele, of Oklahoma, is to succeed Raum as commissioner of pensions. The report comes from the friends of Governor Steele, and has that measure of authenticity.

Commissioner Raum was seen at his esidence by a reporter, and in reply to in-

quiries said: "My resignation has not been tendered, nor has it been asked. For some months similar reports have been circulated concerning me and these have come from unfriendly sources. I saw Governor Steele in Chicago recently. We are friends and talked over many matters, but no hint came from bim that the president desired to place him at the head of the pension office. Just why rumors have been started at this particular time that I am intending to resign or have resigned, I do not know. There is no reason why I should tender my resignation."

The Despatch went ashore on the night of Oct. 9-10, and these reports prove that the Drift must have been in her proper place at that time


