A Day's Introspection.

Never before in the history of our heaven-blest land, have the distressing conditions of other nations of the earth served to so thoroughly inspire the reverent gratitude of the American people for bountiful harvests, health and unbounded prosperity at our Thanksgiving anniversary period, as environs us to-day.

In all Continental Europe. great depression and destitution among the laboring, manufacturing, mercantile and financial classes prevails to an unusual degree. Floods, storms and disasters have devastated hundreds of homes there and ruined the monetary fortunes of thousands.

In far off-Japan, hard struggling to free itself from the half barbarisms of the ancient Orient and to attain the new civilization and progress of the Occident, comes the woeful, terrible story of not less than ten thousand of. her people killed outright and swallowed up by earthquake.

Next, the still more horrible and harrowing tale of scores of millions of Russia's poor starving for want of food. The sickening story of eating cats, dogs, their horses, cows and all domestic animals by the hitherto better classes, and devouring rats, mice and other vermin by the poorer ones, while gaunt famine, with her shriveled lips and bone projecting cheeks, sweeps the land with plague and fever and death. The heart sinks and sickens as the appalling condition in the land of the Czar, is contemplated. Sad, sad, indeed, is the fact to us here in free, abundant America, that while our tenderest sympathies are aroused by these dire calamities in other lands-"the touch of nature which makes the whole world kin,"-that they are so remote from us, we are largely denied the possibility of affording them succoring aid and can only render them the poor as-

Grand and glorious America! with wonderful health, marvellous prosperity, enormous harvests, abundant peace, labor rewarded, and affluent in all that ennobles and exalteth a nation.

What abundant cause have we, as a people, to give thanks to Almighty God in a spirit of reverent gratitude for all his unnumbered mercies, to-morrow, our Thanksgiving Dev.

A Welcome Prophecy.

Some time since the Courant gave utterance to the following prophecy which every one who has occasion to go over the New York and New Haven trains to or from New York, will rejoice to see become a realized fact. It would seem that if the rush of passenger business on our road continues to augment in the near future as in the near past, such a withdrawal from the Grand Central depot and tracks, will become inevitable. The Courant remarks that up to this time the effort in New York to secure the opening of the Harlem River drawbridge during the rush of morning and evening travel has proved a failure. The park commissioners who have the power to do this are evenly divided on the subject and so it cannot be carried. The hitch adds to the annoyance of a large population and thereby hastens the day for a solution of the present problem. It is evident that the Fourth avenue viaduct and Grand Central depot cannot much longer accommodate the immense volume of travel that is pouring through there. It remains to be seen what will be done, but it is by no means improbable that the union station will be movel up above Harlem River or that with a friendly separation (room being worth more than company) the Consolidated road may retire to a depot of its own on what is now called the Portchester brench.

The Legal Battle Closed.

At 9.30 vesterday morning the arguments were resumed in the case of Morris vs. Bulkeley before the Supreme Court of Errors in the capitol.

Hon. William C. Case opened for the Republican side and was followed by ex-Governor Ingersoll who spoke for over an hour, dwelling on the funda-mental constitutional question involved, emphasizing and forcibly presenting the claims of the Democrats that the election is consummated in the presence of the electors. The Hou. H. C. Robinson closed for the Republican side, answering the main points raised by the Democratic counsel and insisting that it was competent for the Legislature to go behind the returns. It was decided to sub nit no supplemental briefs and the Court was adjourned

So far, so good, but is not this the same story which has been told to a suffering and patient people, for the last fifteen years? Another reservoir and all will be well; then came the new pipe line to make things doubly safe; while thirdly and lastly, a reservoir site has been found that will make a sure "pop." that will end all troubles

and bring to our souls the comforting assurance of Mother Goose: They lived in peace and died in pot-grease For fear that this happy state may not come just now. I would most hum bly suggest that the water officers be gin a role that has never been practiced in this Borough. Take the people into their confidence. Tell us all about the whole matter. We pay the money, and are entitled to a fair consideration. If one goes down to South Norwalk, he can find our by asking that their reservoir holds from 770 to to 780 millions of gallons, nearly a two years supply for their wants. That looks like business.

A man very near to our water administration says that had it not been for the extension out of the Borough limits, to-wit, East Norwalk, the extra thirty thousand dollar pipe line need not have been laid, and of course no new reservoir would have to be built Had we not better sell these pipes to South Norwalk, and give up the telle of rent which we now receive from those out of town neighbors and strictly attend to looking after the vater interests of our own people?

An injunction has already been served upon Mr. Andrews restraining him served upon Mr. Andrews restraining him from selling the gaslight company's stock which he now holds.

In addition to his other offices Mr. Andrews is president of an artificial ice company and of a firm of contractors that is now ballasting a portion of the New York Central railroad. He was formerly a director in the American Loan and Trust

A German Socialist Elected.

BERLIN, Nov. 25 .- The election for member of the Reichstag at Halle has resulted in a victory for Herr Hartman, who defeated a prominent member of the National Liberal party, the latter having the support also of the government and conservative party. THE FIGHT FOR SPEAKER

Bynum Withdraws from the Contest in Favor of Mills.

THE CRISP MEN CONFIDENT.

Friends of the Georgia Congressman Claim That He Now Controls 114 Votes-Mills' Claims Not Borne

WASHINGTON, Nov. 25.—The speakership contest is beginning to assume its most interesting phases. After all the claims that have been made for Mr. Mills that he would have a majority of the New York and New England delegations, it has developed that he has been reckoning without his host. His attempts to capture these votes have failed for the most part, and it is claimed that Mr. Crisp has not only a large majority of the New York votes, but a majority also of those in New England.

At his last visit to New York Mr. Mills tried to capture the votes in Brooklyn which have heretofore counted for Mc-Millin, but he failed in this and returned considerably disheartened with the result. In fact, returns from the canvass of other candidates show that many of

W. D. BYNUM the votes that have been claimed for him would go to McMillin, Springer, Hatch and Crisp. He has been counting on a solid delega-tion from Missouri, but all but one of that

delegation have declared their intention to stand by Mr. Hatch as long as there is any chance in the world of his election, and if they do split, not more than three of them will go to Mills. If reliance is to be placed in what members themselves write or say as to their preferences, Mr. Mills' canvass has been one of silly as sumption and empty claims.

Bynum's Withdrawal. The withdrawal of Mr. Bynum from the fight has been expected for some time. It has been understood by a great many people all along that his candidacy, for some time at least, has been merely for the purpose of holding the Indiana delegation, since he could not throw more than a minority to Mr. Mills. It was expected that he would remain in the fight until within a day or two before the caucus, but some demonstration in favor of the Texan was thought to be necessary at this time if he himself was to remain in

This and an intimation that he could not hold the Indiana delegation longer led Mr. Bynum to make the announcement yesterday that he was no longer a candidate, and to declare, what has been known all along, that he was for Mills. He did this after a conference with three of his colleages, who are in favor of Mr. Mills' candidacy.

At a time when some of the loudest claims were being made for Mr. Mills he was preparing to retire from the fight, and would have done so but for the fact that some of the Texas folks and others who were supporting him protested loudly against his doing so after they had entered the contest for him. He had started the preparation of a letter announcing his withdrawal-that is, he was considering and discussing the terms of such a letter. Crisp's Friends Confident.

Some time before the 4th of July he and Mr. Bynum had a conference in Willard's hotel to discuss a proposition for both he and Bynum to retire from the fight, and to combine their forces on Mr. Hol-It was found, however, that they could not hold their men to the Indiana objector, and the project was dropped Since then Mr. Bynum has been staying in the fight for the purpose of holding the Indiana delegation together, and Mr. Mills has been trying to capture enough votes in the east to make his campaign potential.

Out of a claim of fifty-four votes made for him two named are known to be for McMillin, one for Springer and four for Crisp, while severa have declared positively that they are not yet committed to any one. Without giving names, however or location by states, as many as ninety

votes are claimed for Mills.

Mr. McMillin, Mr. Hatch and Mr. Springer have not yet made any definite claims as they all are second choice candidates of a number of members whom they cannot now claim. Mr. McMillin particularly is favored as second choice by a very large number of members

Mr. Crisp's friends claim that he has 114 rotes. They are distributed as follows: Alabama, 6; Arkansas, 1; California, 2; Florida, 2; Georgia, 9; Kentucky, 5; Louisiana, 2; Maryland, 6; Massachusetts, 5; Michigan, 3; Minnesota, 1; Mississippi, 6; New Hampshire, 2; New Jersey, 4. New York, 17; North Carolina, 9; Ohio, 10; Pennsylvania, 5; South Carolina, 7; Virginia, 9, and West Virginia, 3.

The Women Showed Fight.

CHESTER, Pa., Nov. 25.-A big camp of gypsies squatted on Henry C. Fritz's farm in Nether Providence. He procured legal help, and a dozen farmers armed with pitchforks charged on the gypsies, who, when they sighted the armed force, fled to the woods; but the women showed fight, gathering in a group and refusing to surrender. There was a good deal of parleying, and the gypsies promised to vacate the premises, which they did after paying the costs.

Hyde, of Newton, and had 114 rooms, elegantly furnished. The fire is supposed to have been caused by workmen who were making repairs. Loss, \$90, 900; insured for \$60,000.

JAPAN BOWED IN GRIEF

A Quarter of a Million People Homeless in One Prefecture.

STARVATION THREATENING

Additional Details of the Fearful Earthquakes Show the Calamity to Be Appalling-Many Families Were Roasted and Buried Alive.

SAN FRANCISCO, Nov. 25 .- The cable brought the main outlines of the great earthquake in Japan on Oct. 28, but the condensed reports gave no idea of the terrible features of the calamity. The earthquake was strongest in the prefectures of Gifu and Aichi, where towns have been overthrown, the country submerged and mountains are in eruption and railroad communication is interrupted.

Up to Nov. 9 statistics showed 7,524 persons killed and 9,458 wounded, while 90,000 houses had been destroyed. The greatest destruction occurred at Gifu. A correspondent there says that a quarter of a million people were made homeless in that prefecture. He adds:

"There are twenty-eight places where the soil sunk more than three feet, the total area of this subsidence being nearly three acres. Fissures in the ground are also frequent. They vary from one to three feet in width, and some are fifteen feet deep. I have counted over 100 large fissures, and as for smaller ones they cannot be reckoned.

A Terrible State of Affairs.

"The banks of the Nagara river are totally destroyed. In one place near the river there is a subsidence of over twenty feet. In some parts of the town boiling mud spouted out of fissures to the height of ten feet. The majority of them continued for one or two hours. More than 3,000 wells are totally destroyed.

"The condition of Kasaoko-Cho after the earthquake and the conflagration was appalling. There were 1,050 houses in that district and over 4,000 inhabitants. The shock overthrew nearly all the houses, and when the survivors were struggling to rescue the injured fire broke out on all

"From the fall of the houses to the outburst of the conflagration there was an interval of only twenty minutes. Only twenty-nine houses remained standing when the flames were extinguished, and 200 people had been either crushed or burned to death. In some cases whole families of eight or nine perished. Starving people may be constantly seen wandering over the cracked fields in search of potatoes, turnips or any other edibles. It is a terrible state of affairs."

Burned and Roasted Alive. Not a few persons, entombed amid the ruins of houses have been roasted to death. Out of 200 temples in Gifu, more than one third were totally destroyed, and of twenty-five temples in the town of Ogaki only three escaped injury. The banks of the Shonai river in the Kasugai district were thrown down by the earthquake and

numerous fissures appeared in the ground.
At a distance of about 2½ miles from the bridge over this river, where the ground had been conspicuously disturbed, muddy water and stones have been ejected from the fissures in such quantities as to form a kind of small volcano, on top of which is a hole from which mud was thrown out constantly until Oct. 30. The latest telegrams to hand are from Nagoya, dated Nov. 4, and from Gifu dated Nov. 5.

According to the former earthquakes continue to be felt, but the interval between them is gradually increasing and the intensity of the shocks diminishing. From the commencement of the disturbance up to the time of dispatching the telegrams there had been no less than 6.610 shocks, which means thirty-eight shocks per hour, or more than one every two minutes.

Whole Towns Wiped Out.

The first of the above telegrams gives another and increased statement of casualities in Alchi prefecture. The record stands thus at present: Alchi prefecture, killed, 2,248; wounded, 3,310; houses totally destroyed, 42,345; houses partially destroyed, 1,818. The Japan Mail says that of 4,434 houses

constituting the town of Ogaki 3,356 are are completely overthrown and 765 are partially ruined. Fire has destroyed 1,473. The number of persons killed is 747; the number severely injured, 520, and the number slightly injured, 750.

Appalling as is the magnitude of this calamity, still more terrible is the report which comes from Gifu prefecture as a whole. A telegram dispatched on the afternoon of Nov. 1 gives the number of killed in the whole prefecture as 5,000, the number of wounded at 15,000 and total number of houses destroyed 15,000 to 16,-

In addition to the destruction wrought in the towns of Gifu and Ogaki, the smaller towns of Ichnomiya, Kyosu, Ke-somatsa and Takegahans are said to have been wiped out altogether.

Stockton's Public Building Site.

WASHINGTON, Nov. 25.—Assistant Secre tary Crounse accepted the property of J. M. McCarthy fronting 121 feet on California street and 134 feet on Market street, Stockton, Cal., as the site for the public building in that city. The price paid is \$17,500.

FONSECA'S OVERTHROW.

Acting President Peixotto Restoring

LONDON, Nov. 25.—Dispatches come free-ly now from Rio Janeiro, the censorship having been removed. The resignation of Marshal da Fonseca was a great relief and has proved a solution of the complications which were gathering around the new re-

Acting President Peixotto and the provisional cabinet by which he is surrounded will now proceed to restore the operation of the constitution and laws. The general elections will be hurried on, the legislature assembled at the earliest possible moment and unity and harmony beble moment and unity and harmony be-tween the provinces re-established.

In Rio Janeiro confidence is returning and business has revived. There is great rejoicing over the turn things have taken, and Marshal da Fonseca is highly praised for his patriotism in withdrawing from power, although no regret is shown for his resignation.

The change has brought peace and tranquility to Rio Grande do Sul, but the provisional government of that state still holds an attitude of armed attention, awaiting the proceedings of the new government at Rio, in which implicit confidence is not yet placed by the Republicans, it being regarded as a creation of the ex-President da Fonseca, and not to be trusted until it is tried. In fact, it can-not last long. It must make way for a new one which will command the confidence of the whole country.

Don Silveira Martins, formerly governor of Rio Grande do Sul, is spoken of every-where as the future president of the re-public. He is a moderate man, but a strong Republican, and through all the vicissitudes of Da Fonseca's administration has retained the confidence of the people while incurring the enmity of the marshal, who regarded him as his most dangerous rival.

Entirely Opposed to Revision. CHICAGO, Nov. 25 .- The Chicago presbytery, by a vote of 54 to 18, resolved to over ture the general assembly to turn entirely from the project of revising the West-minster confession, and "to take diligent steps to have proposed to the church such simple and scriptural declarations of those things which are most surely believed among us as shall be for the practical help and edification of all our menibers and for testimony to the world of the faith which was once for all delivered to the saints."

An Insanity Expert's Suicide. JACKSONVILLE, Ills., Nov. 25.-Dr. Andrew McFarland, an insanity expert and proprietor of a private insane retreat at Oakland, killed himself by hanging. He was undoubtedly deranged. Dr. McFarland was a native of Concord, N. H. He was superintendent of the New Hamp-shire asylum in 1845 and superintendent of the Central Illinois asylum from 1854 until 1870.

Flames in Minneapolis. MINNEAPOLIS, Nov. 25.—The North Star Boot an: Shoe company building caught fire from some unknown cause at 10 o'clock last night and was totally destroyed. The loss on building is \$100,000; on stock, \$300,-000. Six men in the building at the time barely escaped. The losses are nearly covered by insurance.

Chase Succeeds Hovey, INDIANAPOLIS, Nov. 25 .- The death of Governor Hovey brings into the office of chief executive of Indiana Lieutenant Governor Ira Chase, of Danville. He was notified by telegraph of the governor's death. In response, he came to the city, and the oath of office was administered.

Injured by a Powder Explosion. Belle Plaine, Ia., Nov. 25.—Several persons were seriously injured by an explosion of powder which occurred during a fire. Hanson's jewelry store, Dodd's harness shop and other stores were destroyed by the flames. The loss will be heavy.

BRIEF MENTION.

The worst occurrence during the storm taken out of the ruins alive and the dead bodies of two men were recovered. A portion of the stone balustrade of the White House was blown down, partially demolishing the porticos over the main entrance A gas tank was struck by lightning and exploded. The storm visited Baltimore and did much damage. Many other towns felt the force of the gale and the damage will be considerable. Great damage was done in Cumberland county, Pa. Graham's school house, near Carlisle, was demolished, and the teacher, Miss Bertha Rudy, had a leg broken. A number of scholars were in-jured. The Sunnyside school house, near Carlisle, was wrecked and a dozen scholars were hurt. The new Methodist church in the course of construction at Reading was damaged to the extent of \$1,000. At Harrisburg Arthur Crook, a workman, was blown from the trestle at Lochiel furnace. His wrists were dislocated. Howard D. Carbaugh was killed at Hanover. At York the roof of St. Paul's church was damaged and a number of small buildings were unroofed. Considerable damage was done in the county. In Lancaster county the Baptist church at Monterey was com-

pletely wrecked. A number of barns were badly damaged. Commodore Farquhar, chief of the bureau of yards and docks, in his annual re-port says that a large sum of money is badly needed to keep the navy yards in re-pair and to build new dry docks.

Lieutenant Governor Jones visited Governor Hill at the executive mansion in Albany. The meeting was very cool. General Jones asked the governor what he intended to do, and Hill, with a sort of none-of-your-business manner, replied, "I'm going to remain my term out." General Lones was not in the Jones was not in the executive chamber more than two minutes.

Calvin M. Dechant, superintendent of the Mount Penn (Pa.) Gravity railroad, was arrested at Reading, on the charge of manslaughter. The arrest was made by direction of the district attorney and the coroner's jury, which charged him guilty of criminal negligence in connection with the recent accident.

The Right Hon. William L. Jackson, the newly appointed chief secretary for Ireland, was re-elected as member of parliament for North Leeds, without oppo-sition. Mr. Jackson's appointment as the Right Hon. A. J. Balfour's successor necessitated his re-election to the seat he repsion. resents.

There is now no doubt that the strike of the coal miners in the department of Pas de Calais, France, is a general one. Of the 40,000 or more miners in the coal fields of that department there are only about 100 at work. Meetings were dispersed by the troops, but no conflict has occurred.

THE FLOUR CITY'S PRIZE

Minneapolis Captured the Convention with Hardly a Struggle.

LED FROM START TO FINISH


June 7 Next Named as the Day the Convention Will Meet-Clarkson Succeeds Quay, Hobart Succeeds Clarkson and Barbour Succeeds Dudley.

WASHINGTON, Nov. 25.—Minneapolis has won the prize hands down, and the Republican national convention will meet in that hustling city of the great northwest

on the 7th day of June next.

After the national committee in executive session had elected James S. Clark-son of Iowa to succeed Senator Quay as chairman, G. A. Hobart of New Jersey to succeed Clarkson as vice chairman, William Barbour of New York to succeed W. W. Dudley as treasurer and voted to admit Dennis T. Flynn as the delegate from Oklahoma, the delegations of the various states were called in alphabetical order, California leading, and the oratorical combardment let loose. Each delegation was allowed an hour in which to show cause why the city it advocated was best entitled to the convention.

The Balloting. When all had finished, the balloting commenced, and Minneapolis at once took the lead with 13 votes, which it increased



votes which dwindled to 3 on the seventh ballot. Omaha started with 5 votes, went down to 3 and back to 4 on the seventh ballot. Pittsburg, with 2, 1; Chattanooga, with 4, 4, and Detroit with 1, 1, all dropped out after the second ballot. St. Louis got one lone vote on the first

hallot and no more. The large vote given Minneapolis on the last ballot was the result of a combination arranged by Mr. De Young, of California, to prevent the convention going east of the Mississippi river. Mr. De Young saw, while the sixth ballot was in progress, that San Francisco's chances were hopeless, and he quietly went around among the supporters of that city and of Omaha and asked them to give their votes to Min-

Just before the decisive ballot was taken Mr. De Young announced the withdrawal of San Francisco, and the supporters of Omaha and of that city cast their ballots for Minneapolis, which also secured an unexpected addition of two votes from New York's support, thus giving it the convention by a majority of 5. Appreciation of Mr. De Young's action was manifested by an informal vote of thanks to him by the Minneapolis delegation.

Hilarious Minnesotans. Pandemonium reigned when the final result was announced. The Minneapolis headquarters being next the entrance to the committee room, the news of the success was transmitted instantaneously to to the crowd gathered there. A great shout went up and hats flew in the air. Senator Washburne was hoisted upon a chair in the center of the room and called upon to speak. His remarks were well nigh unintelligible, owing to the inability of his enthusiastic friends to curb the vociferous expression of their triumph. But such of them as could be heard were in good taste and, after modestly felicitating the dele at Washington was the blowing down of the walls of the new Metzerott music hall in course of construction on Twelfth street, of the vanquished cities in turn, which N. W., just below F street. Two girls were were given with a will. Chief Clerk Johnson and other Minneapolis men took turns in addressing the crowd, their speeches be ing interspersed with songs. The merry making was kept up until a late hour.

Satisfied with the Selection. Now that the strain is over, the battle fought and the victory gathered in, the nation has an opportunity to reflect that the struggle here to secure the big Republican convention of June 7 next was a most extraordinary one. It was such a contest as no other country in the world could very well witness, even if all other countries were blessed with such institu tions as national conventions.

Most of the delegates who appeared before the national committee to urge the claims of some city or other for the convention honors have gone home. Among those who remain, even if they chance to be experiencing something of the chagrin of defeat, there is yet a disposition to regard the choice finally made as neither an

unpleasant nor an unwise one.

While the victory is generally spoken of as belonging to Minneapolis, the co-operation of St. Paul was a big factor in the fight for that town. Those who speak of the outcome as a Twin Cities' triumph are very much in the right of it.

Workingmen Ask Recognition. Before the national committee adjourned a committee headed by Mr. William Carsey, representing the labor organizations of New York, was admitted to the room. Mr. Carsey, Mr. John W. Keough and P. C. McGuire in short speeches asked the committee to broaden the call for the convention so as to invite the assistance and co-operation of the

workingmen and the farmers.

They declared that this class of the population believed in protection, public im-provements, national aid to education, an honest ballot and a fair count. These were Republican principles, and with them they asked the committee to insert in the call some suggestions calculated to relieve the evils from which the workingmen and farmers suffered.

After the committee had heard the rep resentatives of the labor organizations, it spent some time in discussing the draft of the call to be issued for the next convention. It was not completed, however, but was referred with instruction to the executive committee, which will draw it up in accordance with the suggestions made and the views expressed during the discus-

THE NEW YORK LEGISLATURE.

Assemblyman Murphy Dead-A Recount in Sullivan—Osborna Declared Elected. ALBANY, Nov. 25.—Assemblyman William E. Murphy, of the Third assembly district, died at his residence in this city, He was a Democrat, and while his death may affect the selection of a speaker of the house, it will not change the numerical strength of the parties after the election of his successor. The district is so strongly Democratic there is no chance of a Republican succeeding him.

Judge Fursman has grantled the appli-

tation for a mandamus compelling a re-tount of the vote in the Beakes case in Sullivan county. The application was made by Mr. Beakes, the Democratic canlidate for assemblyman, whom it was claimed was defeated by a majority of one by Kenrick, the Republican candidate.

Judge Fursman granted a stay of ten
days on his order in which appeal can be made.

The decision of the board of canvassers of Dutchess county, by which Deane (Rep.) gets 8,278 votes for senator, and Osborne (Dem.) 8,462, increases Osborne's vote by ninety-two, gives him a majority of 184 in this county and a plurality of fourteen in the senate district.

This decision was arrived at by adding to Osborne's vote seven in the Dover district, transposing the votes for Osborne and Deane in the Second Fishkill district, which had been wrongfully counted for Deane, by taking forty-nine ballots from Deane in Redhook and East Fishkill.

County Clerk Hoffman (Rep.) refused to sign, whereupon John J. Mylord (Dem.) was elected by a party vote to serve as clerk of the board. This will result in giving the Democrats another vote in the senate and tying that body, even if Edwards, the Independent Republican, goes to the Republicans.

An Archbishop on Trial.

PARIS, Nov. 25.—There has been commenced before the first chamber of the court of appeals in this city one of the most remarkable and important trials in the history of French law. Before that summons citing him to answer the charge of having insulted and questioned the authority of the minister of public worship, M. Fallieres. Thus begins a battle royal in the courts and out of them between the French government on one side and the princes of the Roman Catholic church in France on the other side.

BERLIN, Nov. 25 .- M. de Giers, the Russian minister of foreign affairs, had a conference with the Emperor William which lasted twenty minutes. M. de Giers was afterward entertained at breakfast by Chancellor von Caprivi. The Russian papers, in commenting on M. de Giers' visit to Berlin, have adopted a conciliatory tone and state that it is hoped the visit of Germany.

Bogs in Arctic Regions.

The most valuable domestic animal in Kamtschatka is the dog. During winter they are fed with dried fish every morning and evening, but while traveling they get nothing to eat, even though they run for hours. Their strength is wonderful. Generally no more than five of them are harnessed to a sledge, and will drag with ease three full-grown persons and sixty pounds of luggage. When lightly laden, such a sledge will travel from thirty to forty miles in a day over bad roads and through the deep snow; on even roads, from eighty to one hundred and forty.

During a snowstorm the dogs keep their master warm, and will lie quietly near him for hours, so that he has merely to prevent the snow from covering him too deeply and suffocating him. The dogs, are also excellent weather prophets, for when, while resting, they dig holes in the snow, a storm may with certainty be expected.

The sledge-dogs are trained to their future service at a very early period. Soon after birth they are placed with their mother in a deep pit, so as to see neither man nor beast, and after having been weaned they are again con-demned to solitary confinement in a pit. After six months they are attached to a sledge with other older dogs, and being extremely shy, they run as fast as they can. On returning home they are again confined in their pit, where they remain until they are perfectly trained and able to perform a long journey. 
