Our Town Records.

Mr. Pond, the Milford historian and writer, who has frequent occasion to search the town records of different localities in Connecticut, in furtherance of his historical and biographical literary labors, particularly in matters relating to the colonial and revolutionary war periods, has expressed his surprise to a GAZETTE scribe that this town, so rich in such material, has its older town records in such a deploradition. He says we are far behind other towns about us. In Stamford, Fairfield, Stratford, Milford and other towns. the utmost pains have been taken to preserve these invaluable records of the early settlement and subsequent transfers of property in the respective towns. He says no town in Connecticut is more rich in such early records than Norwalk, but that they are in such a loose and scattered condition as surely to be lost to the future if some action be not taken for their preservation. Selectman Daskam's attention being called to Mr. Pond's criticism, admitted its truth and said it was only the cost of the work that these ancient documents had not been more enduringly arranged, indexed and cared for. It is a work that certainly ought to be done.

The Grand Jury, which has spent nearly a month in investigating the expenditure made by the city and county authorities on the celebration, has declared that all such expenditures were illegal, that the bills themselves were extravagant, that suits could be brought against the Mayor and municipal authorities, as well as the county authorities, for the recovery of the money, and has also found indictments against the contractors who rendered the bills, the city and county Auditors who audited them, some of the Aldermen who managed the city side of the show, and the Supervisors who voted to pay the bills after the Super-

visor-at-Large vetoed them.

The Corporation Counsel is requested to bring civil suits against Mayor Boody, ex-Controller Jackson and the Aldermen of the city for illegally spending the city's money. The expenditures of the Aldermen and Supervisors are declared to be in defiance of the law.

Twenty-three indictments were handed up with the presentment, several of them containing more than one name. All information as to the persons named therein was refused by Judge Moore and by the District Attorney. At the latter's office reporters were informed that sufficient time had not been given for preparing bail bonds, and that the indicted officials would not appear in court until today, when they will give bail.

A HIGH-PRICED KISS.

Elsie Knoblock Given the Biggest Damage Verdict for a Poughkeepsie Smack.

Poughkeepsie, N. Y., Jan. 7.-Elsie Knoblock is a bright, blue-eyed, handsome German girl recently employed as a domestic in the family of A. C. The husband brooded over the matter and finally Elsie brought suit against Harris for damages and the case was tried yesterday, all the parties appearing before Judge Barnard. Foreigners Have an Open Sesame to the Country.

THE SENATE HAS DECLINED TO DO ANYTHING.

Sweeping Charges Made by Senator Chandler.

WASHINGTON, Jan. 7.-The prediction of Senator Dubois that there would be no legislation during the remainder of this session affecting immigration, and that the bill upon the subject finally adopted would simply authorize the President to suspend immigration at his discretion, was partly verified by the debate in the Senate yesterday.

by the various Senators would seem to indicate that it would be almost impossible for them to agree on any measure radically affecting immigration. Every Senator who spoke had either some favorite remedy of his own, or, like Mr. Mills, was entirely opposed to any legislation on the subject.

The subject first came up in the Senate yesterday when Senator Hill's resolution was adopted, with some few verbal amendments, requesting the State Department to inform the Senate whether any of the proposed immigration measures now before the Senate interfered with existing treaty stipulations. Senator Hill has on frequent occasions shown his opposition to any effective suspension of immigration, and the purpose of his resolution is believed to be his knowledge that no sweeping immigration law, such as those now proposed and before Congress, can be passed without violating the treaties with a number of European nations.

In the course of his remarks, Mr. Chandler, who favors the total suspension of immigration for one year, caused some sensation by declaring, in effect, that the North German Lloyd Steamship Company had, by the distribution of courtesies, acquired such influence over his fellow Senators, over the Secretary of the Treasury and his chief subordinates, and over the newspaper press in general, as to make legislation restricting immigration only possible by the consent of that com-

pany.
Mr. Chandler boldly stated that this particular company is the favorite of the Treasury Department, and that this company furnished leading Treasury officials with transportation to Europe every Summer and had furnished certain officials financial advances upon which no

interest was paid. Mr. Chandler also described a dinner in New York harbor recently given to Washington and other representatives of the press, and intimated that these courtesies extended by railroad and steamship companies were designed for indirect effect upon public opinion through the newspapers. He commented sarcastically upon the fact that at a previous dinner given by the same company the guests included Col. Weber, the Commissioner of Immigration, while at this latest dinner a conspicuous guest was Gen. Spaulding, the Assistant Secretary of the Trausury, who is the direct superior officer of the Commissioner of Immigration.

New York Electors' Meeting.

ALBANY, N. Y., Jan. 7 .- Monday, January 9, the Cleveland and Stevenson electors of the State of New York will assemble in the Senate Chamber at the Capitol and be called to order by Secretary of State Rice, and when it has been duly ascertained by the Secretary of State that the 36 electors receiving the highest number of votes are present, and have qualified by taking the oath prescribed by the Constitution and law of the State, then the electors will elect a president, two secretaries from among their number and probably adjourn till 10 o'clock on Tuesday.

The Reading Coal Combine. WASHINGTON, Jan. 7. - The special Reading Investigating Committee of the House has concluded its investigation. and the Chairman, Mr. Coombs, expects to make a report to the House within a few weeks. The members have not yet consulted together as to the nature of their report, but at least a part of them believe that it is possible for Congress, within its constitutional province, to enact legislation that will be effectual in restraining the coal combination.



De Lesseps is Said to Have Turned State's Evidence.

ANOTHER PROSECUTION LIKELY TO BE MADE.

A Letter Explaining M. Floquet's Big Check.

PARIS, Jan. 7.—It is reported that the determination of the Government to prosecute rigorously M. Baihut, Minister of Public Work in the De Freycinet Cabinet for the Panama frauds, is due to an understanding reached between the authorities and M. Charles de Lesseps, whereby the latter, in consideration of giving all the information in his power in relation to the beneficiaries of Panama corruption, is to be treated with great leniency, if not admitted to absolute immunity He is said to have made an unreserved statement of the facts within his knowledge, and will repeat the same on his own trial and at trials of others connected with the scandal. His motives are stated to be, not only to secure immunity, but to convince the public that the Panama Company was forced by irresistible pres sure on the part of officials and the press to choose between wholesale corruption and the threatened ruin of the enterprise. It is said that the acknowledgments were made by him, and will create a sensation in America as well as in France.

The charges against M. Baihut have aroused great interest. As Minister, M. Baihut had an important influence upon the course of the Government in regard to the Panama Canal Company, and the charge is substantially that he so d that influence. The Figaro says that M. Franqueville, the juge d'instruction, has decided that the evidence against M. Ba nut, presented during the examination in regard to the check for 500,000 francs alleged to have been paid to him, warrants putting him on trial. It is reported that the proof against him, as well as against other mportant personages whom the Government is prosecuting or preparing to prosecute, results from Charles de Lesseps's confession. M. Tiburce Franqueville, who is conducting the examination, is a native of Picardy, and is 40 years old. He has been attached to the Tribunal of the Seine for about six years. Following is the text of the letter from M. Algoin to the Committee of Inquiry, relating to the check of 20,000 francs, alleged to have been received by M. Flo-

"Yesterday a lying document, which has given birth to an abominable calumny, was laid before you. I had already brought to you, when you for the first time did me the honor to listen to me, the complete account of the work done by me and for which the 2000. me, the complete account of the work done by me, and for which the 20,000 francs sent me by Baron de Reinach was the remuneration. I had a right to regard that question as settled, and now people dare to say that, on that occasion, I only lent my name, and that the person who really received the money was a political. really received the money was a politician whose high probity is beyond question. I oppose the most categorical contradiction to that allegation which nothing can justify. You, gentlemen of the committee, lave seen the counterfoil of the check; you know my name alone appears on it. You are therefore in possession of a proof of the truth of my words, and I defy any one, whoever he may be to produce a convincing document capable of contradicting me."

The Count of Paris, it is expected, will be joined soon by the Countess, and the rest of the family, and a gathering of the Orleanist Princes and their principal counsellors will take place at the San Telmo Palace. The Spanish Government is watching the Count and his adherents, and it is understood that Senor Sagasta will not allow any demonstration on Spanish territory, especially for the reathat the Madrid Government is about to

Creditors not preferred will be paid? shillings 6 pence, plus four per cent, interest will be paid out of Mrs. Parnell's annual income, which, it was announced, amounted to £800.

One confiding Canadian recently invested \$.00 in a green goods venture and was delighted at the bulk of the package he received.
