Presidential Electors.

Presidental electors met at the capitals of all the States yesterday and cast their votes for President and vice President. The majority of Grover Cleveland over all, was 108. The New York electors at Albany spat in the face of the President-elect, by passing a resolution endorsing Murphy for Senator, despite the protest of Mr. Cleveland. So Tammany rules throughout.

At Hartford Judge George G. Mc-Nall of Greenwich was appointed messenger to carry the certificate of election to Washington.

Congress will meet in joint session, Feb. 8th to count the Electoral votes and to officially promulgate the result.

Towns and the State.

The Hartford Post does a genuine public service in culling out from the recent inaugural address of Governor Russell of Massachusetts the arguments in which that democratic advocate defends the rights and sovereignties of the towns, and points out their just and his-

on the right of home rule." He quotes the decisions of supreme courts and the utterances of accepted leaders in statecraft and government to demonstrate the importance of this town autonomy. He declares that, until recent years, it was "universally recognized and rescreeted, and received the commendation of statesmen, historians and thinkers." He refers to Jefferson's declaration that the town system was 'the wisest invention ever devised by the wit of man for the perfect exercise of self government and for its preservation. He quotes also such foreign students of our system as De Tocqueville and Professor Byrce, the latter of whom describes the New England towns as being "to this day the true units of political life in New England, the solid foundation of that well compacted structure of self government which European philosophers have ad. mired, and the new states of the west have sought to reproduce."

On the grounds of public welfare, of party policy, of patriotic and conservative statesmanship, Governor Russell pleads and argues against anv abridgment of the equal sovereignties and equal rights and equal powers of the Massachusetts towns.

In this state, on partisan grounds, says the Norwich Bulletin, Governor Morris pleads and argues for a discrimination between the towns, the politi-

cal units of state life. The two governors are squarely opposed to each other in their attitude towards the towns.

The answer is very simple:-because in Massachusetts party advantage seems to lie, for the moment, in defending the towns, while in Connecticut party advantage seems to lie, for the moment, in recasting the towns.

Now we will leave it to any thoughtful man if a system of government, honored with the acceptance of a community's whole existence, tried and proven worthy by the test of a phenomenally successful experience, the object of admiration to all outside observers and the example towards imitation of which the whole race tends as human liberties broaden,-if such a system of government should be made the football of partisanship, to be tossed hither and yon, kicked across the field or out of it, according to the shifting calls of changing party whims?

Election time has past, for this year. The stress and fury of party combat can well be laid aside, now, and thinking men can afford to discuss such a matter without regard to party bias or party benefit.

What is best for the state. - best this year and next year and for the hundred years to come?-that is the question which sober-minded and thought ful citizens are to consider :- not what is best for this, that or the other party this year or next election.

Obituary.

GARDINER SPRING HUTCHINSON. Gardiner Spring Hutchinson, a well-

known and popular merchant of New York city, died yesterday at his home in Englewood, N. J. Mr. Hutchinson was born in New York sixty-one years ago. His father was one of the original drygoods commission merchants of that city, and since 1867 Mr. Hutchinson has been in a branch of that business. He was at the time of his death senior partner of the firm of Hutchinson, Pierce & Co., at No. 434 Broadway. Mr. Hutchinson was a lawyer by profession. He was a graduate of the Harvara Law School. After leaving the law school he became a member of the law firm of Chapman, Scott & Crowell, in Wall street. In 1867 Mr. Hutchinson gave up the profession of law and became a member of the firm of Morison & Son & Hutchinson, which later became Morison & Hutchinson, and is now Hutchinson, Pierce & Co. For several years he was president of the New York Dime Savings Bank, and a director of our Central National Bank here in Norwalk. He married a sister of the late Thomas H. Morison, and at the time of his death, was senior partner of the Star Shirt Co, of Bridge-port. He has been in the shirt manufacturing business some thirty years and was at the head of the Morison & Hutchinson house in San Francisco some twenty-five years ago. When the editor of the GAZETTE, with his family, visited the Pacific coast on the first opening of the through Pacific railroads; Mr. H. was most assiduous in his efforts to make the visit both pleasant and profitable. He was a man of most genial manners and engaging friendliness. His wife, two sons and a daughter survive him.

THE ELECTORS HAVE VOTED

They Assembled at all the State Capitals Yesterday.

THE VOTES OF FOUR STATES ARE DIVIDED.

Some Contests Likely--The Facts and Figures.

WASHINGTON, Jan. 10. - The electors chosen to carry out the will of the people, expressed at the polls last November, met in the capitals of various States at noon yesterday. After casting their votes they signed three certificates of the result. One of these was delivered to an elector appointed to take charge of it and carry it in person to the seat of Government and deliver it to the President of the Senate. The second certificate was sent by mail to the same destination, and the third is to be delivered to the United States District Judge for the district in

which the electors meet.
So far 30 of the States have complied with the law requiring the result of the vote to be filed with the Senate, although the election was held two months ago. Congress is required to be in joint session to count the electoral vote at 1 o'clock on the second Wednesday in February after the meeting of the electors. This will be February 6. It is possible that objections may be raised to some of the votes from California, Kansas, Michigan, Ohio ahd Oregon, and in this event the law provides that the two Houses shall separate, consider the objections and report their findings. The count cannot proceed until each objection has been disposed of. The announcement of the vote is by law & sufficient and constitutional declaration of the election of the candidates.

The total number of votes was 444; necessary for choice, 223. Cleveland had 277, Harrison 145 and Weaver 22.

Mr. Cleveland's plurality over President Harrison is 132, and his majority over all 108. The distribution of the electoral vote is approximately as follows: Mr. Cleveland, 62.2 per cent.; President Harrison, 32.4 per cent., and Gen. Weaver,

5.4 per cent.

The electoral votes of four States are divided. President Harrison received 22 of the 23 votes of Ohio, the other being cast for Mr. Cleveland. Of the 14 votes of Michigan President Harrison received nine and Mr. Cleveland five. In California President Harrison got one vote and Mr. Cleveland eight, while three of Oregon's four votes were given to Presi-

CONGRESS YESTERDAY. Silver Was a Topic in Both Senate and House.

MANY PROPOSITIONS BUT NO SETTLEMENT MADE.

Quarantine Bill Left Over--Doings of the House.

WASHINGTON, Jan. 10.—The Senate was in session yesterday for over five hours. Half of the time was spent on Mr. Mc-Pherson's (Dem., N. J.) joint resolution authorizing and directing the Secretary of the Treasury to suspend all purchases of silver under the Sherman act, and the other half on the bill granting additional quarantine powers and imposing additional duties upon the Marine Hospital

Mr. McPherson addressed the Senate at length in support of his joint resolution; and when he resumed his seat Mr. Aldrich (Rep., R. I.) gave notice of a substitute which he proposed to offer to it, and he asked unanimous consent—in order to test the sincerity of the Democratic side of the chamber, which he accused of "masqu rading"—to have a vote taken on the substitute and the original measure

today.
Objection came from Mr. Daniel (Dem. Va.), and the matter went over indefinitely and without any agreement.

Mr. Aldrich's substitute proposed to authorize the issue of bonds to procure gold if necessary to maintain the parity between gold and silver coins and United States Treasury notes; and also provided for the suspension of the purpose of silver bullion on January 1, 1894, if before that time there be not an international agreement reached by which gold and silver shall be given equal mintage rights at an

The Quarantine bill was discussed, but went over till today as did also the Mc-Garrahan bill.

In the House the District of Columbia Appropriation bill was passed; the bill to allow the Norfolk and Western Railroad to enter the District of Columbia was discussed; a favorable report was received on the Andrews bill to repeal the Sherman law; the Stewart Free Coinage bill was voted down; a bill to repeal the State bank tax was favored and will be

NEW JERSEY'S RULERS.

The Senators and Representatives Will Assemble Today.

TRENTON, N. J., Jan. 10 .- The Legislative session will open at 3 o'clock this afternoon. Robert S. Adrian will again be made President of the Senate. This much has been efinitely fixed. "Tom" Flynn, who recently resigned his position as starter at the Gloucester races will in all probability be made Speaker of the House. Adrian's selection as President of the Senate is an indication of the coming success of James Smith, Jr., in the struggle between that gentleman and Gov. Abbett for United States S nator.

Adrian was backed by Miles Ross and Nelson Pidcock, the Governor's foes and Smith's friends. The probable election of Flynn as Speaker of the House has no such significance. His elevation to the Speaker's chair is the personal work and triumph of "Billy" Thompson, the "Duke of Gloucester." Neither Abbett nor Smith cared to cross the "Duke," who is credited with the control of eight votes besides his own in the United States Senator or any question that may come before the Legislature.

Sulzer's Committees Suit Democrats.

ALBANY, N. Y., Jan. 10.—Speaker Sulzer announced the Assembly committees last evening. Owing to the decreased number of Republicans the Speaker was able to give general satisfaction to the old Democratic members. The appointments are well received by the Assemblymen. They are especially commended by the New York and Brooklyn Democrats, who are a majority of the Democrats of the Assembly and who get the best appointments.

Electors' Helpers Disappointed. HARRISBURG, Pa., Jan. 10.—The clerks, sergeant-at-arms, doorkeepers and messengers, including several newspapermen, who helped the electors of Pennsylvania perform their arduous duties are not happy. They would have been paid from \$10 to \$50 each for their services, as has been done on similar occasions since 1856, if some reformer had not discovered that the act of 1839 does not justify such munificent compensation.

Their Choices Were Unanimous. HARRISBURG, Pa., Jan. 10.-A meeting of the chairmen of the Democratic committees of the counties of Dauphin, Adams, Cumberland, Franklin, York, Juniata, M. fflin, Perry and Lebanon was held at the Bolton House. The object of the meeting was to elect a division chairman. R. E. Shearer of Cumberland county, was unanimously elected chairman and W. W. Trout of Mifflin, secretary and treasurer.

Assurance if Not Assurances. JEFFERSON CITY, Mo., Jan. 10.—Senator Francis M. Cockrell has assurances that Cleveland will select him for Cabinet honors. Cockrell's successor in this event is likely to be Major Harvey W. Salmon, Chairman of the State Democratic Campaign Committee, who conducted the Stone Campaign, and insured an old-time vote for his party in Missouri.

Senator Hirst in the Field.

ST. PAUL, Jan. 10 .- Senator Hirst now comes into the North Dakota Senatorial fight as a dark horse, and it is said will defeat both Casey and Ordway. It is said that Congressman Johnson will support Hirst, which renders his election certain.







Prominent Frenchmen Are to Be Arraigned Today.

THE AUTHORITIES MOVED TO STERNER MEASURES.

M. Baihut Arrested -- Names of the Accused.

PARIS, Jan. 10 .- M. Baihaut, ex-Minister of Public Works, was put under arrest yesterday after a long interview with Magistrate Franqueville. Baihaut has heretofore been allowed to go about under surveillance. The authorities are said to have been moved to sterner measures by the reports coupling President Carnot's name with that of M. Baihaut, the arrest being intended to prove that the government is not afraid to take action against any one.

The attem t to involve President Carnot in the Panama accusations causes much excitement. So far as made apparent there is not the slightest evidence of corrupt complicity on his part, the utmost alleged in any definite way being that he may have perfunctoriy and ministerially given official sanction to a who were corrupt.

The enemies of the republic from the first have been endeavoring to involve M.

Carnot, believing that by bringing about a Presidential crisis they would strike a fatal blow at the republic. Besides there are several candidates for the Presidency in the field who would be delighted to see M. Carnot forced to resign.

M. Clemenceau, at his own request, was examined by Magistrate Franqueville yesterday in relation to his knowledge of Panama canal matters. The examination lasted a long time. No details have been given the public.

The new Procureur General M. Tanon,

has summoned 31 witnesses for the trial, which begins today. The persons who will be put on trial are M. Charles de Lesseps, director of the Panama Canal Comgeneral of the Company; M. Cottu of the firm of Reinach, Kohn & Co., and M. Gustave Eiffel, the distinguished engineer. Charles de Lesseps has caused three English directors of the Suez Canal Company to besummoned as witnesses in his be-

The indictment against the accused charges De Lesseps, Fontane and Cottu with having employed fraudulent means to persuade people to believe in the existence of fallacious enterprises and imaginary influence or credit, thus causing divers persons to make subscriptions that would not otherwise have been given for an issue of Panama Canal bonds made on June 26, 1888, the defendants by the fraudulent means thus alleged cheating and defrauding others out of all or part of their noney thus subscribed.

The second section of the indictment relates to the Panama Canal loan of De-cember 12, 1888. The accused are charged with having tried to obtain subscriptions to this loan on false pretences, their at-tempted swindling being only frustrated by circumstances independent of their in-tention.

It is also a leged that the accused had misappropriated or expended, with a view of prejudice, the interests of the bondholders, effects and money given into their charge as trust depos ts for specific purposes.

M. Gustave Eiffel is indicted as an ac-

complice in the alleged swindling opera-tions, and is accused of having wilfully and knowingly received a share of the sums of money unlawfully procured from profits of the fraud. He is also accused of having misappropriated funds in-trusted to him for the mandatory purpose of expenditure for salaried labor. Nothing is said in this indictment as to

the bribery or corruption of public officials.

DESPERATE MINERS.

A Resort to Dynamite Bombs to Help Foment a Strike.

BERLIN, Jan. 10.-A dynamite bomb was exploded in Gelsenkirchen vesterday. Two small hotels which stand on either side of the alley in which the bomb was placed were shaken so that the windows broke and plaster fell from the walls, Although several persons were passing in the street hardly 20 yards away, nobody was injured. The man who placed the bomb has not been caught. He is supposed to be an Anarchist em ssary from the Saar district, who has gone to the mining region around Gelsenkirchen for the purpose of fomenting a strike there in sympathy with the movement on the

GREAT STIR IN VIENNA.

A Story that Brigands Had Captured the Empress.

VIENNA, Jan. 10 .- An enormous sensation has been caused by the report that Spanish brigands have captured the Empress Elizabeth of Austria, and propose to hold the imperial lady for ransom. The Government professes to know nothing about any such rumor, and nothing seems to be known on the subject at Madrid. When last heard of the Empress was yachting near the Balearic islands.

The Shereef of Wazan's White Wife. TANGIER, Jan. 10.—The widow of the Shereef of Wazan, who died a few months ago, has been notified that she will not be allowed to succeed to the property left to her by the Shereef unless she becomes a Mohammedan. She refuses to change her religious belief, and interesting complications are looked for. She is an English

woman. Four Men Lost at Sea

London, Jan. 10. - The British bark Navarch was abandoned at sea while on a voyage from Philadelphia for Dunkirk. Part of her crew, who were taken off by a passing vessel, have arrived at Havre. Capt. Hitton, master of the Navarch, died at sea. The first officer of the bark and two seamen were lost overboard.

Mr. Gladstone Starts for London. PARIS, Jan. 10 .- Mr. Gladstone left Biarritz for London yesterday. A crowd of visitors and residents accompanied him to the station and cheered him as the train moved off. Mr. Gladstone looked exceptionally well.


