It is now published for the first time and solely for the purpose of showing that "touch of nature" in Mr. Blaine's character, that not only "made the whole world kin" to him, but made all the world coming into touch with him, love him as a brother. The text of the letter is as follows, and touches upon one of the severest sorrows and sorest bereavements of our life, the death of a gifted and beloved son, and former editor and proprietor of this paper:

AUGUSTA, MAINE, Jan. 20, 1887.
My DEAR BYINGTON:—I have this moment heard of your sad affliction. I know how great your grief must be and I beg you will receive my deepest sympathy for yourself and your wife.

May God give you both the courage and the grace to lessen your burden of Ever sincerely, JAMES G. BLAINE. sorrow.

No Evasion! No False Pretences

Under the above caption the intensely democratic New York Sun, in a double loaded editorial, yesterday, urges its party to stand squarely and honestly up to its ante-election declarations and professions in regard to the tariff, in the following strong lan-

"We notice in various quarters the indications, more or less distinct, of a disposition among certain schools of of Democrats to emasculate and nullify the Chicago platform of 1892 respecting the tariff.

That platform is a model of clear, decided, unequivocal statement. It expresses most plainly and forcibly the intellectual ground on which the advocates of the free trade doctrine must rest their case. "We declare it to be a fundamental principle of the Democratic party," says the platform, "that the Federal Government has no constitutional power to impose and collect tariff duties, except for the purpose of revenue only." This is the doctrine proclaimed by the party and established by the voting of November, when Mr. Cleveland and the new Democratic Congress were elected by large and unexpected majorities; and it

is a doctrine from which there should

now be no retreat and no variation. Yet in some spheres of political activity, high and low, we see the signs of a purpose to vary and depart from this advanced doctrine; and we make haste to say that any such course on the part of the Democratic party, or of its chosen representatives, will not only be unworthy of them and insulting to the people who have given them these great majorities, but will certainly be productive of political disaster, if not of party overthrow. We say this all the more earnestly because the doctrine in question is not ours, and has never been the doctrine of those Democratic statesmen, such as Andrew Jackson, Thomas Jefferson, and Samuel J. Randall, to whom we have been accustomed to look for instruetion in regard to the principles of public policy. In the recent election all our appeals for support to the Democratic cause grew out of considerations having no relation to the tariff; but when the people in a national election approve a party platform by such vast majorities, we are bound to maintain that they mean the whole of it and not any specific section only. It is true, the subject which seemed of the most vital moment, the controversy respecting the Force bill, was then disposed of forever: but we maintain also that the question of the tariff, second in importance only to the Force bill, was

DIED GOING TO JAIL.

Fisher Took Poison When He Heard That His Wife Had Caused His Arrest

NEW YORK, Feb. 2.-Joseph Fisher, a painter, 52 years old, of 211 West Sixtvseventh street, died yesterday afternoon while being taken to the Yorkville Police Court by Policeman Smith. In the dead man's pocket was found a bottle, which is supposed to have contained a mixture of oxalic acid and whiskey.

For some time Fisher has been drink-

ing heavily. He abused his wife and family, and yesterday morning Mrs. Fisher obtained a warrant for her husband's arrest. Policeman Smith called at Fisher's house vesterday afternoon. Fisher made an excuse to go into a closet, then he accompanied the policemen willingly. The two boarded a cross-town car and when the car reached the corner of Eighth avenue Smith noticed that his prisoner was deathly pale, and was unable to sit up in his seat. He called an ambulance, but when it arrived the man was dead.

Fish Propagation.

The fish commissioners have made their second biennial report, covering the two years ending Sept. 30, 1892. It shows the distribution of over 800,000 trout fry in the state. The demand is increasing and a half a million or more will be distributed in 1893 if an addition of \$1,500 to the appropriation can be made.

The commission notes a decrease in the shad catch in Connecticut, but has the snad catch in Connecticity, but has arrived at no satisfactory conclusion as to the cause. They recommend plant-ing the fry in ponds instead of large streams. These retaining ponds would be clear of all other fish and the fry would have a splendid chance to thrive and grow; besides, a very much larger percentage of them would reach maturity; as it is now, planting them directly in the large streams many of them are killed and more are eaten up

by other and larger fish.

Very few salmon have been caught in the time covered by the report.

CONFIRMED BY SENATE.

Prof. Baldwin's Nomination to Go Back to the House for Concurrence.

HARTFORD, Feb. 2.—The nominations by Gov. Morris of Judge Fenn and Prof. Baldwin of New Haven for the Supreme Bench came up at 1 o'clock yesterday in the Senate. The House had adjourned, and the Senate chamber was crowded. Judge Fenn was confirmed by ballot by a of 18 to 3. Senator Fox (Dem.) of New Haven then spoke in favor of the confirmation of Prof. Baldwin. He culogized the character and ability of Prof. Baldwin, and said the action of the House last week in rejecting him had been condemned by the press and the people. He said that Prof. Baldwin was master of probate, criminal, civil and corporation

Senator Cleveland (Dem.) of Hartford followed in a speech in support of Prof. Baldwin, which he said afforded him greater honor than any other legislative act of his life. Senator Root (Dem.) of Waterbury also spoke in favor of confirmation, as did Senator Crandall (Dem.) of Norwich, Senator Pierce (Dem.) of Bristol and Senator Holden (Dem.) of Ansonia. There were no speeches against the nomination. Upon ballot Prof. Baldwin was confirmed by a vote of 11 to 10, a strict party vote, with three Senators absent. The resolution was transmitted immediately to the House, where it will come up today on a motion to concur with the Senate. The vote will be taken by ballot.

SMALL-POX IN THE WALLS.

Although Covered by Wall Paper for Thirty Years They Are Active.

NEW HAVEN, Feb. 2.—Thirty years ago a person was sick of small-pox in a farm house in the country town of Groton, across the Thames River from New London, and after the patient recovered the dwelling was fumigated and the room in which he had been ill repapered. Ira Chester and family now dwell in the house, which is on School street, in Groton, Bank hamlet, near the tall monument in memory of the Fort Griswold massacre. The paper that was placed on the wall of the room in which the small-pox patient was sick 30 years ago was removed a week or so ago, and presently Mr. Chester's seven-year-old daughter was stricken with small-pox. In the opinion of the physicians the germs of the disease were dormant in the walls of the room, and when the paper was stripped from them the disease was communicated to the child. In no other way is her sickness to be accounted for, since she had not been otherwise exposed to the malady.

PERHAPS A PROTECTORATE.

A Possible Solution of the Pending Hawaiian Ouestion.

BOTH PARTIES PROMISE AID IN CONGRESS.

Present Session Can Accomplish Little.

WASHINGTON, Feb. 2.-No developments which might be called actually new may be expected in the Hawaiian affair until the arrival here of the Commissioners representing the Provisional Government at Honolulu. Every day, however, makes it more evident that there will be practical unanimity in Congress, either for the immediate annexation of the islands, in case that proves advisable and in case it can be accomplished before the 4th of March, or for the immediate establishment of a protectorate, with a view to an-

The policy of President Harrison for an immediate protectorate is promised substantial support by both parties in Congress. Secretary of State Foster held conerences this morning with Senator Morgan, the leading Democratic member of the Senate Committee on Foreign Relations, and with Representative Blount, the Democratic Chairman of the Committee on Foreign Affairs, and with Representative Hitt, ex-chairman and the leading Republican member of the same com-

It is generally agreed that it would be difficult, as the President himself has assumed, to do much at this Congress. These consultations have served to show. however, that not since the controversy with Chile, when Democrats, with few exceptions, vied with Republicans in upholding the hands of President Harrison, has there been such practical unanimity

of opinion in both Senate and House.

It is fully expected that Great Britain, as soon as the Hawaiian commissioners have formally made their proposition and as soon as President Harrison has sent to Congress or to the Senate his expected message recommending annexation or a protectorate, will make a protest. That will probably be followed by diplomatic correspondence, which may grow very spirited and which may lead to serious controversy, for this Administration will not be turned aside by any threats which the British Foreign Office may make.

WHAT HAWAIIANS WANT.

Their Representative Thinks the English Form of Colonial Government Best.

OMAHA, Feb. 2.-The Commissioners of the Provisional Government passed through Omaha last evening on their way to Washington to present the claims of that country for admission to the United States in some form or other.
"If your credentials are accepted what

form of government will you request," was asked Mr. Thurston, Chairman of the Commission.

"That question has been asked frequently," replied Mr. Thurston. "But we have not any information as to the wishes of the people whom we represent on that point. The fact is we are not agreed on what we want or what would be best for the interests of the white population of the island and for all concerned. Of course, our admission as a State is out of the question.

"Our admission under the laws governing Territories would be equally un-satisfactory to the United States and the representatives of the Provincial Government. Popular government is out of the question, and, still, popular government in some modified form is the only thing that will satisfy the people.

"The most of us are agreed that we could get the best results from a Government similar to that which England gives her colonies. We would expect the United States to appoint a Governor of the island, and leave the election of the legislative bodies to the qualified voters of the island."

DEADLOCK UNBROKEN.

Col. Benton Three Votes Short of Being

Elected United States Senator. BISMARCK, N. D,. Feb. 2.—John D. Benton (Dem.) came within three votes of being elected United States Senator again yesterday. As the temperature was hovering about 40 degrees below zero, several members suffering from bronchial troubles remained away from the Capitol. Nearly all of the Democrats and Indenearry all of the Democrats and Independents, however, were in their seats, and word was passed around to vote solidly for Benton. The anti-Casey Republicans, however, did not embrace the opportunity to put Mr. Benton through, as they cast three votes for each of the four candidates.

THE PANAMA PRISONERS.

M. Eiffel's Lawyer Makes a Speech in His

PARIS, Feb. 2.—The trial of the Panama defendants was resumed yesterday. The court room was crowded with people anxious to hear M. Waldeck-Rousseau's defence of M. Eiffel. M. Waldeck-Rousseau began by remarking that the prose-cuting officer, in his five days' speech in-dicting the accused, had occupied scarcely 50 lines with the charges against M. Eiffel. This, the counsel argued, indicated a belief in M. Eiffel's innocence. M. Waldeck-Rousseau proceeded to detail the provisions of M. Eiffel's contract with the Panama Canal Company.

M. Waldeck-Rousseau declared that his

client, without inquiry having been made or proof adduced, had been repreached with making a profit of 33,000,000 francs out of his contract with the company. M. Eiffel had had his accounts audited, and no breach of trust had been revealed. He had accepted the contract, which involved great difficulty and risks, and had commenced his work without delay. This work M. Eiffel has pushed forward actively until he was notified by the com-

any to cease operations.

M. Waldeck-Rousseau went on to say that the profits attributed to his client from Panama connections were mythical. The truth was that M. Eiffel had incurred enormous expense, and when the contract was cancelled he had fulfilled all his engagements. Pending the argument the court adjourned.
