Major McKinley is a friend to all legitimate manufacturing enterprises. He was born in one manufacturing center and reared in another, and has by personal experience learned of the benefits which accrue to the community and the commonwealth by the prosperity of industries. In his public career he has devoted himself to the perfection of legislation in this interest, and he loses his private fortune in an attempt to build up a business which would promote the welfare of the workingman. His declaration that every dollar for which he is responsible shall be paid, even if it takes all that he has been enabled to accumulate, is only in harmony with the high character he has always maintained as a man of the strictest honor and highest integrity.

Fortunately this reverse will not remove Governor McKinley from the activities of public life. To the Nation this is an important matter. Invaluable as his services have already been, there is a feeling that he has but just entered upon a career of exceptional usefulness to his countrymen. The Republic has need of him and men like him as it never had before.

And that which has happened within the past few dayswill only commend him still more strongly to the esteem, affection and confidence of his fellow citizens as not only an accomplished publicist but a man of the most exacting sense of honor as well.

Having suffered ourselves to an amount even beyond the extent accredited to Governor McKinley, in precisely the same direction, we know how to sympathise full well with any one of his high honor and sensitive nature.

A Plea for the Democracy,

We enter a respectful but firm protest against the growing tendency on the part of Mr. Cleveland's personal organs to condemn Democrats who criticise the appointment of Mr. Gresham, says the Washington Post. Of course Mr. Cleveland has the right to invite Mr. Gresham to enter his Cabinet. The President is responsible for his administration, and Mr. Cleveland, more than any Executive who ever occupied the chair, regards Cabinet officers as the mere agents of his political plans. Nevertheless, the members of the party that elected him to the Presidency have some privileges also, and among these is the privilege of expressing their approval or disapproval of Mr. Cleveland's public acts.

The personal organs have a great advantage at this time which they should not use too ruthlessly. They support Mr. Cleveland, while they despise or

only tolerate Mr. Cleveland's party. If the latter had taken into his Cabinet net only Mr. Gresham, but Mr. Ingalls, Mr. Chandler, and three or four other anti-types of Democracy, the personal organs would still have been in a position to commend, because they are committed to nothing but adulation of Mr. Cleveland and his acts. They are safe, whatever happens, and can be consistent no matter what Mr. Cleveland does. But plain, ordinary, hard-working Democrats, who believe in the party first of all and who think that leaders owe something to the organization that created them, are not so comfortably situated. They remember quite distinctly that Mr. Gresham has, often and without much ceremony, expressed his opinion of them, and they can hardly be expected with water which quickly froze.

"As happy as a clam at high water has long been an expression which is supposed to represent the height of felicity and enjoyment that would result to the bivalve being perfectly secure from capture. But this has now got to be laid on the shelf with many an-other exploded theory for by an invention of James B. Burr the clam car now be dragged from its lair at high tide as well as low, and can no longer gambol about in its native element in peace and security. Mr. Burr has invented a contrivance that enables him to go on our shores at any time of tide and capture either hard or soft clams with greater ease that was ever dreamed of by our fathers. It is a metal cylinder with valves and handles whereby the operator can easily work it down into the sand or mud and when estimated that the great faction when satisfied that the gay and festive clam is in the cylinder, by closing the valve can raise the entire contents to the top of the water or into the boat and then liberate instantly the load, pick up the clam and again start for his prey. By this contrivance one can go out before the tide falls off entirely, particularly on the L. I. Sound side and catch clams fully an hour longer than is now possible. WALKING IN AIR.

The Fahyahs Do It and Many Other

The Fahyahs are the greatest legerde mainlsts, necromancers and hypnotists

in the known world.

One of their principal feats is walking in the air. The Fahyah who performs it lays flat down with his face toward the earth for a minute or a minute and a half, then arises, and forcing his arms against his sides, standing very erect, deliberately walks into the air as far as his power of endurance will permit him, at times reaching an altitude of from 250 to 400 feet, when he simply walks down

JUBILEE THE KIND THAT CURES

Thousands of Pilgrims Did Homage to the Pope.

IMPRESSIVE SERVICES HELD IN ST. PETER'S.

Perfect Order Kept in Immense Throngs.

ROME, Feb. 20.—At daybreak yesterday he pealing of the church bells announced the celebration of the Pope's episcopal jubilee. By four o'clock thousands of pilgrims, tourists and citizens were crowded before the doors of St. Peter's. At five o'clock two battalions of infantry in full uniform were drawn up before the Cathedral, so as to ready to help the 200 or more gendarmes in preserving order. The crowd swelled steadily, but remained quiet, despite the tremendous pressure caused by some 5,000 ticket holders in their hopeless struggle to get near the

At six o'clock the Cathedral doors were opened and the foremost of the crowd swept in. Within half an hour the great building was packed to the steps. Thirty thousand pilgrims and twenty-five thousand or thirty thousand Catholics from this city gained admission. No fewer than 49,000 persons, many of them ticket holders, were turned away by the military, who cleared the space round the building, so as to prevent disorder when the service closed.



POPE LEO XIM.

The Pope entered the Cathedral at a quarter to 10, pale but smiling and apparently in somewhat better health than usual. The Cathedral rang with tremendous cheering as the Pope was borne toward the altar. His Holiness officiated at the special jubilee mass, intoning the opening words of the Te Deum and giving his blessing in a clear, penetrating

The mass lasted until a quarter to 11, but apparently did not fatigue His Holiness. He remained in the Cathedral 45 minutes after the celebration and then proceeded to his apartments. The crowd dispersed slowly. At noon most of them

the military withdrew.

In the afternoon the Irish pilgrims attended service in the Church of St. Sylvester and were blessed by Cardinal Logue. The English pilgrims at St. George's received the blessing from Car-

dinal Vaughan.

The weather was magnificent all day. The air was mild and dry and the sun shone uninterruptedly. Last evening St. Peter's and all the other churches, all the convents and hundreds of private houses were illuminated. The streets were thronged and the square in front of St. Peter's was almost impassable. Without exception, however, the people were perfectly orderly. Not an arrest has been reported. King Humbert and Queen Margaret took their usual drive through the city and everywhere were saluted re-

spectfully.

The scene at the Cathedral was brilliant and impressive. The interior was hung in crimson and profusely dressed with flowers. The Pope, in full canonicals, was borne on the sedia gestatoria up the nave to the altar, acompanied by a gorge-ous procession of richly clad and be-jeweled Cardinals and officers of the Swiss Guards. The vigor of the Pope's movements during mass and the energy

movements during mass and the energy of voice and gesture as he gave the blessing astonished the people.

A transparency before the Belgian College in Rome attracted a group of Liberals, who shouted, "Long live Italy!" to which the Catholics replied, "Long live the Papacy!" There was a little excitement, and gendarmes removed the transparency. Otherwise nothing occurred to mar the peace and pleasure of the day.

Seeking Aid for Home Rule. London, Feb. 20.—An appeal signed by Justin McCarthy, Edward Blake, Thomas Sexton, Michael Davitt, John Dillon, Timothy M. Healy, William O'Brien, Arthur O'Connor and Thomas Power O'Connor, addressed to "our kinsmen and all friends of Ireland in the United States, Canada and Australia," has just been issued calling for financial support to aid Gladstone to successfully carry on the struggle for Home Rule. The signers of the appeal fear that the bill will meet well-nigh insurmountable obstacles in the House of Lords.

Making Real Diamonds.

PARIS, Feb. 20.—M. Moissan, member of the Academie des Sciences, has brought before his colleagues a number of mice Superior Quality, scopic specimens of true diamonds, m by him from ordinary carbon which had crystallized. SATOLLI IS DISPLEASED.

Bishop Wigger's Action is Severely Cen-

BAYONNE, N. J., Feb. 20.-Rome has spoken through her Apostolic Delegate in the Bishop Wigger case. Monsignor Satolli has put his foot down and has made known to the Bishop that he will stand no trifling with his decisions in the controversy between Father Killeen and the Bishop as to the re-opening of St. Thomas's Church.

The church must be re-opened, and there must be only two principal parishes in Bayonne, namely: St. Mary's, of which Father Killeen is the pastor, and St. Thomas's, for which a pastor has still

Bishop Wigger astonished many people a week ago by sending a letter to be read at the Catholic churches of Bayonne, which either reversed or modified the terms of Mgr. Satolli's recent decision in the case. Both Father Killeen and Father Ahne then complied with the Bishop's request, as they were in duty-bound, but Father Killeen said at the time that Bishop Wigger was pursuing a course which was at variance with the Apostolic Delegate's wishes.

At yesterday's services Father Killeen read a letter from Mgr. Satolli to Bishop Wigger. He stated that he was directed not to permit the letter to be inspected. While the latest communication may be taken as final from the highest authority opponents of Father Killeen are not tisfied and await further news from Bishop Wigger, who must explain his

BEDFORD, Pa., Feb. 20.—Saturday night 20 men, part of whom were masked, called at the house of John Pleasinger, in the suburbs of the town, and after knocking at the door, which was opened, asked for Orange Gordon, a colored man, who has been waiting on Pleasinger's daughter for some months.

Pleasinger showed fight, but four re-

volvers were thrust in his face, which had the result of quieting him. They then gearched the house, but Gordon had made his escape at the rear.

They then went upstairs and, finding the girl in bed, gave her a mild thrashing with hickory whips. The girl showed fight, and succeeded in knocking one of the white caps down. The party were provided with tar and feathers, and Gordon would have fared badly had he been found.

Two Men Killed, TROY, N. Y., Feb. 20.—Two freight trains bound east, on the Fitchburg Railroad, collided near Athol, Mass. The locomotive of the second telescoped the caboose of the first train, on a steep down grade. SENATE AND HOUSE, WEEDING

Congress is Not Working as Populists Seeking Control of Fast as Desired.

APPROPRIATION BILLS ARE BE-HIND TIME.

Night Sessions Threatened -- Mr. Fear That Trouble Has Only Just

WASHINGTON, Feb. 20.—The backward state of appropriation bills lends serious interest to the remark that Senator Vilas might only be a short interval between the adjournment of this Congress and the assemblying of the next.

Mr. Allison, Chairman of the Approsessions for the Senate to dispose of the appropriation bills, but experience has shown that it is impossible to hold the Senate together in night sessions for more than one or two nights. Nicaragua bill, another fruitful subject of talk, is the unfinished business, and there is the Hawaiian treaty to be dis-

posed of in executive session. It is possible that the New York Bridge bill and the Utah Admission bill may come up in the House under suspension of the rules.

He has not asked for an opportunity to pass the bill under suspension of the rules, and it is asserted by its opponents that he could not so pass the bill if he tried. Two other courses are open to him—first, to get a special order from the Rules Committee giving him a day for the bill and then to vote down the previous question, as the antisilver men attempted unsuccessfully to do, and amend the order by making a cloture rule a part of it; second, to move to go into Committee of the Whole to consider revenue bills. This latter course would put no curb on the filibusterers, and therefore Mr. Hatch is not likely to take this course. If he did so the fight would be one of endurance between the friends and opponents of the Anti-Op-

JACKSON'S SUCCESSOR.

The President Has Concluded to Fill the

Vacancy on the Circuit. WASHINGTON, Feb. 20 .- President Harison has concluded to fill the vacancy in the United States Circuit Court, created by the appointment of Judge Jackson of Nashville to the Supreme Court. The President says that if there were any understanding among Senators which led them to believe that he would not fill the Circuit vacancy he is not responsible for it; that he made no promise in that direction, and is free to act if he succeeds in finding a man who is well fitted for the position and so popular personally as to

be reasonably certain of confirmation.

The President believes he can select from the list of applicants presented a man for the Circuit whose nomination will be confirmed, and he will try today to make that selection. He wants a Republican for the place, and hopes to take one from Kentucky.

An Ex-Assemblyman Goes Wrong. NEWARK, N. J., Feb. 20.—Thomas Cavanagh, who was last year an Assemblyman elected from one of the districts in this city, has left town and is short in his accounts. He was the Treasurer of St. Patrick's Alliance, No. 7 of this city, and an investigation shows that he has taken most of the money in the treasury of the association. He owned a number of houses, but they have been mortgaged to pay his losses at pool rooms.

Mormon Preachers Murdered. PULASKI, Tenn., Feb. 20.-News has reached here from a remote part of Lewis county, about 25 miles from Pulaski, that two Mormon preachers who had been in that section for some time preaching Mormonism, after being repeatedly warned to leave the country, were, while preaching to a small crowd, assassinated by a masked band of men.
