New Military Law.

The special board appointed some time since by Adjutant-General E. E. Bradey consisting of Colonel Tyler, of the Third regiment, C. N. G.; Lieu-tenant-Colonel Burpee, of the Second regiment, C. N. G.; Lieutenant Bowen, U. S. A., and Corporal Beach, F com-pany, Second regiment, U. N. G., for the purpose of regiment, the state milithe purpose of revising the state mili-tary laws and code of regulations, have about completed the first part of their work.

Some of the changes made in the proposed new law are quite radical but there is not one of them but what will be approved by every member of the National guard of this state. One of the most important is the reduction of the term of service from five to three years. The present term of five years has long been considered too long and has presented many young men from has prevented many young men from enlisting. This section will provide for subsequent re-enlistments of two years each until age limit of 45 is reached.

The new law will also provide for the

The new law will also provide for the appointment of a board which shall consist of the governor, the adjutant general and the brigadier general commanding, who will be empowered to increase the number of infantry companies of the state from forty, the present number, to forty-eight.

An important change is made in re-

An important change is made in regard to the pay of both officers and men. According to the present law privates and musicians are allowed \$2 and 30 cents extra for rations. No provision is made for the pay of the noncommissioned officers. The new law states that the officers of the national New Freight Engines.

No attention was paid to her for some time, as it was thought she was merely indisposed. Suddenly a terrible scream was heard from the young girl's eabin. Mrs. Reagan, the stewardess of the Bolivia, rushed inside, followed by a few of the passengers, and were terrified by the sight which met their eyes.

Elizabeth Wright was on her knees on the floor, with her hands clasped across her breast and her long hair trailing down below her waist. A strange, unnatural light glowed in her eyes. The moment she saw the stewardess and the passengers shere-doubled her shricks and cried in heartrending tones to be saved from drowning at sea. Mrs. Reagan endeavored to calm her,

but it was no use. The young girl, who had been completely unnerved during the storm, had gone crazy through fear Her agonizing shrieks could be heard above the howling of the blast. She endeavored to push the kind-hearted stewardess aside and get on deck. She was, however, restrained, and forced gently into her berth. The ship's surgeon was summoned and he, too, for a long time was unsuccessful in trying to calm the frenzied girl.

The doctor, as a last resort, administered an opiate to the girl, and she sank into a quiet slumber. FIGHTING IN RIO GRANDE.

A Federal Army Besieging the Town of Santa Anna.

NO DECISIVE BATTLE HAS YET BEEN REPORTED.

Disaffected Government Cavalry Refuses to Fight.

VALPARAISO, Feb. 25 .- From various sections in the Rio Grande do Sul comes news of fighting. The Federals have assumed the offensive and appear to be making decided gains. An army of 2,000 Federals is besieging the town of Santa Anna. They are poorly armed and hence have made no assault on the town.

The Second cavalry, which is in garrison at Santa Anna, made a sortie and attempted to drive away the beleauguering forces. After a desperate skirmish they were defeated and were compelled to seek refuge behind the defences of the town.

A fierce battle was fought near Dom Pedrito. Many were killed on each side, but the result of the fight is not known. Government cavalry are disaffected, and in some cases have refused to fight the rebels. Colonels Pinto and Barcellos. with their commands, have passed over to the Federals.

The Federal Government has sent 3,900 national troops to Pelotas, in the province of Rio Grande do Sul. It is stated that the Twelfth regiment of cavalry was de-feated by the Federals and pursued into Uruguayan territory, where they were disarmed by the troops of that country. The Castilhistas admit they have suffered many losses owing to desertions.

A revolution has broken out in the province of San Pablo against Gov. Campos.

One painful feature of the fighting which is going on in the unfortunate province of Rio Grande do Sul is the awful atrocities against non-combatants of which both sides are guilty.

It is said in Buenos Ayres that the ex-

pected resignation of President Saenz Pens will be based on the ground of a wide divergence of opinion in the Cabinet.

CAPRIVI'S BIRTHDAY.

The Chancellor Presented a Sword of Honor by the Kaiser.

BERLIN, Feb. 25 .- Yesterday being the 62d birthday of Chancellor von Caprivi, the Kaiser was the first to call at the Chancellor's residence to congratulate him. The Kaiser expressed a wish that his valuable life might be spared for many years to the service of the State. Then His Majesty personally presented to the Chancellor a sword of honor, gold hilted, and splendidly incrusted with precious stones. The gift is regarded as significant, in view of the alarming reasons which Caprivi has held out for the passage of the Army bill.

Leprosy Spreading in Canada. OTTAWA, Ont., Feb. 25. — Dr. A. C. Smith, the inspecting physician at the Le prosy Hospital at Tracade, reports the same number of inmates as in 1891, 14 males and eight females. During 1892 three patients died and three new cases were admitted. While on a tour of inspection last year Dr. Smith found leprosy cropping out in unexpected

The De Lesseps' Appeal Rejected. PARIS, Feb. 25.—The Court of Cassation announced its decision rejecting the appeal of Charles de Lesseps, Marius Fontane and M. Sans-Leroy from the indictments charging the two former with corrupting members of the Chamber of Deputies, and the latter with receiving a bribe while a member of the Chamber.

A Tax on Time Bargains. PARIS, Feb. 25 .- The Chamber of Deputies today, by a vote of 436 to 41, passed the bill providing that a tax shall be levied on time bargains on the Bourse, as explained by M. Tirard, yesterday. The Chamber then rejected a proposal to impose a tax on time bargains in produce and merchandise.

Moravia Puts Into Halifax. HALIFAX, N. S., Feb. 25 .- The Hamburg liner Moravia, 17 days from Hamburg and 18 days from Portland, England, bound to New York, put in here yesterday short of coal. The ship met with the same gales and high seas reported by other steamers, and sustained slight damage.

An Anti-Parnellite Victory. DUBLIN, Feb. 25 .- Mr. Hogan, the anti-Parnellite candidate, was elected without opposition to the seat in Parliament for Middle Tipperary, made vacant by the death of John F. McCarthy, anti-Parnell-ite, who was elected in July last by a large majority over Conway, Parnellite.



An Insane Man Wounds the Famous Financier.

THE INJURY DANGEROUS BUT PROBABLY NOT FATAL.

Would-Be Assassin Fatally Shot Himself.

SAN FRANCISCO, Feb. 25 .- John W. Mackay, the multi-millionaire, was shot shortly after noon yesterday. W. C. Rippi, a crank, is the would-be assassin. Having been crazed on the subject of stocks, he had an imaginary grievance against the Bonanza King and tried to kill him.

Belleving, probably, that he had finished Mr. Mackay, Rippi turned his weapon against himself and inflicted a death wound over the heart.

Tremendous excitement was occasioned by the shooting. Rumors were rife that he was the victim of an Anarchist plot. Then the man's name was given as Ratcliffs. Later he was designated as Dunn, Finally the authorities decided the shooter was William C. Rippi.

Mr. Mackay gave the information of the attempted killing himself. He cool-ly drove back to the Palace Hotel and "I have just been shot. I den't know

the man. Send for my doctors. I don't think I'm hurt much, but I can't tell Then Mr. Mackay went to his apartments in the hotel and awaited the arrival of the physician.

Mr. Mackay thought the man had killed himself. This was not confirmed. He was picked up by the police, carried out of Sutter alley to a patrol wagon and driven to the Receiving Hospital, where he is reported to be dying.

By 2 o'clock in the afternoon the doctors had extracted the bullet from Mac-

kay's back, dressed the wound and put the patient to bed for a while.

Then they left a nurse in charge and

announced that Mr. Mackay's wound was not serious. The bullet had not injured the shoulder-blade, and was easily withdrawn from the flesh, they said. Mr. Mackay ordered a cablegram sent to Europe informing Mrs. Mackay and their sons and daughter of the shooting,

making the point that he would soon be Dr. John F. Morse, who performed the operation in conjunction with Dr. Keeney, said that the bullet entered below the right shoulder-blade, and, ranging slightly to the right, struck the vertebrae

and lodged in one of the spinous proces-Dr. Morse said that the wound was not necessarily fatal, but that the patient was by no means out of danger. He added that in the case of gun-shot wounds there was always danger of blood-poisoning or

lock-jaw.
William C. Rippi was well known to old-timers in San Francisco, and was a familiar figure around 1,229 Powell street, where he made his home. Everybody who knew him considered him harmless. For the last two years he roomed at the above address, and the landlady asserts that he was the easiest to please of all

the boarders.

He was born in Cincinnati, O., and leaves a widow and family there. At one time he was worth over \$100,000, and made about \$50,000, on Comstock.

He came to San Francisco and began gambling in stocks. His money soon

began to go and then he opened a cash grocery store on Fourth street.

That venture failed, and about four years ago he was running a bar and dining room on the steamer Mary Gafrett which plies between San Francisco and

At one time he lived in Denver and owned quite a lot of property, but it also went in his stock speculations. Latterly the old man was almost without means and was in a very despondent frame of mind. He knew almost all the old-timers in California. When no one else could identity, old man Rippi was called, and he generally succeeded.




