### Pope Leo's Jubilee.

That His Holiness Pope Leo XIII. should feel grieved because of the nonappearance of American pilgrims in Rome to join in the universal homage paid to him on the celebration of his episcopal jubilee is certainly only very natural. The Vatican is evidently convinced that this lack of American attendance is due to the serious differences that have disturbed the life of the Church on this side of the Atlantic. There can be no doubt, says the Recorder, of the allegiance of many millions of Americans to the Holy See, and, from any standpoint we choose to take, it is to be regretted that America has not joined in these great pilgrimages which have been instituted to show the esteem and reverence in which Pope Leo is held.

The days have fortunately long since passed when even Protestant rulers and peoples could think with jealousy of the splendid position which the Pope holds in the world of religion. Pope Leo especially has won with every year of his pontificate the admiration of men for the words of gentle remonstrance and statesmanlike wisdom which he has so frequently uttered on momentous occasions, and which the great world has been willing to listen to as coming from one in supreme authority over millions among us. Protestants and Catholics alike will, we believe, join sincerely in the wish that His Holiness may be preserved long in life and that he may live to see during his jubilee that his beneficent rule has won the admiration of millions who do not own religious allegiance to him.

THE PUBLIC DEBT.

Statement of the Treasury's Condition at the End of February. WASHINGTON, March 2.-An increase of \$615,699.14 in the net debt of the United States is shown in the public debt state-

ment for February, issued yesterday. The balances of the several classes of debt at the close of business February 28 were: Interest bearing debt, \$585,034,260; debt on which interest has ceased since maturity, \$2,335,305.26; debt bearing no interest, \$375,912,187.37; total \$963,281,752.-

There was in the Tressury at the same time a total of \$764,322,266.78 of cash. The receipts for the month were \$33,-009,892.23. The expeditures amounted to \$31,677,454.

Presidential Nominations.

WASHINGTON, March 2.- The President has sent in the following nominations: Truxton Beale of California, to be Envoy Extraordinary and Minister Plenipotentiary and Consul-General of the United States to Roumania, Servia and Greece. Genio M. Lambertson of Nebraska to be arbitrator on the part of the United States under the treaty for a claims com-mission concluded between the United States and Chili. Alfred B. Pusey of Kentucky and E. M. Shipp of Virginia to be Assistant Surgeons in the navy. Second Lieut. C. P. Summerall, First Infantry, to be Second Lieutenant of artillery.

"No Differences," Says Mr. Murphy. NEW YORK, March 2.-Before leaving for Washington yesterday Mr. Edward Murphy said that there were no differences with Mr. Cleveland in the Demo-cratic party of the State. Mr. Cleveland, he said, entered office with the good wishes of every Democrat, and was not likely to disappoint them. Mr. Murphy said that he would call on Mr. Cleveland in Washington at his first opportunity.

Reception at the White House. WASHINGTON, March 2. - President Harrison held his last informal public reception at the White House yesterday. The one of yesterday was the largest public function of this character, in point of attendance, held by Mr. Harrison since the first few days of his term as President, when many thousands of visitors crowded through the White House in the hope of seeing the new Executive.

Distinguished Visitors to Congress. WASHINGTON, March 2. - Vice-President-elect Stevenson appeared on the floor of the Senate about 3 o'clock yesterday and was given an informal reception by Senators of both parties. Gov. Russell of Massachusetts visited the House, and a number of members were presented to

A Dinner to Richard Olney. Boston, March 2.-A banquet was given to the Hon. Richard Olney, the coming Attorney-General, last night at the Hotel Vendome by the Suffolk bar. There were about 250 members of the profession present.

Gleveland Filed an Objection. WASHINGTON, March 2.-Mr. Cleveland has written a letter to Secretary Noble objecting to the proposed concert in the Pension building Sunday evening. The concert will not be held.

Stevenson Received by Morton. WASHINGTON, March 2.- Last evening Vice-President Morton established a social precedent by giving a reception to his successor, Mr. Stevenson.

### WASHINGTON NOTES.

Comptroller Hepburn has appointed Frank M. Hayes bank examiner for the Southern District of New York State. Gen. Canevaro, the new Peruvian Minister, and Clement Haeutjens, the new Minister from Hayti, presented their cre-

dentials to the President. The Senate passed a joint resolution to authorize Thomas Adamson, United States Consul General at Panama, to ac-

cept an honorary medal from China in recognition of his services to Chinese subjects in Panama. The Post Office Appropriation bili was

reported to the Senate and placed on the calendar. The committee added to the House bill \$75,000 for the cancellation of stamps, and added a little more than \$200,000 to the appropriation for foreign mail service. Gov. Flower and his staff will not lead

the New York State troops in the military division of the inaugural parade as was originally intended. He with his staff will appear in the civil division escorted by Troop A, National Guard, in command of Capt. Charles F. Roe.

The Indian Appropriation bill was reported to the Senate. The appropriation of \$8,796,336 for the purchase of the Cherokee outlet was inserted in the bill as a separate section, making the grand total of the bill \$16,431,490. The appropriation for the current year is \$7,664,047.

The Sundry Civil bill was reported to the Senate by the conferrees. Agreements were reported upon all points, but the mendments relating to the World's Fair, the Sherman bond issue amendment, the appropriation of \$50,000 for the entertainment at the exposition of notables invited by the Government. The total of the bill is \$37,966,356.

Senator Higgins introduced in the Senate a bill to give effect to the President's recommendation to Congress touching the Canadian railways. It repeals Article 29 of the Treaty of Washington, and also repeals the statutes which permit goods to be shipped in bond through Canada between United States ports, which permit consular sealing of cars, and which permit relived care. exempt railroad cars or vehicles from duty and inspection.

The Secretary of the Navy took action in the cases of three officers now undergoing suspension. Commander Felix McCarthy, who was convicted of running the Alliance on a breakwater, and Chief Engineer Gowan, convicted of drunkenness, are restored to duty, and Passed Assistant Paymaster Cowie, sentenced to five years' suspension for drunkenness, has had his sentence reduced to two years' suspension, dating from last October.

### THEY FOUND OPEN DOORS.

Law and Order People Met in the Assembly Chamber.

STRONG PROTEST AGAINST THE JERSEY RACE BILLS.

Resolutions to be Presented to the Legislature.

TRENTON, N. J., March 2.-The Law and Order people found the latchstrings of the Assembly Chamber on the outside when they arrived yestenday, and they had no difficulty in holding their indignation meeting there. A large delegation from Camden county was the first to arrive. Its members walked into the chamber and took possession, notwithstanding the announcement of Speaker Flynn yesterday that they could not use the chamber.

The meeting was advertised for noon, but it was later than that when it began, owing to the fact that the protestants were not decided where to meet. When the announcement was made that they could not use the Assembly Chamber yes terday, Taylor's Opera House was secured, in order to be on the safe side. As a con-sequence, a big crowd went to the Opera House, but found none of the leading

lights there.

Rev. Dr. Dixon of Trenton called the crowd in the Assembly Chamber to order, and stated that another meeting was about to be begun in the Opera House. A motion was adopted to combine the two, and a committee brought in over 1,000 people, headed by Rev. Dr. Kempshall of Elizabeth, who was given the Ocean Grove salute when he entered.

Dr. Kempshall was immediately elected Chairman. He made a stirring address, in which he said that the tyranny sought to be fastened upon the people of New Jersey was worse than that which the redcoats sought to enforce.
"This," said Dr. Kempshall, "is the

house of the people, built by the people; yet we were denied the right to use it by the man whose seat I unworthily occupy. We now occupy the chamber by the right of eminent domain. But, even though our blood boils with righteous indignation, let us not forget our solemn re-

syonsibility.

"We stand here, humiliated to the lowest degree in the eyes of our sister States; but, by the help of God, we will show them that the same blood which flowed in the veins of our revolutionary fathers

Dr. Kempshall referred to the remark made by Speaker Flynn about letting women talk, and termed it as an insult, and when he spoke about the retort which Mr. Lane made, the large audience broke forth in a paroxysm of en-

When Dr. Kempshall finished the meeting adjourned to Taylor's Opera House, where another large body of peo-

The audience listened to a resolution extending thanks to the legislators who voted against the bills, and urging the other members to vote for the passage of the repealers.

A committe consisting of one member

from each county was appointed to draft resolutions for presentation to the Legis-After this committee retired. Dr. Aus-

tin Scott of Rutgers College made a spirited address. Very Rev. Dean McNulty of Paterson

Other speakers were W. H. Beach of Jersey City and Vice-Chancellor John T. Bird.

SAVED BY THE ENGINEER. Pulled His Train Out of Danger as the Earth Sank.

MOREA, Pa., March 2.—An engineer's nerve saved a train of loaded cars and the lives of the six men who composed the train's crew at this place yesterday. Engine 576 made up the train and then started to pull out. Conductor Crosby, with one of the brakemen, entered the cab, and two other brakemen sat on top of the first car.

Just as the train was approaching the switch leading to the main line the earth about the tracks sank. The engineer started ahead at full speed, and all of the cars but 10 had reached the main line when the siding on which the train had stood disappeared. The 10 last cars were engulfed, the couplings fortunately breaking, thus saving the remainder of the train. The siding was built over a mine, the roof of which caved in.

### HE TOOK SALT PETRE.

Strange Death of a Man Whose Life Was Heavily Insured.

ROXBURY, Ct., March 2.—Edward Mannering, a well-to-do farmer of this place, died February 19 under suspicious circumstances. He had felt ill, and his wife, it is alleged, advised him to take a dose of salt petre in a cup of coffee. He did so, and soon died. The case is being investi-

A man named Whitman and Mrs. Mannering have been arrested on suspicion of conspiring to cause Mannering's death. The farmer's life, it is said, was heavily insured. Whitman formerly worked for Mannering, but was discharged, it seems, because he was too attentive to the farmer's wife.

Kaiulani Comes to Seek Help to a Throne.

SHE WILL PLEAD HER CAUSE AT WASHINGTON.

She Wants Either Dominion or Protectorate.

NEW YORK, March 2.-Princess Victoria Kaiulani, the claimant of the throne of Hawaii, arrived in New York yesterday from England on the White Star steamship Teutonic. She is on her way to Washington to plead her cause and request the United States authorities to either restore her to her kingdom or establish an American protectorate there.

The Teutonic, which was beaten in her race across the ocean by the City of Paris, was sighted off Fire Island at 12.15 p. m. yesterday, and reached Quarantine at 3 o'clock. She was at her pier a few minutes after 4 o'clock.

E. C. Macfarlane, ex-Minister of Finance to Queen Liliuokalani, and Dr. Mott Smith, the Minister at Washington of the Hawaiian Queen, went down the bay to meet the Princess, taking passage on the revenue cutter Chandler. They boarded the Teutonic at Quarantine.

Minister Davies, the Envoy of Hawaii in England, accompanied the Princess on her voyage. Mr. Davies is an Englishman and has

extensive commercial interests in the Sandwich Islands. He strongly favors the establishment of a regency in the islands, with S. B. Dole, Chief of the Provisional Government at its head, as President or Executive, so that Princess Kaiu-lani may be crowned Queen at the attainment of her majority.

The Princess is 18 years old. She is tall, of sweet face and slender figure, with soft brown eyes and swarthy complexion. She has been in Europe several years, acquiring an education.

Rooms for the royal party had been engaged at the Brevoort House, Fifth aveue and Clinton place. It is not expected that she will remain in New York more than a day, but will proceed today to Washington, where she will be present at the inauguration of President Cleveland.

The Teutonic was more than seven hours late. She had a rough voyage, encountering strong gales nearly all the way across. She was passed by the City of Paris February 26. She had more than 1,000 passengers on board.

A reporter saw the Princess in her cabin. She appeared to be in excellent health and spirits, and spoke hopefully of the prospects of succeeding in her mission.
