A special word of kind farewell is to be said to the retiring Vice President, Mr. Morton. No one has ever realized more completely the ideal of this unusual office, says the Philadelphia Times. The Vice President has nothing to do but to preside over the Senate -and wait. Most Vice Presidents have thought it necessary while waiting to keep themselves in evidence. They have often formed little centres of intrigue, such as may form around the heir-expectant in a monarchy. They have dreamed of setting up for themselves and becoming the inheritors of power by other process than the accidental one provided for them in the Constitution. Mr. Morton has done nothing of the sort.

No man ever filled the Vice Presidency for four years and kept himself more successfully subdued. He has presided over the Senate with the utmost dignity and impartiality. A better Chairman the Senate never had, yet he has so carefully avoided any selfassertion in the chair that on one or two occasions, when his casting vote would have been important and might have determined the policy of his party, he has taken care to be away.

Being fortunately a man of means, he has held up the social end of his position with the utmost acceptability, and for their programme. has been entirely respected and csteemed by all shades of Washington society. But his great success has been made in keeping resolutely out of any evident participation in politics. If chance had called him to the Presidency, he would have come to it untrammeled; as chance did not, he remained outside, never embarrasing by word or deed either the President or his party, and leaving Washington precisely as he entered it, an independent and self-re specting gentleman.

communication from the superintendent of the company:

Norwale, Conn., Feb. 24th, 1393.

James T, Hubbell, Esq.,

Dear Sir:—Your favor of the 23rd received and contents noted. I am sorry there have been complaints about the lights and also about the globes being dirty. I think perhaps were the matter thoroughly investigated you would find that there is really not as much cause for complaint as the members of the board of Burgesses seem to think exist. You must realize that we have had a hard and stormy winter, particularly the last few weeks, and the heavy wind has caused lights to be out at times which otherwise would not have been so. The frost and sleet gives the globes, in a great many cases, the appearance of being dirty where they are really not so. This weather gives us much more labor, and causes us to use much more coal than we would otherwise have to use.

My lamp trimmers have orders to properly trim and clean each lamp and globe, and also to go over the circuit after the lamps are started and see that each one is burning properly. After they have done this if some lamp goes out, because of high wind or other causes, I have a man at the station who goes out and fixes such lamps when reported to us. The trimmers also have orders to report to the office every lamp which they have found necessary to start, and also every lamp which has not burned through. They can tell such lamps by the length of carbon left unconsumed.

These lamps which are reported as being out are rebated for at the end of the month in our bills to the Borough. I would be very much pleased to have citizens make complaint to me of anything which is amiss in the service and the same would be promptly attended to. The trouble seems to be that if one light is out for half an hour one night a great many people see it and the consequence is that a report gets about that quite a number of nights, when in fact they have all seen the same light the same night. It would please ne very much if you could give me the particulars of complaints which may turn up should be particularly reported to me in order to enable us to discover whether the fault is ours entirely, or on the other hand, whether it is a complaint which is a little "stretched."

Report of Councilman Volk that an electric light be placed in front of the Methodist church was accepted. \$350 was appropriated to the committee on lamps and gas for use of electric light commissioners. A resolution authoriz-ing the committee on streets to purchase a steam road roller at a cost net to exceed \$4,500 was offered and will to exceed \$4,500 was offered and will be voted upon at the annual city meeting, which will be held in a few days. The clerk was authorized and directed to publish a statement of the expenses of the city for the past year, also the report of the electric light commissioners, which was read and placed on file. Carriages were in readiness, the first being for the use of ex-President Harrison, Gov. Matthews and Gen. Harrison's grandson, Benjamin Harrison McKee, also occupied this carriage, which was preceded by the marching clubs, the first of which was the Columbia Club. The welcome home of Gen. Harrison was as warm as was his godspeed to Washing-

As his carriage proceeded slowly up Illinois street to Washington and thence east to Pennsylvania street, the ex-Presieast to Pennsylvania street, the ex-Fresh-dent was kept busy bowing and lifting his hat to the cheering people along the way. The procession disbanded at the new Denison Hotel, and later in the after-noon Gen. Harrison was driven to his old home, at 674 North Delaware street, with

Mrs. McKee and family.

Last night a general reception took place at the State House. Gov. Matthews delivered an address on behalf of the State, and the Hon. C. W. Fairbanks spoke for the citizens of Indianapolis.

THE CABINET CONFIRMED.

Nominations Acted on Speedily by the Senate Yesterday.

WASHINGTON, March 7.-At 11.50 a.m. esterday Maj. Pruden, the President's Executive Clerk, appeared upon the floor of the Senate bearing the nominations of he officers of President Cleveland's Cab-

net, as follows: Walter Q. Gresham of Illinois to be Secretary of State; John G. Carlisle of Kentucky to be Secretary of the Treasury; Daniel S. Lamont of New York to be Secretary of War; Richard Olney of Massa-chusetts to be Attorney-General; Wilson S. Bissell of New York to be Postmaster-General; Hilary A. Herbert of Alabama to be Secretary of the Navy; Hoke Smith of Georgia to be Secretary of the Inter-ior; Julius Sterling Morton of Nebraska

to be Secretary of Agriculture.

After the Journal of Saturday's session was read, Mr. Pruden presented his mes-sage, and on motion of Senator Harris, Dem., Tenn., the Senate went into executive session. The Cabinet nominations were then confirmed.

The Senate afterwards adjourned until Thursday noon.

Judge Gresham took the oath of office as Secretary of State at the State Department yesterday afternoon. His commission and those of the other members of the Cabinet had been received at the White House from the Department and were handed by Private Secretary Thurber to the President, who signed them

immediately.

Col. Crook, the Disbursing Officer and Notary Public of the White House, administered the oath of office. Acting Secretary of State Wharton signed Judge Gresham's commission, and the latter will perform a like office today for his associates in the Cabinet.

Sending in Their Resignations.

WASHINGTON, March 7. — W. E. Simonds, Commissioner of Patents, and Assistant Commissioner Frothingham will today send in their resignations to the President to take effect March 31, or whenever prior to that date, their successors may be appointed. Messrs. Simonds and Frothingham have formed a partnership with Col. C. L. Burdett of lartford for the practice of patent law in New York city.

The Inaugural Fireworks.

WASHINGTON, March 7.—Incidental to the inauguration festivities was the illumination of the Capitol Building and Pennsylvania avenue and the display of fireworks on the monument grounds last night. These were to have taken place Saturday night, but owing to the inclem-ent weather they were postponed.

Ex-Secretary O'Brien Cared for. WASHINGTON, March 7. — President Cleveland has appointed Robert O'Brien, who was his private secretary during the campaign, executive clerk at the White House. The salary is \$2,000.

Invited to Open the Fair. WASHINGTON, March 7. - President Cleveland was yesterday formally invited to open the World's Fair. He has the matter under consideration and will answer in a day or two.

Gresham No Longer a Judge WASHINGTON, March 7. — Secretary Gresham has filed his resignation as Judge of the Seventh Circuit and it has been accepted.

Tommy Russell Gets \$14,000. NEW YORK, March 7.—The parents of "Little Lord Fauntleroy" Tommy Russell have recovered in the Supreme Court a verdict of \$14,000 against Edward K. House, who dramatized Mark Twain's "Prince and Pauper." They made a contract with House to produce the piece for two years, with their son in the leading role, at a salary of \$100 a week. A QUARREL IN THE HOUSE OF COMMONS LOBBY.

Saunderson's Charges Against the Irish Party.

LONDON, March 7 .- When Col. Saunderson, the Grand Master of Orangemen and member of Parliament for North Armagh, denounced the Irish Home Rule members a few days ago as defenders of criminals, William Redmond, Parnellite member for East Clare, challenged Col. Saunderson to repeat the words outside the House of

Col. Saunderson offered to repeat the vords anywhere, and after the debate he wrote a note to William Redmond offering to repeat in the lobby what he had said.

Last evening Col. Saunderson and Mr.

Redmond met in the lobby.

Mr. Redmond, going up to the doughty
Colonel, asked: "Do you accuse me and
my colleagues of being murderers?"

Col. Saunderson replied: "I know nothing of you personally, but I accused the Irish party of conduct leading to murder."

Both Redmond and Saunderson were angry and confronted each other in pugi-

listic attitudes.

Peers from the House of Lords and members of the House of Commons gathered around in expectation of seeing

he first blood in the threatened civil war between the Ulsterites and the rest of Ireland. Just as the two seemed about to strike friends stepped between them preventing blows. Col. Waring, Conservative member for

North Down, one of the strongest Loyalist leaders in the North of Ireland, restrained Col. Saunderson, while James J. O'Kelly, Parnellite and formerly member for North Roscommon, held Redmond

Speaker Peel, hearing of the affair, or-dered a police inspector to the scene with instruction to arrest the man who struck the first blow. The inspector appeared towards the end of the quarrel and, after having warned both members of the nature of his instruction, waited to see what would happen.

Col. Waring led Col. Saunderson away

to the library, Saunderson showing evidence of much excitement and anger. Mr. Redmond walked away from the scene amid shouts of "They shall meet at Boyne!" followed by cheers and laugh-

It is reported that Col. Saunderson has challenged Mr. Redmond to a duel on the Continent.

GAGGING THE PRESS.

M. Ribot Only Wants to "Protect Foreign Ambassadors."

PARIS, March 7.-In the Chamber of Deputies M. Develle, Minister of Foreign Affairs, spoke at length in support of the bill making punishable with special severity all libelous attacks of the press upon foreign ambassadors.

M. Ribot said that the Government had no intention of curtailing the legitimate freedom of the press, and had no objec-tions to the criticism of foreign ambassadors in any spirit which might suit the

Such blackmailing accusations as had been current a short time ago, however, and other gratuitous insults could not be tolerated, and the Government required the passing of the bill in order that in any future emergency it might be prepared to deal summarily with the offend-

ers.

The Government would regard the vote on the subject as a matter of confidence. The bill was then approved by a vote of 257 to 188.

POPE LEO GRATIFIED.

Pleased With the Plan of Catholics to Give Mgr. Satolli a Home.

ROME, March 7.—Pope Leo is gratified by the offer of American Catholics to give to Mgr. Satolli a residence in Washington as a present in honor of the Pope's Episcopal Jubilee, and his Holiness will send his benediction to the donors. It is reported that Dr. O'Connell, the American Secretary to the Propaganda, has been appointed to a high place, and that the delay in America in the assumption by the Rev. F. Z. Rooker of Albany of the post of Secretary to Mgr. Satolli is due to the negotiations in regard to the Rev. Mr. Rooker succeeding Dr. O'Connell.

Protest Against Home Rule. DUBLIN, March 7 .- In addressing the Senate of Dublin University yesterday, Lord Ashbourne said he was convinced that if the Home Rule bill should be passed, Ireland would be thrown into a state of semi-bankruptcy and civil war. The Senate voted to petition Par-liament against the passage of the bill.

Twenty-Seven Drowned. PARIS, March 7 .- Advices from Madagascar bring news of the wreck of the French dispatch boat Labourdonnais, near the French island of St. Marie. Twenty-seven of the crew were lost.


A WORLD'S FAIR STRIKE.

CONFLICTING STATEMENTS OF SEVERAL AFFIDAVITS.

phine to Helen Potts.

The Convicted Murderer Makes His Last Stand.

NEW YORK, March 7.-What may be the final skirmish in the famous battle of Carlyle W. Harris to escape the penalty for the murder of his wife, Helen Potts Harris, of which he was convicted, took place in the Court of General Sessions vesterday.

Harris' fate rests with Recorder Smyth. Application has been made for a new trial and affidavits have been submitted by the score. The crowd that collected in the court-room, expecting to see Harris, was disappointed, for he was not brought into court. Neither was Mrs. Harris there. Moreover, there was no argument in the

The District Attorney submitted a number of affidavits and consented to the introduction of two affidavits by Mr. Howe. One was from Dr. Hugh S. Kinmonth, a druggist and a graduate of the College of Physicians and Surgeons. Dr. Kinmonth says he comes forward now because of the attacks upon the testimony and characteristic Leffects the Ashara Beach darks acter of Lefferts, the Asbury Park druggist. He says that he frequently sold morphine pilts to Helen Potts, who told

him they were for her mother. One of the people's affidavits is from J. H. Van Mater, the owner of the drug store in Asbury Park where Lefferts worked. He says that he never had as much morphine in stock as Lefferts testifies he sold to Helen Potts.

To offset this Mr. Howe had prepared an affidavit of his own in regard to an inventory of William Stiger, dealer in drugs at 20 College Place. The inventory shows that Stiger sold to Van Mater on June 25, 1890, several hundred morphine pills and opium in other forms.

The District Attorney's affidavits all attack the character of the persons who made the affidavits submitted by Mr. Howe on his motion for a new trial. Two of the witnesses who say Helen Potts was in the habit of taking morphine are Mrs. Mary Harris Frenette and her daughter Ethel. Detective Alex. Gray of Philadelphia says that he knew Mrs. Frenette in 1887 as the mistress of James N. Taggart, who is a fugitive from justice accused of robbing the Union Trust and Safe Deposit Company of Philadelphia. On one occasion, Gray says, he overheard a conversation between Taggart and Mrs. Frenette in reference to Mrs. Frenette's daughter. The girl went to Canada with Taggart when he fled and subsequently accompanied him to Eu-

rope.
Guillaume Pons, who keeps the Hotel
de Louvre at 53 West Twenty-eighth street, and Catharine! Saudray of the Hotel Luxembourg, 400 Sixth avenue, make affidavits about the great trouble they had with Mrs. Frenette and her

daughter when they boarded there.

The other affidavits are against Drug Clerk Lefferts' probity. George Potts, Helen's father, makes affidavit that none of his family was at Ocean Grove, N. J., or in the State of New Jersey at all be-tween June 1 and the latter part of Sep-tember, 1893. He believes that Lefferts never knew his daughter.

The Recorder will read the affidavits

and, it is expected, render his decision this week.

THE MISSING NARONIC.

Her Crew Thought to Have Been Saved by the Eglantine.
PHILADELPHIA, March 7.—The British

steamship Eglantine, from Rio Marino for Philadelphia, was sighted at 5.30 p. m. vesterday passing the Delaware Breakwater. In a few minutes she displayed signal that there was a crew of shiprecked seamen on board.

It is unusual to signal at this point the presence of a shipwrecked crew unless an important vessel has been left behind by those saved. It was too dark to get any response to signalled inquiries from shore, but among the shipping people it is believed that the Naronic's crew were the shipwrecked people. The Eglantine will be at her wharf at Port Richmond today.
