The Naval Parade.

The naval parade in New York was one of the finest pageants that this country has ever seen. And its significance at New York was different from its meaning at Hampton Roads. At the latter place it was chiefly remarkable as a gathering of warships of all powers at a great naval port. In New York it was as a representation of the maritime powers in the harbor of the mightiest commercial port of this hemisphere, destined to be the richest port in the world.

At Hampton Roads the review was purely naval; at New York it was more strictly maritime. At Hampton Roads we looked at the ships as engines of war; in New York we looked at them as the friendly representatives of great powers whose relations are those of peace and who rejoice in our well-being. America is proud to welcome them to our shores and to invite them to share our hospitality.

It is the hope of the civilized world that before many years these mighty warships of to-day may be needless; that warfare may be abandoned for wiser methods of settling disputes; that great nations may abstain from enlarging their possessions by seizing distant territory, and allow the doctrine of universal home rule to have sway. But until then warships and coast defenses will be necessary.

The United States has made wonderful strides in the building up of a pow-ful Navy Our coast defenses are erful Navy. The Soldiers of the Sea Make a Fine Display.

A SPLENDID STREET SPECTACLE.

The Naval Brigades of Ten Nations Capture New York Streets-How the Marines and Seamen Looked-Heartily Cheered by the Populace.

NEW YORK, April 29.-Never has a more interesting spectacle been presented to Americans than that of the naval parade yesterday as witnessed from the lofty buildings in the vicinity of the City Hall. The esplanade in front of that graceful pile of architecture which has for nearly a century been the chief ornament of New York is admirably adapted for just such a review, while the adjoining park, streets and buildings furnished ample accommodation for spectators. The sun shone brightly down on the green of the park, the vast crowds were orderly and goodnatured, and the police, themselves a fine example of discipline and manliness, showed their ability to manage the multi-

The arrival of the parade at the City Hall was delayed until noon, and meantime President Cleveland had been obliged to start away without waiting for the review. To the American and foreign menof-war's men, however, the presence of their own commanding officer was quite a sufficient incentive to put on the very best appearance. Throughout all the brilliant line of sailors and marines from both hemispheres it could be truly said that none showed better discipline or finer physique than the United States naval brigade. There was a harmony, grace and intelligence in their marching that was the English discipline was as perfect, but it was stiffer and more mechanical.

The British officers marched in that per functory fashion which characterizes the official Englishman, whether at court or in the field or on the quarter deck. They seemed oblivious of their surroundings, and conscious only of her majesty's uni-form. The crowd extended generous applause to the Englishmen, who made the turn into Park Row in excellent order. and marched in the same direction that the departing British troops followed on Evacuation Day, 110 years ago.

The Russians looked remarkably well in their white caps and handsome uniforms and showed very good discipline. Strange to say they were not applauded. Perhaps they were not generally recognized by the spectators. The men from the Dutch manof-war, although not imposing in numbers, were conspicuously Dutch in their tidy, well ordered appearance, and compared favorably with the rest of the parade in discipline. They received a scattering volley of applause, probably from some people who remembered that New York

only New Amsterdam. The French marched well and were per haps the most picturesque of the foreigners, and the Germans showed up splen didly, receiving a hearty welcome. Italians looked good, but did not keep time as well as some of the others. Their officers exhibited a vivacity and nervous-ness of manner in notable contrast to the calm, deliberate conduct of the more northern races. The Brazilians and Ar gentines were not conspicuous in the parade, and their discipline was not equal to that of the well trained Europeans.

The familiar strains of "The Red, White and Blue" ushered in the third division, composed of state troops. The fine appearance of these men must have given the foreign admirals some new ideas regarding the citizen soldiery of America The provisional regiment marched in admirable order, and those who had seen the foreigners pass had no reason to be ashamed of the Americans. Among other regiments of the National Guard the Sev-

enth attracted most attention.

The Sixty ninth, which marched to the strains of the "Star Spangled Banner," looked as ready for war as for parade, and the white uniforms of the Twenty-second contrasted picturesquely with the blue of the Twenty-third, the regimental procession ending appropriately and significantly with the torn battle flag of the Seventyfirst. All the citizen soldiers bore a highly creditable part in the most memorable review that New York has witnessed, at least since the civil war, and the foreign naval officers in their gold and lace viewed the scene with an interest that was evidently more than official.

The Naval Reserve of Massachusetts were

quite an attractive feature in the parade, and were followed by the Naval Reserve of this state. The officers of the fleet filled a long line of carriages, and were received everywhere with hearty cheers by the vas crowds that lined the streets over which the parade passed.

The line formed on Forty-second stre et and marched down Broadway to Park Row and past the reviewing stand at the City hall to Ann street, and then turned into Broadway, continuing down that thoroughfare to Battery Place, and thence to pier A, where the steamers were wait-ing to carry the sailors and marines to

their ships.

The only marring incidents were a slight accident to Mr. Cleveland when he was entering his carriage to proceed to the reviewing stand, which delayed him twenty minutes, and the fog, that made the start as much later. The reception that was to have teen held by Mayor Gilroy at the city hall did not take place owing the de-lar in ctarting the nervale. lav in starting the parade.



MURDER MYSTERY CLEARED. After Twenty Years a Tramp Confesses

the Crime. BANGOR, Me., April 29.—Twenty years ago Daniel Morrison, a wealthy sportsman from Ohio, was murdered and robbed in a hunting camp near Moosehead lake. His guide, whom he had dismissed a few days before, was arrested but proved an alibi. The murdered man's relatives and the authorities made all possible efforts to discover the guilty person but failed. A letter has just been received here containing the information that a man named Markham died a few weeks ago in Bonanza City, Idaho. On his death bed he confessed that he killed Morrison. He said he was out of money and tried to rob Morrison. In the struggle that ensued he killed him. He escaped into Canada, and then went west, never returning to this part of the country.

HARRIS' CASE HEARD.

The Commissioner Takes Testimony in Relation to Helen Potts.

NEW YORK, April 29.-Most of the witnesses called yesterday in the hearing before Commissioner Raines in the Carlyle Harris case testified that they had had opportunities for observing and had never noticed that Helen Potts took morphine. Others declared that they would not be ieve under oath Dr. Kinmouth, the Asbury Park druggist who said he had sold her morphine. Mrs. Potts denied that she had ever said she hoped Harris would not be executed. She also declared that Helen had never refused to go home declaring that it was a "hell upon earth." Miss Jackson, the seminary principal, con-tradicted her. The hearing will probably be concluded today.

Bitter Legal Fight Ended.

TRENTON, April 29.—Two years ago Harry Kern and Rachel Johnson, of At-lantic City, were married. Kern was a business man, who at one time lived in Philadelphia, and his bride was highly respectable. Almost immediately after the marriage Kern was placed in an insane asylum, and his brother Frank was ap-pointed his guardian. Frank began proceedings against Harry's wife and Rev. John Payran, the minister who performed the ceremony. He wanted the marriage annulled on the grounds that Harry was mentally incapable of choosing a wife. The fight was a bitter one, and Vice Chancellor Green has decided that the marriage was

Ocean Penny Postage Discussed. LONDON, April 29.—Gerald E. W. Loder, Conservative-for Brighton, made a motion in the house of commons for ocean penny postage. He spoke at length in favor of reducing to one penny the postal tariff for letters passing from one British colony to another and between any British colony and the postal tariff or another and between any British colony and the mother country. Arnold Morley, postmaster general, Mr. Gladstone and Sir William Harcourt, chancellor of the exchequer, expressed their approval of the principle of the motion, but maintained that financial considerations made the change impossible at present. The motion was withdrawn.

Killed by a Brother. BENGIES, Md., April 29.-William H. Burneston, a fisherman, was shot and in-stantly killed by his brtoher, John N. Burneston. William returned from Baltimore in an intoxicated condition. He got into a scuffie with his brother, during which one barrel of a gun was discharged, the contents entering the wall. John then got the gun, when a second barrel was discharged, accidentally, he says, and William fell dead.

Judgment for Boatbuilders. WASHINGTON, April 29.—The court of claims has rendered judgment for \$91,072 in favor of Snowden & Mason, of Bronswille, Pa., who in 1862 built the ironclad monitor Manajunk. The plans of the vessel were modified so as to provide for the enlargement of the vessel after the contract was made for which the claim for additional compensation was made.

New England Directors Meet. Boston, April 28.—An informal meeting of the New York and New England Rail road company directors was held yester-day. President A. A. McLeod presided. The actual net increase in earnings for the month of March were \$39,910,50 and the auditor claims that certain adjustments will swell the total net increase to \$45,000.

Has Plenty of Work. BALTIMORE, April 29.—The Maryland Steel company, which went into the hands of a receiver about a week ago, has been given a large order for steel rails from the New York, New Haven and Hartford Railroad company. The daily output of the rail mills is steadily increasing.

Russia's Five Million Exhibit. BALTIMORE, April 29. - Five special trains of twenty cars each passed over the Baltimore and Ohio railroad today, bearing the five million dollar Russian exhibit to the World's fair. Three Russian officials accompanied the trains as a guard




