Those Water Meters.

When Benjamin Franklin discovered electricity, Morse the telegraph, Howe the sewing machine, Fitch the steamboat, Edison the electric light and Bell the telephone, the world looked on aghast and wondered what startling discovery would next appear. They were great discoveries, but they pale into infinitesimal insignificance alongside of the Borough water meters, which a short time ago were placed by the Water Commissioners upon the motors of a selected few of our water

consumers. A motor in use by one of the Commissioners was exempted from this selected number and he cannot, therefore, enjoy the wonderful mechanism contained in one of these innocent looking little machines, nor can he stand and gaze upon it and watch the "w'eels go wound" with that awe and admiration enjoyed by the members of the selected few, but he can, however, throw up his hat with enthusiasm and cheer his colleagues who so kindly provided for his motor's exemption.

On December 8th, 1892, the following retroactive notice was sent out by the clerk of the Water Commissioners to the selected motor users.

Norwalk, Ct., Dec. 8, 1892. Please také notice that from and after Nov. 1, 1892, your water supply will be furnished you by meter measure-ment, and the rate charged will be 50 per M gallons. By order of the Board of Water Commissioners.

Respectfully yours,

A. H. CAMP, Sec'y. None of the water consumers who received this illegal notice discontinued their water service, however, but they watched the cunning little dial fingers as they joyfully sped around their meter disks with far more interest than did "Helen's Babies" when they eyed the watch; and well they might, for with a concealed velocity unknown to man they danced about the dial's face, each striving with the other for superiority and each grinning with ghoulish glee as he thought of what the selected few would say when they received their water bills on May first.

Bright and early on Monday May 1st clerk Camp with a Mugwumpian smile to-night. The principal business will that Le had been drunk for six months, be the arrangement of a Memorial day which is not generally believed, but as o'er-spreading his face journeyed to the post office laden with the water bills programme. for the selected few. He appeared un usually happy as he tripped along. He laughed, joked, shook hands with, and told a jolly story to every one he met as though he, too, was enjoying the huge joke perpetrated upon the metered users of Borough water as well as those jovial little fingers who had made for themselves a record that no human power could excel.

The first of the selected few to receive his bill was Captain R. M. Rose, who found that in fifteen days his meter had registered 495,998 gallons of Huckleberry water. The next to fall in line for gruel was John Wade, who was thrown into a violent attack of the grip on discovering that the Hour motor had used but 1,249,235 gallons of the precious fluid. After Wade came the GAZETTE, (which had been unable to turn its press with water power without the aid of a steam engine) with 1,888,700 gallons.

These bills were ridiculous enough, but they were not in it with A. J. Meeker & Bro. When A. J. opened his yellow envelope he found that in six months' time those dear little fingers had waltzed about the disks on his meter until they registered 5,631,766 gallons, and his please-call-before-thetwentieth-and-settle called for \$281.59. The record made by the Meeker meter was never excelled in but one instance when Captain Rose succeeded in coaxing his dial up to 6,721,528 gallons in six months.

After receiving the bill and inspecting the inoffensive looking little demon. the GAZETTE concluded that it was either crazy or some unseen power was toying with its interior. With that conclusion in view a letter was addressed to the New York Scientific American, the standard authority on Burgesses. everything relating to mechanics and hydraulics, requesting them to state how many gallons of water, with a 75 pound pressure, could pass through a one-quarter inch nozzle (which the GAinquiry from the Scientific American taste.'

stating that about 800,000 gallons of water could pass through the nozzle.

resent. The death rate for the state was 21.2. Bridgeport is credited with cases of nearly all of the infections diseases, among them being la grippe, diphtheria and croup, typhoid fever and cerebrospinal fever. An adjourned meeting of the Court of Burgesses was held Tuesday evening. It was understood that the meeting was called for the purpose of paying bills only, but at the outset other

important business was introduced.

The Warden and full board were present. After calling the meeting to order Warden Sloan remarked that there were some gentlemen present who evidently wished to be heard, and extended to them the privilege of mak-

Reading's Ex-President Replies to Expert Rice.

"Because of the publication of Mr. Isaac L. Rice's report, in which it is insinuated that I induced the Philadelphia and Reading Railroad company to relieve me of a private speculation in the stock of the Boston and Maine Railroad company and of the New York and New England Railroad company at a time when it had greatly fallen in value, in justice to myself, requires me to state the facts of that transaction. I care not to say aught in vindica-tion of my management of the Philadel-

I must look for that.

"In the summer of 1892 it was advisable, I thought, to secure such a control of the stock of those companies as would bring about an alliance between them and the Philadelphia and Reading Railroad company under one president—an alliance which would inure to the benefit of all, and especially to the company of which I was then president. I saw my way, by means thereof, to the placing, under most favorable circumstances, in territory not otherwise controlled by it, of an immense additional tonnage of anthracite coal; to the securing of assured customers for large quantities of bituminous coal; to the making the Lehigh Valley branch a connecting link between the west and New England in the transportation of immense quantities of the products of the former,

and to many other advantages.

"Everything I did, from the beginning to the end. in the purchase of shares of the Boston and Maine Railroad company, and of the New York and New England Railroad company, was done solely and exclusively for the purpose of insuring to the Philadelphia and Reading company for its benefit, and not at all for my own, of the control necessary to accomplish this al-liance. At no time was I actuated by any desire to benefit myself personally. I had no intention to speculate in the shares of stock of either of those companies upon my own personal account, nor to reap any

pecuniary benefit therefrom.
"My motives and intentions were communicated at the time, not officially, but very fully, to three directors of the Philadelphia and Reading Railroad company, to one of its prominent officials, and to several other persons. They were fully apprised from the beginning and throughout of my intention concerning these

After reviewing at length his negotiations for the absorption of the two roads, and defending his action in the matter,

Mr. McLeod concludes: "Reflecting now upon what was done, then in this matter, I believe I acted with no selfish desire and with no intention to do other than that which I deemed for the true interest of the road I represented. He will meet the infanta at

Quarantine on Friday. Commander Davis saw Private Secretary Thurber prior to his departure in reference to the final details of the official recep tion of the Infanta Eulalie in Washington

Commander Davis says that if the vesse on which the infanta is coming to the United States arrives in New York early on Friday next the royal party will come to Washington that evening unless the infanta is too much fatigued to continue her journey, in which event she will remain on board the vessel until Saturday morning, when she will start for Wash ington on a special train over the Penn sylvania railroad. No questions were asked by the commander in reference to the manner of her entertainment while in this city, and no information bearing on that subject was given him, so that the action of the president with reference to the infanta remains as much a mystery as

MADRID, May 17.—An official statement has been issued concerning the reception of the Infanta Eulalie in the United States. It says that the Spanish government re garded it as offensive to American cour-tesy that any negotiations should be made in advance as to the reception in the United States of the royal guests invited by the American people to attend the World's fair. Unsolicited, however, an intimation had been given by the Washington government that the infanta, as representative of the queen of the nation who discovered America, would be received with the highest honors.

Christie Warden's Murder Avenged. CONCORD, N. H., May 17.—Frank C. Almy, or George H. Abbott, was hanged in the jailyard here for the murder of Christie Warden at Hanover, N. H., in July, 1891. The murderer went to his doom with annarent unconcern. The exe cution was a bungling affair. Almy's feet touched the floor when he went through the drop, and he was apparently strangled to death. A minute after he fell officers body up several feet. The rope had pulled over the left ear while the knot was fully one foot above the neck. Among the witnesses was a brother of the murdered girl.

MORE VISITORS NEEDED.

The World's Fair Losing a Moderate Fortune Every Day.

WORKMEN CLAMORING FOR WAGES.

Their Pay Long Overdue, and They Are Kept Waiting Because the Officials Are Short of Cash-Directors Decide to Return the Government's Donation.

CHICAGO, Way 17.-While the weather may be a monotonous subject to read and talk about, it is nevertheless becoming a serious matter to thousands of people who are financially and otherwise interested in the exposition. Yesterday was the six-teenth day, and more bleak, disagreeable weather it would be hard to find anywhere at this season of the year. The effect is seen on all sides, and the exposition people are discouraged accordingly. The average paid attendance so far has not been much over 17,000 daily, which is far below the



B. J. PRICE. number necessary to meet even the operating expenses of the exposition, to say nothing of the millions of half dollars needed to pay the bondholders and stock-holders of the great enterprise.

Thousands of strangers are in the city waiting for fine weather to come to Jackson Park, but they refuse to shiver on the lake shore even for the sake of seeing the fair. Outdoor work in the Midway Plais-

ance and other parts of the exposition is also being retarded by the cold.

The Woman's congress in Memorial Art palace, on the lake front down town, is proving a counter attraction to the fair week. The woman's building does not seem to have as animated an appearance inside today as last week, because nearly all the women are interested in the con

The judiciary committee of the national commission has vetoed the resolution of the national body which was referred to it providing for the establishment of a bureau of complaints. In a report to the commission the judiciary committee said the director general was the proper person to adjust all claims and hear complaints, and that in their judgment the establishment of this bureau is unnecessary. The eport was adopted.

Considerable discontent and uneasines is apparent today among some of the la-borers on the grounds and janitors of the different buildings because their salaries are not forthcoming. The carpenters and staff workers erecting the band pavilions in Administration plaza, who struck on Monday for back pay are still out. The men have not been paid for three or four we k, and another month's pay will be due on the 26th. The contractors have been putting them off from day to day with the information that they will be paid when the exposition gives them the

money due on the contract. Nearly all day long lines of shivering workmen are to be seen outside the office of Paymaster Meehan. When asked why they were there the men said they had be n waiting for their pay for several days, and it was not the first time they had stood in line there only to be put off with the announcement to "come around tomorrow at such a time."

A national commissioner said, in speak-

ing on the subject: "I have no doubt that the exposition authorities are hard up for money. Every-thing has worked to the detriment of the fair for some time now, particularly the weather. It would not be surprising if several of the Chicago capitalists would be asked to help out before this month is over. The running expenses of the fair are about \$45,000 daily. That means 90,000 paid admissions every day to pay the bare operating expenses."

Columbian guards laid violent hands on Chief Allison, of manufactures and liberal arts, late Monday night, and there is music in the air in consequence. The chief is not only bent upon having the scalp of every guard who took a hand in his arrest, but he is determined to obtain an apology from his higher officers. The department chief presented himself at the exposition gates with several assistants at nearly the midnight hour. He showed his credentials and passports, gave his name and stated that his business at that hour was to superintend some important work of installation. The guards on duty not only refused to admit the chief of the biggest department in the White City, but they discredited his story and doubted if he was Chief Allison. This did not im-prove the situation and the end of it was the chief and his party were arrested as suspicious characters, taken in the patrol wagen to the guard house and confined wagon to the guard house and confined

wagon to the guard house and comment there nearly three hours before being identified and released.

The directors of the World's Columbian exposition have decided to abrogate their contract with congress by which they bound themselves to close the fair on Sunday in consideration of an appropriation of \$2,500,000. The money will be returned to the government and hereafter the fair will be opened Sundays. This course was decided upon at a special meeting of the directory yesterday afternoon. The action was practically unanimous, but two directors out of thirty-six voting against the proposition. By the terms of the resolu-tion the machinery will be closed down on Sunday, but in every other respect the fair will be open in all departments the same as on secular days. What action the national commission will take is problemated. In any event it is the evident purpose of the local directors to open the fair Sandays, even at the expense of a rupture with

Mecca. President T. W. Palmer, of the World's Columbian exposition, delivered an address of welcome and was followed by Mosses P. Handy, who also welcomed the editors to Chicago. On behalf of the convention Governor George W. Peck, of Wisconsion, who is also a delegate to the convention, responded to the addresses of welcome and Byron J. Price, president of the association, also expressed his thanks.

The men fought with skin tight gloves, and at the end of the third round, when Hawley was knocked out by a vicious blow over the





CANNOT ENFORCE LAW

The Government Will Not Attempt to Deport Chinamen.

CONGRESS MUST PROVIDE MEANS

Otherwise the Mild Celestial Must Re main Undisturbed in His New Home The Chinese Six Companies Asks That the Law be Temporarily Suspended

WASHINGTON, May 17.—At yesterday's cabinet meeting, with a full attendance, the Chinese question as complicated by the decision of the supreme court, was discussed from every point of view, and it is the complete with the supreme court. is understood the conclusion reached was reason that there was no money available for that purpose. The act only carries an appropriation of \$100,000, and Secretary Carlisle showed that not more than \$35,000 of that sum remained, with some bills still unaudited to be acted upon. It was estimated that it would cost to deport all the Chinamen now in the country who have not complied with the law more than \$6,000,000. This statement exhibited what one member of the cabinet called the utter inability of the government to give any effect to the law itself, without further action by congress. Under the circumstances it was understood that nothing could be done, and it is said there is little if any probability of the government making any immediate effort to put the law into effect.

One member of the cabinet, who holds a high place and is looked upon as a man of strength and character, made the broad assertion after the session was over that the law was nothing short of a political scheme enacted for political effect (he said in fact, something about "demogoguery") and he intimated that there had been a general hope among his associates that the court would have held it to be unconstitu-

It is assumed that in the ordinary cours of diplomatic usage a copy of the decision of the supreme court, as soon as the ma-jority members of the court had determined upon its exact phraseology, will be transmitted to the Chinese minister to be by him forwarded to his government.

This will necessarily involve considera ble delay, and congress will probably be again in session before a return can be

made to this communication. Numerous telegrams have been received at the treasury department respecting the decision. Most of these telegrams ask that the law be suspended for at least six months, as its execution at this time will impose great hardships on Chinamen in the United States. Among the telegram-received is one from the attorneys of the

Chinese Six Companies, who also ask for a suspension of the law.

Treasury officials acquainted with the

record of the Six Companies during the past three or four years regard this request, coming from them, as rather sur-prising in cool assurance. These officials assert that of the 110,000 Chinese in the United States, probably one-third have come into this country illegally; that the come into this country illegally; that the Six Companies have persistently encouraged the violation of the law by furnishing transportation from China to this country to Chinamen, supplying them with fraudulent certificates on their arrival, and taking collateral from them when they landed in the United States for money advanced for passage. In fact the Six Companies, it is asserted, have practically mortgages upon the labors of thouscally mortgages upon the labors of thousands of Chinamen for years to come, and if they be now deported in accordance with the decision of the supreme court the Six Companies will lose hundreds of thousands of dollars advanced by them to Chinese immigrants.

The rumors and surmises of Chinese re taliation are not given credence to. Not even an intimation bearing on the report that the Chinese government in ends to deport American missionaries and all other citizens of this country has come to the ears of department officials.


