A Committee to Organize a Campaign Club.

A caucus of the Republican electors of the First and Third Voting Districts was held at the Town House last even-

Less than fifty voters were present Bradley S. Keith was elected chairman and Francis Leonard secretary.

The first business before the meeting was the election of delegates to the state convention. It being voted that the selections be made by ballot the Chair appointed Samuel Lynes and Joseph A. Gray tellers.

Belden Hurlbutt, Fred A. Hill and Arthur C. Wheeler, was appointed to consider the matter of forming a Republican club in the First district, and then the caucus adjourned.

ARE IDENTIFIED.

Three of the Men Shot at Bedford Station Known.

Two Kept a Bicycle Store in Brooklyn.

The identity of the three burglars who were shot while attempting to break into the store of Walker B. Adams & Son, at Bedford Station, early Thursday morning, and who shot the elder Mr. Adams, inflicting a wound from which he died at quarter to one o'clock yesterday morning, without having regained consciousness, is being established.

A man visited the Long Island Hospital on Thursday night and asked that a severe bullet wound in his arm be attended to. He declared that he had been shot at Long Branch while handling a pistol.

His description agreed with that of one of the burglars at Bedford Station, who escaped after being shot in the arm. The hospital authorities therefore detained him and communicated with the Brooklyn police, who placed him under arrest.

R. A. Schenck, a blacksmith at Bedford Station, who saw the burglar who was shot in the arm and escaped, visited the Long Island Hospital yesterday and identified the man there as the robber.

Detective Sergeants McCauley and Vallely, of New York Police Headquarters, accompanied Schenck to the hospital. They also identified the prisoner as Charles Jenkins, alias John Gilmore, alias Clarke, a bank robber and burglar, who has served several terms in prison and whose picture is No. 1,364 in the Rogues' Gallery. His record appears in former Superintendent of Police Byrnes' book on criminals.

The two other burglars who were shot in the fight and locked up in the jail at Mount Kisco, are said to be John Jenkins, who passed as a brother of Charles, and Peter James. They lived in New York and kept a bicycle shop and salesroom at No. 112 Atlantic avenue, Brooklyn, and had a repair shop in Henry street near Atlantic avenue,

Father Huntman, of St. Francis' Catholic church, at Mount Kisco, heard the confession of the burglar who was shot through the lung. The burglar told the priest his name and address in New York.

The priest went to New York Thursday evening, presumably to inform the man's relatives. At any rate, two middle-aged women, dressed in black, arrived in Mount Kisco on the train from New York a 9 o'clock vesterday morning. They were accompanied by Detective Sergeants McCauley and Vallely. They visited the jail together.

The women saw both the prisoners alone. They addressed the man who was shot through a lung as "Pete." They showed some emotion, but after leaving the jail and before returning. drank several glasses of whiskey.

It was said one of the women was a sister-in-law of one of the burglars.

McCauley and Vallely looked at the prisoners in the hope of identifying them, but refused to say if they had

The women, accompanied by the detectives, left on the train at twenty minutes to two o'clock in the afternoon, Before the train reached White Plains the detectives placed them-under arrest and locked them in the county jail at White Plains.

This action was brought about by Coroner Birch, of that place, who believes the women can give important information about the attempted burglarly and facts which may show which burglar shot Mr. Adams.

The women would not tell their names nor would the detectives disclose them. When questioned at the jail the women replied, "We are too old to turn traitor now."

Acting Superintendent of Police MacKellar, of Brooklyn, said last night that the prisoner's name was Charles Jenkins. He said the burglar who was shot throught the lung by William Adams was Peter James, and the burglar who was shot through the stomach was John Jenkins. Their bicycle business was conducted under the firm name of Peter James & Co. Charles Jenkins was known in the neighborhood as the moneyed man of the firm.

Sheriff Johnson, of White Plains has idenitified the burglar who was shot through the stomach as Dick Burns, a noted criminal, whose picture is in the Rogues' Gallery in N. Y. city, and who served a term in prison for killing a guest. sheriff in Missouri several years ago.

It was thought last night that this burglar would not live until morning. The other burglar was slightly better.

Of such acts is the building of a pagoda to the memory of the holy Gautama Buddha. Hence it is that Burmah is the land of pagodas. From the summit of every mountain, of every hill or hillock, from above the cliffs and rocks, and from among the woods of the islands of the broad Irrawaddy, rise the graceful forms and gilded pinnacles of umberless pagodas. Often they are crowned by a golden tree or umbrella.

Pagodas are rarely temples in the true ense; they are usually solid tapering buildings placed over real or imitation relics. Close by, among groves of palms and bananas, are generally to be seen the carved and seven-storied roofs of the Kioungs or Buddhist monasteries. Gay and light-hearted as are the Burmans, they realize another and future existence as vividly as they do the present life, and the teachings of the great Buddha are ever present to their minds, and influence them profoundly. In the Buddhist religion there is no God and no priesthood; but all men are given the opportunity of following the great example, by retiring from the world in to monasteries, renouncing the temptations of the flesh and the devil, and living an austere, self-denying life, en gaged in contemplation, devotion, and teaching.—Cornhill Magazine.

A Strange Spring.

A ROLLING STEAMBOAT.

Its Designer Expects It to Attain a Speed of Sixty Miles an Hour.

The State Department at Washington is in receipt of a consular re-port on the new rolling steamboat designed by the French marine engineer Bazin, which is attracting the attention of prominent experts in the shipbuilding line. By this marked innovation in marine architecture a speed of about sixty miles an hour is promised, which closely approximates that made by the fastest express trains on the Continent.

The rolling boat, as its name indicates, will not slide, as is the case with ships now in existence, but will roll on the water by means of huge hollow wheels or rollers. The vessel consists of a large platform, holding the boilers, machinery, saloons, cabins, etc., which is supported on each side by movable hollow wheels. The power is used partly to propel the whole by means of screws or paddle wheels, but principally to propel the rollers. Mr. Bazin claims to get rid of water friction and resistance and with a minimum of expense and power to attain a 50-knot ragidity. The result which he has obtained with a model about four feet long on the lake at Vincennes has encouraged him to undertake experiments on a much g ter scale, and he now has under construction at the St. Denis dockyard a rolling boat of 280 tons displacement, to be driven by 750 horse power, which will be utilized by a screw and three pairs of side rollers, each about thirty-three feet in diameter. This boat will make its first trial trip in a few weeks on the Seine, thence across the channel and up the Thames to London.

On the Safe Side.

RYDE, Isle of Wight, Aug. 21.—The memorial services here this afternoon, held as a tribute of respect to the late Baron von Zedwitz, the German diplomat who was killed on Tuesday as the result of a collision between his yacht Isolde and Emperor William's yacht Meteor, were attended by representatives of the queen, the Prince of Wales, all the yacht clubs and a large number of distinguished yachtsmen.

Mrs. Snell Renounces Her Claims.

SAN FRANCISCO, Aug. 21.—Mrs. Hulda Snell has renounced her claims to the millions of the late Andrew J. Davis of Butte, Mon. Mrs. Snell claimed to be the wife of the millionaire. Detective Stillwell has been working on the case in Mrs. Snell's interest and has learned that there were two men named A. J. Davis and she was the wife of the poor one.

A Half Breed Lynched.

LEWISTON, Ida., Aug. 21.—Frank Biles, a half breed Indian from the Nez Perce reservation, was taken from the Asotin jail and hanged by a mob of indignant citizens. His crime was assaulting Miss Mary Richardson, a young woman 17 years of age. Miss Richardson, whose home is in Enterprise, Or., was in delicate health at the time.

A Singular Double Fatality.

A Sensational Chicago Rumor Printed In a New York Paper.

A PLAN OF MIDDLE ROADERS

A Quiet Day For the Democratic Candidate In Upper Red Hook-One Opinion of Fusion In Missouri-The Third Ticket Movement.

NEW YORK, Aug. 22.—The Evening Post prints the following special dispatch from its Chicago correspondent:

Prominent Populists here say that if Bryan fails to accept their nomination another convention may be held, or a candidate may be named by a national commit-tee. After the Populist convention the middle of the road delegates selected a provisional national committee to decide upon a course of action should Bryan refuse their nomination. Henry F. Call, formerly of Kansas, but now of New York, was chosen chairman, and that the committee is about to take some action seems likely from the fact that a Chicago Populist has received a letter from Mr. Call, in which he requests the names and addresses of prominent Populists who were opposed to the nomination of Bryan and would be in favor of substituting another candidate in his place. It also asked information as to the probable result of such action on the part of the middle of the road Populists. Chicago Populists of the middle of the road tendencies believe that Candidate Watson is in sympathy with the movement and his recent attacks on Bryan were made in anticipation of such course. Seymour F. Norton of Illinois, who was a candidate opposed to Bryan at St. Louis, is said to have been approached on the subject. He has given no sign, but it is rumored that he is willing to accept.

Altgeld and Hinrichsen have told him

that he can have the nomination for auditor on the Illinois Bryan Democratic ticket, but he declined it, and his friends say that the reason may be found in his belief that Bryan would withdraw or be removed from the Populistic ticket. Should Norton or some other man be nominated it is believed that the western Populists would remain with Bryan and Sewall, while the southern and eastern members of the party would support Norton and Watson. Watson would lose nothing by this, as the Populists of the west will vote for Bryan and Sewall electors in any

The Third Ticket Movement.

INDIANAPOLIS, Aug. 22. — The correspondence of the executive committee of the gold standard Democrats has grown to enormous proportions within the past week, and the indications for a large gathering at the convention of Sept. 2 continue to grow. Chairman Bynum and his co-workers are confident that not less than 38 states will be represented by full delegations and believe that the convention is likely to draw a crowd of from 5,000 to 10,000 persons. There was much gratification expressed over the showing made by the National Democrats in New York and the calling of the New York convention for Aug. 31. They are watching with much interest the state convention in Ken-

The executive committee will hold its next full meeting at the Grand hotel in this city on Monday before the convention, and the national committee will meet at the same hotel the next day to make up the temporary convention roll. While the appointment of temporary officers of the convention will be made by the national committee at its full meeting, the executive committee will probably recommend such officers, and there is talk of appointing Bourke Cockran as either temporary

It was arranged by correspondence yesterday that both Maryland and South Carolina should send full delegations, and Mr. Bynum now believes that the only states not represented in the convention will be Idaho, Utah and Nevada and possibly Wyoming, though there are some prospects of the last named sending delegates.

Idaho Agreement For Fusion.

Boise City, Aug. 22.—The Democrats and Populists have agreed upon a basis of fusion, and all that now remains is for the Democratic convention to ratify officially the agreement arrived at. The nominations will be distributed as follows:

To the Democrats, presidential elect-

ors, supreme court justices, governor, attorney general, treasurer, mine inspector; to the Populists, the legislature, senator, congressman, lieutenant governor, secretary of state, state auditor, superintendent

of public instruction.

The fusion idea was fought bitterly by the middle of the road men, who had the hearty support of Dubois and the other Republican bolters. The serious bone of contention was the senatorship, and the Duboisites several times came near dis-rupting all the prearranged plans and stampeding the conference. The result of the prolonged conference has been to im-

bitter many of those who fought the fusion with such dogged determination.

Among these is J. H. Hawley, a candidate for senator. When he learned that the Democrats had agreed to give the Populists the senator, he declared publicly that he would take the stump against the entire arrangement.

The convention will meet tomorrow and commence the work of nominating the combination ticket. In this conference the Democrats have come off victors.

May Talk Politics In the Streets

INDIANAPOLIS, Aug. 22.—For ten days a great crowd had collected on the postoffice corner discussing the financial question of the present campaign. The discussion frequently lasted until midnight, and as fast as one speaker

wearied another filled the gap. The police made numerous and futile efforts to scatter the disputants, and finally made several arrests. Twice the cases came before Judge Cox of the city court, and the last time, with much impatience, he discharged the defendants, holding there was no decision by any court, high or low, where it is held that a man violates the law by discussing politics in the

"On the contrary," continued the court, "all of the decisions are the other way. The right of free speech is fundamental in our constitution and must not be denied. No police can stop it. It is the right of American citizens. This is a time when American citizens. This is a time when perplexing questions are puzzling the people. They are questions of vital importance to the common people. It is only by ample discussion of the questions that confront them that they can learn properly to exercise their right of franchise. They

have the right to discuss those questions, and the court will protect them."

Mr. Bryan's Quiet Day.

UPPER RED HOOK, N. Y., Aug. 22. Candidate Bryan laid out a quiet day for the next 24 hours. After he had worked all the morning on his letter of acceptance and his mails he spent the afternoon at a nearby fishing resort.

After reading the morning papers today he said that he had always believed that the state Democrats would be true to the party nominees. From Syracuse, Buffalo, Rochester and Albany, he said, he had re ceived assurances of the support of the county Democrats and notification that the arrangements in that locality are entirely in charge of the Democratic county committee. Mr. Bryan was shown a morn-ing paper which reported Mr. Croker's indorsement of the Chicago ticket. He said he was gratified to find so many eastern Democrats falling in line, and added that before the campaign closed he expected the co-operation of all Democrats except those whose pecuniary interest may be better advanced by the gold standard. It is said Dr. Jenkins of New York gave Mr. Bryan intimation that Mr. Croker would be with him.

Fusion In Missouri.

KANSAS CITY, Aug. 22.—The Times prints the following:

The prospects for fusion between the Democrats and the Populists in Missouri are very slim. At the recent meeting of the Democratic central committee Chairman Cook was instructed to see what the Populists desire. It would seem from his investigation that that particular wing of the party which is now in control of the state organization does not want to fuse, to compromise or do anything which will help the cause of free silver. Instead of patterning after the Populists of Kansas, they seem to belong to the Texas wing of the party. No reasonable proposition has yet come from the Populists' state central committee, and there seems to be no reason to believe that it ever intended for a mo ment to consent to anything within reason.

Nebraska Gold Democrats.

OMAHA, Aug. 22.—The gold Democrats of Nebraska have named a delegation to the Indianapolis convention. A conference of the state central committee and leading Democrats to the number of near ly 100 was held, presided over by Chairman Euclid Martin. Many speeches were made, most of which favored a third ticket and the naming of a state delegation to the national convention. It was the concensus of opinion that a third ticket in Nebraska was necessary, not only to aid in the regular party organization in this state after the issues of the present campaign shall have been decided at the polls. Ev ery delegate was pledged to vote for a gold standard candidate for president, but no preference was expressed

Perhaps No Third Ticket.

TAYLORVILLE, Ills., Aug. 22.—Senato. John M. Palmer says it looks now as though the gold standard Democratic convention would meet and adopt a platform and then adjourn without naming a ticket "In that event what will the so called sound money Democrats do—vote for Mc Kinley or not at all?" was asked.

NEW ORLEANS, Aug. 22.—The gold standard Democrats of New Orleans issued a call for a state convention of sound money Democrats to meet in this city or Thursday, Aug. 27, for the purpose of electing delegates to the Indianapolis con vention. The call is headed by United States Senator Caffery, and is signed by 60 of the leading Democrats of New Orleans. Gold standard Democrats in each parish of the state are requested to mee and elect delegates.

PHENIX, Aug. 22.—The territorial Pop ulist convention nominated W. O'Neil for delegate to congress and adjourned after making preparations for a vigorous cam paign. The platform, besides indorsing the national nominations and favoring free silver, declares for statehood for Arizons and reclamation of desert lands by govern mental aid and objects to the present ir rigation laws of the territory.

Democratic Fusion In California. IMPORTS AND EXPORTS

Former Have Fallen Off as Much as the Latter Have Increased.

EARLY COTTON MARKETING.

That and the Rapid Movement of Grain Tend to Aid the Foreign Exchange Syndicate_Money Withdrawals. Failures of the Week.

NEW YORK, Aug. 22.—R. G. Dun & Co.'s weekly review of trade says: Political events of the week had no definite influence upon business prospects, for the phenomenal variations in sterling exchange and the beginning of imports of gold, although following the great meet-ing in Madison Square Garden on Tuesday, may be fairly attributed to the accumulating excess of merchandise exports over imports, to which attention has been repeatedly called, exports from New York for the past two weeks having been 20 per cent larger and imports here 21 per cent smaller than last year. The rapid movement of grain and the unusually early marketing of cotton tend strongly to aid the banking syndicate which has undertaken to regulate foreign exchanges.

Withdrawals of money to the interior are rather large, and commercial loans are hard to place, and this difficulty checks many new enterprises and business in many departments. Want of confidence lies back of this restriction of loan, as may be inferred from the failure of offers of Boston and New York city bonds, but the immediate effect of the speculative failure at Chicago has passed, and the stock market has slighty advanced, railroad stocks an average of 21 cents per share, though trust stocks average 38 cents per share lower. There has been no considerable marketing of American securi-ties held abroad, and the indications are that London is more ready to buy than to sell. Bank clearings are small; for the week 15 per cent less than last year and 24 per cent less than in 1892. Railroad earnings are not as good as might be expected for the first half of August, exceeding those of last year by only 3.4 per cent, but falling 15.6 per cent behind those of 1892, although the east bound tonnage from Chicago for the same two weeks is larger than last year by 6 per cent and larger than in 1892, though slightly smaller than in 1894.

Wheat, Cotton and Corn.

Speculation has advanced wheat about cent during the week, corn a small fraction and cotton a quarter, the principal motive power being reports of injury to growing crops. As before the unfavorable accounts respecting wheat are in some measure discredited by the continued heavy movement from the farms, western receipts having been 10,697,137 bushels in two weeks against 6,759,363 bushels last year, With prices 8 cents lower than last year such a movement cannot be interpreted as a sign of deficient yield. The At lantic exports for the same weeks have been, flour included, 4,892,660 bushels against 2,995,233 last year, and while the increase is encouraging, it scarcely corre sponds with current accounts of deficient yield in some foreign countries. The movement of corn continues heavy, although the price is still so low that one wonders why the product is put into cars instead of into hogs. The alarm about destruction of cotton has been most vigorously worked here and abroad, and has readily raised the price, although it is yet to be seen whether the yield has been so far diminished as to warrant a price nearly a cent higher than a year ago.

The boot and shoe industry, which continues to lead all others in proportion of hands employed, is nevertheless rapidly nearing the end of past orders excepting in women's grain and buff shoes, of which there are still orders for some weeks to but in other branches the new business is light. Prices are a shade weaker, many dealers refusing to pay the advances which have been asked. The shipments Boston for three weeks have been 256,116 cases against 272,947 last year and 263,833 for the same weeks of 1894. Leather is weaker, with a small demand, although restricted supplies have caused a shade of advance in some kinds. Hides at Chicago averaged more than 3 per cent lower for the week again, the fall in the past five weeks having averaged about 25 per cent. Some additional heavy failures in the lumber trade call attention to the continuing depression which appears to result, at lesst in part, from expectations entertained by many that the unlimited increase in new buildings during the last year or two would be permanent.

Iron and Steel Industries.

The iron and steel manufacture has only continued depression to report. Bessemen pig has sold at \$10.40 at Pittsburg, while Southern No. 1 is offered at prices equiva-lent to \$10 at New York, and nearly all finished products are being sold below the current quotations. There is rapid cur-tailment of production, the Illinois Steel company having only 7 of its 17 furnaces at work, but in spite of this the sup-ply of finished products appears to greatly exceed the demand for them. The one bright spot is a sale of 9,000 tons steel rails to Japan, for refitting railways in that country, which makes an aggregate of 45,000 tons exported during the year. Nothing encouraging can yet be said regarding the woolen manufacture, and the demand for goods, even at recent reduc-tions in prices, is still disappointingly small. Sales of wool at the three chief markets have been only 7,670,000 in three weeks against 16,847,200 last year and 23,361,400 in the same weeks of 1892. A heavy auction sale of cotton goods brought prices which were considered quite encouraging, and the current demand is fairly maintained, although the mills are not inclined to make large contracts for the future in view of the rise in the raw material. In general the working force in the textile branches does not appear to have increased.

Failures for the week have been 280 in the United States against 222 last year, and 27 in Canada against 43 last year.

CHRISTIANIA, Aug. 22.—Professor S. A. Vitrified Brick Paving.

In Washington vitrified brick as pavement in the publicly traveled streets and avenues have been thoroughly tested and found to stand the wear and tear of the iron tires of carriages and heavy trucks, even better that granite blocks.

In New Haven a particularly severe test has been given these vitrified bricks as a paving material near to; the outside and between the iron rails of their street car tracks. At the corner of Chapel and State streets in the latter city, these brick payings have been down for three years and are found to be tougher and firmer of fibre than are stone blocks. They are a specially hard and tenacious material, not given either to chipping off or crumbling, as in the case of Belgian blocks or other stone paving.

If our city authorities will permit the street railway companies to thus pave their tracks through Wall street, we are confident, from our personal inspection of the above narrated cases, that they will have no cause to regret their action. The Street Railway Company is ready and anxious to do this and as they would have to replace them in event of failure, it is difficult to see why they are not permitted to go ahead and improve the dangerous condition of this conspicuous discredit to our city, without any further delay.

The True God.

Most people, brought up on puritanical traditions and red on the dry husks of dead creeds, have a strange idea of God. They look upen Him as a stern and unyielding tyrant whom they must besiege with prayers and groanings and self-abasement, and even then run the risk of being damned. They robe Him in the imperial purple of a Nero, and build Him a throne of human skulls.

They have made a God of their own evil natures, and crimsoned His hands with the blood of the innocent and helpless. They see Him in the flash of the deadly lightning, but never in the aew that moistens the lips of some dying flower. They view Him in the storm and tempest, but never in the cool night nestling down in mercy over the fainting earth. He is plain to them in the tornado that blots a town out of existence, but never in the kindly rain that spreads a wave of rippling laughter over the world in the white blessing of the harvest that leaps up jubilantly from the soil. They hear Him in the awful thunder roll, but never in the royal song of some tiny bird hidden in the roses of their own home. He is present to them in the earthquake, but never in the rainbow's glory spanning the heavens with a bridge of joy. They hear Him in the wail of sorrow and despair, but never in the song of rejoicing and happiness that goes up to the smiling stars. And they worship Him, not in the spirit of love or in goodness,

but in that of fear. God is not a tyrant. The eternal goodness is manifest in everything that is; in the hipiness that makes life so sweet; in the affliction that turns the soul from its downward course and makes it white for the beautiful fields of heaven. It is a goodness that is as eternal as God is eternal; it is a goodness that is as plain as the glorious sun of noonday to those whose eyes have been opened by the eternal hand so that they no longer see as through a glass darkly.

God is good. He takes no pleasure in the Jeath of the wicked, but in a million ways shows them His goodness, that they may take it as a lamp for their feet, a light that will never fail, a guide whose feet never go astray. Sometimes, when all else fails, He shows them His power, crushing them down in their sins until the very earth reels in agony and the stars grow dim; and then, if they repent and throw off the chains of vice and sin, He lifts them up until they

can see the great river of His peace and hear its gentle waves singing upon the sunlit strand.

The eternal goodness is in the earth as well as in the sky. It speaks in every flower that lifts up its head to greet the wayfarer passing by, and it is seen in every star that guides the traveler through the mazes of the night. It is heard in every song that floats upward and dies away beyond the heights that no human feet may scale; it is seen in every blade of grass that is some happy insect's swinging home.

The eternal goodness is with us every where, and spreads its soft mantle of hope and peace over every heart that aches, if that heart but understands and acknowledges the goodness of the one eternal God. It is thrown around us even when we wander far away from the safe, strong fold, and it takes us back there if we but ask for its kindly aid. God is good, and no soul need lose its heritage if it but kneels down in earnest faith and prayer. The crippled wings shall be healed and it shall gain the upper sphere.

AMERICAN SNUFF. TAKERS.

Every year the snuff-taking citizens of the United States deliberately pay for and throw away \$1,750,000 worth of snuff. How is this? Well, in 1895 the total production of snuff in this country amounted to 11,705,414 pounds, valued at about 60 cents a pound, and when a man takes a pinch of snuff he wastes at ing to his fingers. It is the most extravagant, wasteful way of using tobacco known.

About three ounces of snuff per capita are manufactured annually in this country. Nearly all of it is made by one company in New Jersey and another in Pennsylvania, the two turning out 600,000 pounds a month. The users are Catholics priests, Italian and German music teachers, some of whom have a vest pocket lined with leather, and carry the snuff loose in this with a tiny horn spoon to convey it to their nose; the Swedes, Norwegians, and Scandinavians of the Michigan lumber forests and the West generally; pianomakers to a man, and women in the large cities, who "dip" it as is done in the South, where there is a great demand for snuff.

In Arkansas about every native, with his trousers in his boots, sleeves rolled up, and shirt bosom open, carries a hardwood stick and snuff loose in a pocket. He wets the stick, dips it into the snuff, rubs one gum, dips again, and rubs the other, and goes through life with a brown dusty halo around his lips. The Virginian mountaineers originated this practice. It spread through the South, struck Texas, and is reaching up into the lumber districts among the Scandinavians.-New York Sun.

A QUEEN IS WANTED.

KING ALEXANDER OF SERVIA HUNT-ING FOR A RICH WIFE.

A Good Chance for Some Foolish American Heiress to Sell Herself and Get the Servian Throne and Its Appur-

What American girl wishes to become a real queen?

The only requisite is millions. The boy king Alexander of Servia needs ready money very badly, and he has decided that an American heiress

will solve all the troubles of his bankrupt kingdom. A throne is, therefore, awaiting any American girl who has sufficient wealth

to meet the requirements. This is probably the first time in American history that such an opportunity has ever been

Along with the distinguished title of queen goes a palace, a crown, a collection of royal jewelry of stupendous antiquity and a number of castles scattered throughout Servia.

Servia is one of the kingdoms that sprung up out of the ruins of the Roman empire. The people are Slavonic, with some slight traces of the Roman influence. For centuries it was strong and independent, and then the great power of the Turkish empire forcing its way into Eastern Europe overwhelmed it. From the fourteenth century it was a Turkish province, and only at the end of the last century did it begin to assert its independence.

But the national spirit was never crushed. There was always an hereditary chief and a nobility, rough, but without the faults of a similar class in richer countries. A more interesting nationality could hardly be found in

The king has great personal power, is Commander in Chief of the Servian Army, and supervises the acts of the national Legislature. His queen would share to a great extent in many of his

She would be mistress of a large palace in the capital, Belgrade; of the castle of Topschider, and a splendid park near the capital, and of many other residences. She would have a great suite of ladies of the bedchamber, courtiers and chamberlains at her disposal, for although Servia is poor, there is no lack of officials with high-sounding titles.

She would receive at her court the homage of noblemen who held their feudal estates before William the Conqueror entered England, even before the Eastern Empire had gone to ruin, and the philosophers of Greece had ceased to teach.

It is also probable that she would have to become a member of the Greek Orthodox Church.

Ex-King Milan, father of the young monarch, will come to America himself to conduct the negotiations for the securing of an American bride for his hopeful.—New York Journal.

NORDICA'S TIARA.

A Hundred Friends Give Her a Beautiful Present.

Mme. Nordica was the brilliant star of the performance of "Lohengrin" at the Metropolitan Opera House not long ago, when she was crowned with a fivethousand-dollar tiara of diamonds pre sented by her admirers in swell society in this city.

The presentation was made with marked simplicity, after the tumultu-ous applause of the first act. The curtain rose to the echoing shouts of the audience, and wreath after wreath was thrown to the handsome singer, who appeared hand in hand with Jean de

Those in the front rows had seen a large basket of beautiful roses standing behind Conductor Seidl's chair. This he lifted when the hearty hand clapping had somewhat subsided, and Mme. Nordica stepped forward with a smile to accept it.

Jean de Reszke thrust his hand into the basket and drew forth a large blue plush jewel case and handed it to Mme. Nordica, and she opened it and showed 233 diamonds glittering in their plati-num setting. As soon as they caught sight of the brilliant treasure the spectators renewed their plaudits, and the curtain was lowered. It was raised once more, and Nordica appeared

crowned with the beautiful tiara. Attached to the basket was a large envelope containing an address to Mme. Nordica, signed by 128 donors.

BILLIONS OF GOLD IN UTAH. Deposit of the Precious Metal Said to Cover 150 Square Miles.

Reports received from mining experts sent to investigate the alleged important discoveries of gold in a district about 40 miles south of Salt Lake City shows that there is an enormous amount of gold there. The district as a whole will probably rival South Africa within the next year or so in gold product, and those who are well informed say that as

soon as the snow is off the ground there will probably be a rush to that district greatly exceeding that which followed the Cripple Creek discoveries in Colora-do, and greater than that which is now being directed to Alaska.

The geological formation in the Utah district is almost exactly similar to that of the Johannesburg district in South Africa. A shaft recently sunk for 1,000 feet showed that, exactly as is the case with South Africa, the one became richer and richer as the depth of the shaft became greater and greater.

But, like the South African ore, it

was not of a kind which could profitably be handled excepting by the new cyanide process. That makes it possi-ble to mine gold averaging not more than \$4 a ton.

There is some difference of opinion as to the formation of the ore body in the Utah district, some of the experts thinking that it runs very much like a coal vein, while others incline to the single blanket theory. But there is no difference as to the enormity of the wealth in this district.

The estimate was made upon one of the mines that it has within its control \$500,000,000 of gold, and the opinion of the experts and miners is that no such gold mining district has ever been developed in the world as this tract, only an hour's ride south of Salt Lake City will be found to be. The impression is that the deposits cover an area of about 150 square miles, and that, like the mines of the Johannesburg district in South Africa, the deposits will be found to be richer and richer and richer as the mines go deeper and deeper.

It is the discovery of the cyanide process that makes the development of this mining district possible. The stamping mill or the smelting process would be too expensive, as it would in South Africa.

An expert who has no personal interest in any of the mines said the other day that in two years, he was satisfied the Mercur district of Utah would devide with Johannesburg the interest of the gold miners and bankers of the world.

Of course, it is easy to see that if in Utah, a district of 150 square miles is capable of producing wealth of sixty to seventy millions of dollar a year in gold, as these experts assert, it will be only a few years that the political relation of silver will be very different from what it is in that State at the present time.-P.i.adelphia Press.

HE IS A PROPHET.

Picks Out Coming Presidents, but Doesn't Know How He Does It.

While statesmen of the different parties are wondering who will be the next to sit in the Presidential chair, there is in Washington a man who has foretold the election of three Presidents, and now asserts that he knows who is to be the successor of Mr. Cleveland.

This man is Dr. Keyser, a physician and spiritualist of note. Keyser is a man of middle life. He lives in comfortable style, and there is in his conversation nothing of the visionary,

He has held frequent communications with spirits. Among his papers are photographs alleged to be of his dead children, who came back to him, and whose bodies were photographed by an ordinary camera.

When questioned as to the truth of the fact that spirits had communicated to him the name of our next President, he did not deny the fact, but asserted that the story was true."

"I cannot explain just exactly how the presentiment is made known to me," he answered. "But it is by a method of communication of the mind with the spirit world. We on the earth plane are surrounded at all times by spirits, and those who are dead are still al about us.

"Weeks before the convention met at which Garfield was named I predicted the event, though Grant and Blaine stood in the way of it, as every one thought. Garfield was not heard of in the way of a candidate. Yet I knew it was to be Garfield. WERE CRAZYTO GIVE.

\$101,500 RAISED FOR HEATHENS IN A MEETING AT OLD ORCHARD.

Remarkable Session of the Christian Alliance Convention. A Crowd of 10,000 Swept Away by Emotion. Gifts of Money, Stocks and Bonds Poured Out.

The year 1896 is noted for its emo tional conventions. Mr. Bryan held the Chicago convention by the power of his oratory, and as wonderful, or more so, was the emotional qualities displayed by a camp meeting at Old Orchard, Maine. The occasion was Mission day of the Christian Alliance Convention.

The total received was \$101,500, the largest amount subscribed in a single service for the work. The money has literally poured down like the rain.

The stately pines and towering beeches of the Old Orchard camp ground, a veritable tabernacle of nature, have looked upon many remarkable gatherings. They have heard the patriotic utterances of Hannibal Hamlin in the times of political peril; they have listened to the eloquence of James A. Garfield; they have seen John B. Gough hold a great audience spellbound; they have looked down and beheld crowds go mad over the utterances of Maine's two idols, dead and living, Blaine and Reed; they have scattered with the breezes of heaven the echoes of songs sung by thousands, thrilled by the preaching of a Beecher or a Phillips Brooks, but never in their long years have they been silent witnesses of a more remarkable scene than that which was enacted to-day. When Dr. Simpson arose to make his appeal he faced a crowd of at least 10.000 people. It was an audience made up from every walk and condition of life, and an audience that sat for hours hanging on the words of the exhorters, laughing or weeping at the will of speakers, shouting allelujahs, and showing by the workings of the countenances the earnestness of their interest in the services. It was an audience that was finally to lose all control of itself in the fervor of its faith, and in the end was to contribute, under the influence of what a layman would call a religious-evangelistic hysteria, and in sums ranging from a nickel to \$25,-000, the sum of \$101,500. Dr. Simpson's sermon was brief. His theme was that all are debtors to Christ, and can never liquidate till they have given everything and done everything

possible. He said: "We must sacrificate; do what hurts. God loves what hurts, because it smells of the sweet odor of Calvary. I must solemnly lay the command of Christ upon you, 'Go ye.' What will ye do about it?"

The first subscription was \$1, and it was given by Mrs. F. E. Morrow, who said she had gone without her supper and breakfast, and now was going without her dinner to give this.

Then came a man who said he started from Springfield with only a dollar. He had got here somehow. He gave his last 50 cents last night. He had since earned \$2, and he gave that. He said he left a wife and children in Springfield. They hadn't any money, but had enough to last them till the next night; then the Lord would pro-

The next donation was \$25,000. From this point the money simply rained down. It came in bills, in gold, in silver, in checks, in bonds, in stocks, and n pledges. The monster gift came from a man in New York, who telegraped 10,000 shares of stock worth \$5 per share, but for which he would give his check for \$25,000. His name is not to be had. Mr. Lelacheur said they needed two house boats for the work in China. They cost \$250 each.

Then the missionary on the Congo needed two steam launches at \$25,000 each. J. R. Libby, a merchant of Portland, promptly provided means for one, and the other was quickly taken care of.

Then a missionary named Creamer made an impassioned appeal, crying out: "You cannot hold up jewelled hands with gold and silver and have them clean before God. There's blood on them! Take them off; take them off! Give them to the Lord; they are for His work."

BEDFORD'S BURGLARY.

Postmaster Adams Has Finally Succumbed to His Wounds.

THE MYSTERIOUS SUSPECT.

Probably Not One of the Guilty Men, but Police of Brooklyn Are Watching Him Nevertheless - Young Adams Hero of the Hour.

NEW YORK, Aug. 22.—The unknown man who is now suffering from a bullet wound in the Long Island College hospital, Brooklyn, and is suspected of being one of the three burglars who fought at New Bedford with the Adamses, is under arrest there, still unidentified with the transaction. He was in an excited mental transaction. He was in an excited mental state today, the doctors say, due to the intense nervous strain he has suffered and to the effects of the anæsthetics administered to him, that would not be conducive to a rational statement. Nevertheless he knows enough of what is going on to re-fuse to answer questions and to curse the

policemen who are there guarding him.

The wound in the man's left arm is a severe one. Dr. Campbell of the hospital and Deputy Police Superintendent Mackellar examined it together and say that there is no doubt whatever that the wound was made, not by shot, but by a large bul-let. The injury was inflicted on the up-per left arm, and the laceration of the flesh and the injury to the bone are so extensive that they could not tell with certainty whether the ball came from a rifle or a pis-

Dr. Campbell feared at first that it might be necessary to cut the man's arm off just below the shoulder, but the surgeons decided to try to save it by extracting the shattered pieces of bone. They administered ether and chloroform and went to work. They took out three large sections of bone tissue and are not certain that they got all the splinters out at that.

Deputy Police Superintendent Mackellar

sent a dispatch to Will Adams, at Bedford, asking him if the man in question was the third burglar, who escaped. Mr. Mackellar sent an accurate description. The prisoner is fully 55 years old. His hair is slightly gray, and he is clean shaven. He wears a dark blue serge suit, with vest, light fedora hat, outing shirt and new necktie.

Probably Not the Man.

Deputy Superintendent Mackellar received from Mr. Adams a dispatch that

read, "Not the man; too old."

"I am inclined to believe that Mr.
Adams' judgment is correct," said Mr.
Mackellar. "He ought to know. He had the third man a prisoner for some time and had a good chance of seeing him close-But it is certain that some disreputaly. But it is certain that some ble transaction is back of this man's injury and his appearance at the hospital. I do not say that he has been guilty of any-thing, but either that or he is trying to

shield somebody."

The man appeared at the hospital alone about 8 o'clock last night. He pretended not to be very badly hurt. He said he wanted a little wound dressed. He asked that it be done at once, as he was in a

hurry to get away.
"A little wound!" exclaimed Dr. Campbell as he looked at it. "Why, man, it will take three hours to fix that up! It's a wonder you didn't bleed to death. We will have to give you anæsthettes, and you will have to stay here several days."
"I can't do that," said the man nerv-

"I can't do that," said the man nervously. "I must get away in a few minutes. Hurry up."

Replying to questions, he said his name was Bell; that he was a New York city photographer, and that he was shot in Long Branch. He was fooling with a friend there who had a pistol, he said, and the weapon accidentally went off. "I walked all the way from Long Branch," Beyond this the man would say noth-

ing. Dr. Campbell's suspicions were aroused. He telephoned to Mr. Mackellar, who at once connected the man with the Bedford affair. This suspicion he considered was confirmed by the fact that a time table of the N. Y., N. H. and H. rail-road was found in his pocket. Among his effects also were a bottle of laudanum and a handkerchief with blood spots on it.

Mr. Mackellar at once hurried two policemen to the scene. They were slipped into the operating room, and when the man was led there to be operated upon he saw them for the first time. At sight of them, it is said, he started back. Then he was told that he was under arrest. He denounced the proceeding as outrageous, cursed the officers and applied some vile epithets to Mr. Mackellar.

None of the injured man's friends had been to call on him today. The detective department has been unable to identify him as a criminal. Chief Detective Sergeant James Reynolds will take a look at him and endeavor to do so.

Dr. Campbell says the man has wonderful grit. Not one man in a thousand, he says, would have endured all the suffering he must have undergone from the wound. He objected to taking anæsthetics. He said he wanted to see the operation performed and insisted that he could stand it without flinching. His muscles are as hard as steel. He is a man about 5 feet 9 inches and weighs about 150 pounds.

Mr. Walker B. Adams died early this

morning. He never regained consciousness after he was struck by the bullet from the burglar's pistol. Both the captured burglars are dying in the Mount Kisco jail. So far they have refused to make an antemortem statement. One of them has received the ministrations of a priest, but the other only asks to be left alone and to get free from his pain.

Several arrests have been made, but the prisoners have not as yet been identified as men who had any connection with the at-

tempted burglary. It is thought that the prisoners belong to a gang of postoffice robbers who have been exceedingly successful in their crimes in the last few years. If this be so, the gang is pretty thoroughly broken up.

Nothing but praise is heard for the con-

duct of young Adams. He displayed the highest kind of nerve, courage and skill. Bedford Station will never again be a popular stopping place for burglars.

Two detectives from police headquarters

in this city went up to Mount Kisco today to look at the captured burglars.

A Burglar In Hard Luck.

F NEW YORK, Aug. 22.—A burglar got into the office building at 182 Grand street, and after prying open an iron safe and ruminaging through dozens of drawers and closets of the Prudential Insurance com-

pany secured only a 50 cent piece.

The burglary was discovered when the office was thrown open. The insurance company's offices are on the seventh floor. The small safe in which it kept the private

open with burglar tools. Nothing in money had been found to take away. This fallure probably enraged the burglar, who then searched every drawer and closet in the company's rooms. He scattered the papers about, seemingly getting angrier at finding nothing of value. At last he came across a 50 cent piece which an old woman had paid on two policies late the night be-fore, and which had been put in the cash

A BIG OIL DEAL

The Cudahys Said to Be About to Establish a Pipe Line to Chicago.

CHICAGO, Aug. 22.—The Times-Herald says today: "Michael and John Cudahy, wealthy packers of this city, have entered wealthy packers of this city, have entered into a large oil deal. If their present plans materialize, Chicago is to have a new industry, a rival of the great plant of the Standard Oil company at Whiting, and the first pipe line from the oilfields to enter its limits. The Cuhahys have purchased in Wells and Adams counties, Ind., the entire plant and wells of the Northern Indiana Oil company. What price was paid is not known, but the purchase was made more than a year ago, and the fact has only just leaked out in the commercial has only just leaked out in the commercial circles of the city. Following this purchase they have this week placed with the National Tube and Pipe company of Pittsburg a \$500,000 order for six inch oil pipes. How big the order is may be appreciated when it is known that it covers pipes for an underground oil line 170 miles in length and extending from the ciffelds to Chi-cago. With the tankage which they will erect in Indiana and the refining plant and tanks needed at the Chicago end, it is estimated that their investment, from the original purchase price, will represent \$1,500,000."

NICE SOLDIERS THESE.

They Fight In a Railroad Train and Make All Kinds of Trouble.

CHICACO, Aug. 22.—Twenty-five police men were sent to the Union depot at the call of the Fort Wayne railroad to meet an incoming train bearing a carload of drunken and riotous privates of the United States army. The conductor of the train had telegraphed ahead for assistance to prevent loss of life and to protect the railroad property, but by the time the train reached Chicago the rioting had ceased.

Twenty-eight private soliders without a commissioned officer were on their way from the Columbus barracks to various forts throughout the west. While passing through Indiana a fight was started be-tween Privates Hayes and Karpp. A general riot followed, in which four men were cut more or less seriously and a number of the car windows broken. Karpp had one of his fingers broken. All but three or four of the soldiers were drunk.

The conductor became frightened and telegraphed ahead for police assistance. At the station here the men were quiet, and as the railroad officers were willing to let them go the police took no action.

Lord Russell's Speech Commended.

LONDON, Aug. 22.—The afternoon news-papers all praise the address of Baron Russell of Killowen, the lord chief justice, to the American Bar association at Sara toga vesterday. The Pall Mall Gazette says: We know that behind the sentiments of Lord Russell are the sentiments of the whole of one nation and behind the enthusiastic cheers of his audience the whole of another."

Prison Revelations Promised. nor's Sun today publishes a column sensational account of the condition of John Daly, the Irish political prisoner who was released from Portland prison yesterday. It says: "Daly will be able to prove that the Irish dynamiters have been subjected to indignities and punishment that the vilest criminals in her majesty's prisons

have escaped." Marocco In Turmoil.

LONDON, Aug. 22.—A dispatch from Tangier says that a plot has been discovered at Marash aiming at the dethronement of the sultan of Marocco, Mulai-Abd-el-Aziz, in favor of his elder brother, Muley Mohammed. Four provincial govrnors have been murdered by the plotters. Wholesale arrests have been made and a general state of terror prevails.

Killed an Escaped Prisoner.

DEADWOOD, S. D., Aug. 22.—Ray Sewell was shot and killed at Sturgis by Fred Willard. Sewell was under indictment for cattle stealing and broke jail. Willard killed him in an attempt to recapture him. The coroner's jury exonerated Willard.

MONEY TO SUBDUE CUBA.

The Senate Votes Extraordinary Supplies

MADRID, Aug. 22.—The senate has adopted the extraordinary budget as recommended by General Azcarraga, minister of war; Admiral Beranger, minister of marine, and Senor A. Bosch, minister of public works.

The Liberal deputies declare that this is of the nature of a surprise vote, and that they will therefore work with increasing energy and activity for the defeat of the government's money raising proposition in the chamber of deputies.

Aug. 8 the extraordinary budget caused an animated discussion in the chamber of deputies. Premier Canovas explained that the extraordinary budget was necessary, the insurrection in Cuba, which had spread over the entire island, preventing the people there from contributing their share toward the expenses of government.

He explained that the government already had been authorized to borrow 500,-000,000 pesetas (\$100,000,000), but to ap ply to the Bank of Spain for such a loan he said, would make the fiduciary circula tion enormous.

Senor Moret criticised the government' scheme as dangerous. He believed that it would be better to borrow the money than to tax the people at the present time. Spanish newspapers during the past week have estimated that the Cuban war is costing the government at least \$300,

THE MOORE FAILURE. The Chicago Stock Exchange Not to Be

Opened For Awhile Yet. CHICAGO, Aug. 22.—A meeting of a number of Stock Exchange brokers interested in the Moore Bros. deals was held. The special committee appointed by the governing committee made a partial re-port to the effect that there was a pool back of the Moores in the deal in the Dia-mond Match and New York Biscuit stocks. Attorneys for the special committee expressed the opinion that members of the pool can be held responsible for carrying out all the Moore contracts. At the meeting the matter was carefully

discussed, and while no decision wa reached the general opinion seemed to be that there was no way to force the members of the alleged pool to come to the front. The special committee was not ready to make a detailed report. The consensus of opinion seemed to be that while the reopening of the Stock Exchange is extremely desirable, the only wise thing to do is to keep it closed until general confidence has been fully restored and business has readjusted itself on a normal Those present at the meeting be lieved that a settlement on an equitable basis will be arrived at before long.

Band of Outlaws Eroken Up.

BRISTOL, Tenn., Aug. 22.—A party of 26 revenue officers, representing all parts of Virginia, went to Franklin county to break up the most noted band of outlaws and illicit distillers in the state. By arti fice they succeeded in capturing 12 of the outlaws without bloodshed, and they destroyed several stills. Among the captured were Calvin Moore, the Martin brothers and the Atkins brothers, the leading spirits of the gang.

Swiss Jurists to Arbitrate.

BERN, Aug. 22.—At the request of the governments of Great Britain and the United States of Colombia the government of Switzerland has appointed three Swiss jurists to arbitrate the difference arising out of a disputed railroad conces sion in the republic of Colombia. The concession is claimed by a British subject, whose contention is disputed by the Colombian authorities.

An American Ship Lost.

BATAVIA, Island of Java, Aug. 22,— The American ship Governor Goodwin Captain Oakes, which sailed from New York on April 29 for Chefu, and which was spoken in latitude 2 degrees north and longitude 29 degrees west, has been lost on Princess island.

A Fatal Dynamite Explosion.

PARRY SOUND, Ont., Aug. 22.-While a number of men were blasting in a rock cut near here a heavy charge of dynamite exploded prematurely. Two of the men, Smith and Hillman, were instantly killed. John Olsen was fatally injured, while others of the gang were seriously hurt.
