St. Mary's Church.

A Hearty Welcome Extended Him.

The new rector of St. Mary's church, Rev. Father J. J. Furlong officiated for the first time at the 10.30 a. m. services in that church, yesterday.


He preached an eloquent sermon to a large congregation, at the cenclusion of which he introduced himself as rector of the Parish by appointment of Bishop Tierney. He took occasion to compliment the

society on its prosperity and for being free of all debt. He said that during his two days stay here the thought suggested itself to him as to what there remained for him to do, as his predecessors and the people had seemingly done everything. He promised, however, to devote his energies to the spiritual welfare of the people, and if ever occasion arose would also work faithfully for the temporal needs of the church.

He said that he proposed remaining in charge of the church as long as his life was spared.

The reverend Father created a good impression with his hearers and was accorded a hearty welcome.

He is evidently a man who will gain and retain the friendship of all, and the GAZETTE extends to him a most cordial



Father Furlong comes to Norwalk kin pay me for the good, honest likker from Rockville, and prior to his departure the Rockville Journal contained the following complimentary notice:

"The news that Father Furlong is to leave Rockville will be received with sincere regret by the members of his parish; that after a rectorship of almost twenty-three years he is to leave St. Bernard's Church seems hardly creditable, yet such is the fact. Father Furlong has been transferred by Bishop Tierney to St. Mary's church, in Norwalk. Fully as keenly as his parishioners feel his departure, must be the rector's regret to break the ties of love he has learned to cherish for those he has been laboring among so long. He will be missed not alone in his church, but in the city as well. For as his church people had learned to love him, so the residents of the city had learned to respect and esteem him for his noble traits of character and constancy in his faith.

Yet in going it will be gratifying to his parishioners to know that he is gaining a promotion. The Norwalk church is one of the consecrated Catholic edifices of the state. It is free from debt and is not allowed to contract new debts. He will have a permanent rectorship and cannot be transferred by the bishop. In case of the death of the bishop he will, by reason of this permanent rectorship, be one of those elligible to vote on his successor. There he has two assistants and consequently his duties will be lightened. The parish here has grown so that it is necessary to have more services than would otherwise be necessary if the Catholics has a larger church building. And this will be one of the things to be attained by the new rector. A larger building will undoubtedly be erected at some future date. This Father Furlong has been considering for some time but it will remain for his successor to bring the matter to a culmination. There are now about 3,000 souls in the parish, which has surely outgrown its

present church accomodations. One of the plans suggested is the removal of the rectory to the west end of the church lot and erect a handsome granite church building in its place. Also to move the present church building to School street and erect a convent on that site. This would be the rectory, church and convent in ro-

tation, facing the same street.

Father Furlong has seen grea changes in St. Bernard's parish since his first Sabbath here. The church has been enlarged, a beautiful Parochial school building has been erected and many other improvements made. The cemetery has been fenced, an addition of six acres bought, which will probably be consecrated by the bishop next

Father Furlong was born in Hartford and was the first native of the state to be ordained to the priesthood. He was appointed rector of St. Bernard's church on December 26, 1873, but owing to illness he was unable to assume his duties here until the twenty-fourth of the January following. At that time he was rector of St. Patrick's church, New Haven, and was transferred by the late Rt. Rev. F. P. MacFarland. For nine years he was alone and in 1883 Father Curtin came as his assistant. The latter remained here nine years and was succeeded by Father Clark, who was transferred last winter to Waterbury.

The parish has grown from 2,000 to 3,000 since 1873 and the church has property valued at over \$80,000. Father Furlong has been the means of organizing many societies in connection with the church, all of which are in a flourishing condition to-day and still grow-

After Thirty Years Service to be Retired.

A meeting of the Fairfield county members of the Connecticut Teachers' Annuity Guild, was held at the High school, Bridgeport, on Saturday afternoon. Sipsco Stevens was elected chairman, Miss E. F. Eames of Bridgeport, secretary, and W. W. Porter of Bridgeport, trustee of the Guild for Fairfield county. Mr. Williams of Bridgeport, Mr. Comstock of Danbury and Miss Emily Brown of Stamford. were appointed collectors.

Annuity guilds for teachers are in successful operation in other parts of the country, notably in Washington, D. C., in Brooklyn and in Boston. The purpose of these guilds is to retire teachers on half pay after 30 years of service. The Connecticut guild, in the preparation of its constitution, has had the benefit of the experience of other guilds. Already there are several hundred members, largely from Hartford, New Haven and London counties.

Any teacher in a public or private school who joins the guild during the present year has the advantage of having the full term of service counted, but after this year those who have taught 15 years will be ineligible for membership, and those who are eligible cannot count their term of service previous to joining the guild.

Filed for Probate in Greenwich—a Legacy to Stamford Roman Catholic Church.

The will of the late Nicholas Cassidy has been filed for probate in Greenwich. The deceased leaves property estimated at between \$15,000 and \$20,-000, all of which he made in Greenwich since coming to make his home there some twenty years ago. He was not married, so far as is known, and a few months ago Mrs. Yessen, who had boarded and cared for him for several years, placed an attachment on his estate for \$2,500 to compensate her. The deceased, however, provided for her in his will. He also leaves a portion of his estate to a sister and to the short outline of the most important necker. CHEATED THE NOOSE.

Down in Alabama they tell a strange story about a man who succeeded in cheating the gallows by a clever ruse. As he lived a respectable life afterward, and some of his children are still living, his real name is not given. We will call him Dever-

William Devereux was a rising young lawyer of good family, married to an accomplished wife, and possessed of a large number of admiring and devoted friends. Indeed, he was one of those magnetic persons, having the fortunate faculty of making strong and loyal friends of nearly all who came in contact with him.

But in the town where he lived there was considerable dissipation of a certain kind. Devereux became a member of a choice circle of card players. He lost money of others with which he had been entrusted. For a long time he managed to keep this state of affairs concealed by a sort of system of robbing Peter to pay Paul, and to meet his obligations as they matured. But a period came when William Devereux realized that these things could be concealed no longer, and the day of exposure and disgrace came ever nearer.

It was in the old--fashioned times, when there were no railroads, no telegraph, no means of travel, save over ill-kept roads, generally on horseback. It was before the day when drafts, bills of exchange and similar banking conveniences for facilitating money transfers had reached anything like modern perfection, and payments were made at a distance by sending the money itself.

It was also the custom of the various county collectors and treasurers to make yearly trips to the state capital, carrying such moneys as had been collected in their districts on be-Half of the state and the necessary vouchers, and have an annual settlement for the year's receipts and disbursements.

Now, at the time when Devereux's affairs were most desperate, his own county treasurer started out on horseback with the state money, a large sum, in a pair of saddlebags, to effect his annual accounting.

On the road he was joined by a fellow traveler, who afterwards was proved to be Devereux. They put up one night at a roadside tavern, occupying the same room. Next morning the treasurer was found dead in bed, his throat cut from ear to ear. His companion had disappeared, and the saddlebags, with their contents, were also missing. The countryside was aroused, bloodhounds were brought out, and a fierce chase of some hours resulted in Devereux being run down and captured. There was no question but that he had been the murdered man's companion the night before, but none of the missing money or papers were found upon him.

These were the facts in the case. When the news passed from traveler to traveler along the country roads, and finally reached Devereux's home town, there was a tremendous sensation, further heightened when the damning circumstances of his business affairs came to light and made clear the motive of his crime.

Nevertheless, many of his friends were still loyal, strong family influence was exerted in his behalf, the best lawyers were employed, and every effort was made to free him from the consequences of his awful erime. All without avail. He was tried, found guilty, and sentenced to be hanged. The higher courts deeided against him on appeal. The Governor refused to interfere, and Devereux occupied a cell in the jail in the little town of St. Stephens, closely guarded, within a few days of the date appointed for the date of his execution, with all prospects of escape seemingly cut off.

In spite of the enormity of his crime there began to be a great deal of sympathy for the man who lay in jail awaiting death. His youth, his handsome face, his graceful, dignified bearing, his calm courage, his perfect manner and his unfailing persistence in the declaration of his innocence, all combined to produce this effect. He expressed no animosity toward witnesses, judge, jury or prosecutor, simply stating that he was an unfortunate victim of remarkable circumstances, from which he could blame no one for drawing the mistaken inference of his guilt.

Not many days before the fatal day the sheriff found the prisoner visibly agitated and in an excitable state, noticeably different from his usual calmness. In answer to the officer's question as to the reason, Devereux gave the following explanation:

"I have had," he said, "a most extraordinary experience. It came to me last night in the form of a dream so real, distinct, and different from the usual hazy dimness of ordinary visions that I believe it to be the premonition of an actual event. I cannot rid myself of this impression. I expect it may seem foolish to you or the result of the broodings and halfwaking imaginings of a man in my condition, but nevertheless I will tell

"Last night I dreamed I was standing on the scaffold facing thousands of people. The scene was as real to me as the actuality itself. I had spoken a few werds of farewell, and was about to resign myself to your hands, when suddenly by the exercise of some new faculty or perception, I saw the real murderer standing in the crowd before me. I never saw him before, and yet I knew him to be the man in who. stead I was to suffer death. He was slight in build, with dark hair and eyes and neatly dressed. His features are indellibly fixed in my mind. With this vecog-nation my dream raded away. There

was no further intimation as to my fate, yet I feel indeed as though God himself had spoken to me and revealed the absolute assurance of His Divine protection."

The narrator's manner was so earnest and impressive that a hope sprang up responsive in the sheriff's mind that something might happen. He was mentally prepared and on the watch for the happening of the mirac-

ulous. The day of the execution was a beautiful, clear, cool October day. Thousands of people were in attendance, and had gathered about the gallows. It was to be a public hanging, and the multitude availed itself of the privilege of seeing a human being choked to death. As has been inti mated, there was much feeling and sympathy for the doomed man, much argument as to the fallibility of circumstantial evidence, and a hundred vague rumors in circulation suggesting his innocence.

At last Devereux stood upon the gallows platform and faced the people. There was no man in all that crowd apparently so cool, so collected. and so much a master of himself. He stepped forward to say a few words of farewell. His voice rang out in the stillness clear, distinct, and perfectly

audible to all.
"Friends," he said, "this is not a fitting time to indulge in vain protestations. I can but simply reaffirm that I am not guilty, knowing well what would be the consequences of a falsehood standing as I am, almost in the presence of my immortal God. I desire especially to relieve any man from the possible thought that he may have misjudged or wronged me, and might have to meet my accusing words before the great tribunal hereafter. It was a human error, the re-

At this moment the speaker stopped short and leaned heavily against the railing. His countenance betrayed terrible excitement. His eyes seemed fixed on some one in the crowd before him, whom he indicated, bound as he was, as well as he could. When he found his voice again he fairly shrieked:

"There he is! The man of my dream, the murderer. Stop him, Stop him!"

He had pointed out a slightly built, almost feminine looking young man, who utterd a hasty exclamation and attempted to get away, but before he could do so he was roughly seized and held by the crowd. The sheriff, almost beside himself with excitement, rushed down from the scaffold, followed by a half dozen deputies. The young man was hurriedly searched there and then. Upon his person were found a watch, a pistol, and certain papers of value well known to have been the property of the murdered treasurer. He seemed to give up at once, and in answer to excited questions sullenly responded:

"Well, it seems you have me. I was a fool to come here. I demand of the officers protection from this

Protection was needed. Like quicksilver a knowledge of the matter seemed to have permeated the whole multitude. An innocent man was saved and the guilty apprehended in the nick of time. Cries of "Hang the scoundrel," "Turn Devereux loose," arose from all sides, while the officers struggled fiercely to withstand the surge of the angry mob. There is no knowing what might have happened had not Devereux's voice arrested the movement.

The mob poured up the gallows stairs and cut the ropes that bound Devereux. The jail officers hurried their prisoner to the jail. Once there the latter made a full confession, which soon became the talk of the streets. Nothing could be done that was too good for Devereux, who at first busied himself in counseling moderation, and being satisfied of its accomplishment, simply asked for two things. He wanted to go at once, he said, and bear the glad tidings back to his wife. For this purpose he requested the loan of a good horse and some money, a request which was enthusiastically gratified. At sunset Devereux was miles away.

In the morning the new prisoner spoke to the sheriff when that officer was making the rounds of the jail. "I think now," he said, "you had better let me go."

The display of assurance caused the sheriff to think the prisoner crazy.

"I mean what I say," he persisted, "send a woman here, your wife. I am not what you think me. I am a woman. I am William Devereux's wife. My purpose is fulfilled; I have saved his life, and he is now far away. You can never catch him. He sent me word where I would find the things you found on me, and I used them to deceive you."

It was true. Devereux's prison manner, his talk, the dream, the denouement at the gallows were all parts of a skillfully worked and successful plot. The chivalrous spirit of the time and country saved his wife from any punishment. Devereux vent to California, changed his name, was joined by his faithful wife, prospered greatly, and died not many years ago, the leading citizen of a thriving village that bore his false name.

PATRIOTIC PALMER.

Speaks Golden Truths on the Opportunities of Youth.

NO CLASSES EXIST IN AMERICA.

Talk About Goldbugs Will Perish, but Bright Young Men Will Continue to Win Success, Thereby Becoming Goldbugs-A Candidate for Principle Alone, and the People Will Indorse His Modest Claim by a Heavy Vote.

Never has a more representative or intelligent audience gathered in the Academy of Music at Philadelphia thau assembled there Sept. 26 at the grand ratification meeting to honor the standard-bearers of the National Democratic party-Gen. John M. Palmer and Gen. Simon B. Buckner-men who had the courage to say they have no hope of personal preferment, but are making the fight for the sake of the principle. BYNUM'S BRAVE WORDS.

Free Silver Would Destroy Our Credit Now Based on a Gold Standard.

At the great Palmer and Buckner ratification meeting in Madison Square garden, New York, intense interest was elicited by the outspoken utterances of Hon. William D. Bynum, chairman of the National Democratic committee. Mr. Bynum held the rapt attention of the audience for an hour and a half. Among his most forceful utterances wers the following:



CHAIRMAN W. D. BYNUM. "Mr. Chairman and Fellow Citizens After thirty years of earnest, continued service in behalf of Democratic platforms and Democratic candidates, I find myself unable to give support to that platform and that ticket which

was nominated at the so-called Demo-

cratic convention at Chicago, (Ap "I find myself unable to support the nominees of that convention, because I do not believe that they are Demo-

the platform adopted at Chicago, because I know it is not Democratic. "All our money, including silver, circulates not only throughout the Unit-

ed States but all over the world on a parity with gold, and what the National Democratic party which assembled at Indianapolis and promulgated a platform and nominated a ticket insists upon is that all this money shall be maintained at a parity with gold.

"Now, if under the act of 1792 and under the act of 1834, this government was not great enough or strong enough to bring the commercial value of the two metals together, by fixing a coinage ratio that was within 3 per cent. of the commercial ratio, how could we do so by opening our mints at a fictitious ratio where one metal was worth twice as much as the other? (Applause.)

"Mr. Bryan has a great deal to say about bimetallism. Why, we are the only true bimetallists in this country. The only way bimetallism can maintained is by making our silver money at a gold standard. (Applause.) No man that regards the integrity and honor of this country will be afraid of the gold standard.

"While we might get away from the gold standard in our domestic transactions and in payment of home debts, when we come to carry on our great trade and commerce with Europe we will have to come back to the gold standard; the gold standard that fixed the price of our commodities abroad would fix it in gold at home. (Ap-

"Now, Mr. Bryan talks about the appreciation of silver to a parity with gold. The par value and the mone-tary value by the gold standard of an ounce of silver is \$1.29. Mr. Bryan insists that with free coinage the value of an ounce of silver, which is now less than 70 cents, would appreciate until it commanded in the market \$1.29 an ounce. If that be true what becomes of the theory of the Populists that we are going to have cheap money under free coinage? (Applause.)

"The Sherman law was the true test as to whether the consumption of the American product by the American government would appreciate the value of silver to a parity with gold. Under that law, after the speculators got through, the price of silver went down, down, down, lower than it ever

"It is said that silver is the poor man's money. It is no more the poor man's money than it is the rich man's money. It is the money of small transactions, and the transactions of the poorer class of people being generally small, it is the money almost exclusive ly used by them, and therefore I want it to be as good as the dollar that is used by the rich man." (Applause.)

IN TOUCH WITH THE SULTAN.

The German Government In Spite of Public Opinion Will Support the Status Quo In Turkey-A Case of Startling Military Brutality.

BERLIN, Oct. 19.—During his brief stay in this city and Potsdam, it is understood M. Shishkine, the Russian acting minister of foreign affairs, gave Emperor William and the chancellor, Prince Hohenlohe, a full account of the visit of the czar and czarina to France, coupling therewith assurances that the Russian-French entente is entirely of a peaceful nature. His majesty is reported to be wholly satisfied with these statements, but persons who were present at the dejeuner given by Prince Hohenlohe to the Russian guests declare that the German chancellor is not free from suspicion.

The emperor, however, speaking to the

Russian embassador, Count von Osten-Sacken, after the departure of M. Shishkine, said:
"Nothing, I am sure, will occur in the

near future to disturb those amicable rela-tions with Russia which I cherish so

To Support Turkey.

There is a growing feeling of dissatisfaction in Germany at the policy of the government toward Turkey. Crumbkow Pasha (the German officer in the Turkish service who brought to Berlin a letter of thanks and presents from the sultan to the emperor for the latter's picture, sent to Abdul Hamid shortly after the massacres at Constantinople) is reported to have convinced Emperor William at an audience on Wednesday, that Abdul Hamid intends to do his utmost to restore order and preserve peace in his dominions.

The emperor was greatly touched at re-

ceiving the sultan's costly presents. Prince Bismarck also received two priceless vases from the sultan sent him by courier, with an autograph letter from Abdul

Hamid thanking the prince for his sympathy during the recent troubles.

It is considered certain that the German government will continue to support the status quo in Turkey, but the entire Lib-

eral press strongly condemns this policy. The Vossische Zeitung pooh-poohs the idea of Turkish reforms and says: "Every province must be put under foreign administration. That is the only remedy."

Military Brutality. An extraordinary instance of military brutality has occurred at Karlsruhe. A workman on entering a cafe accidentally pushed the chair of Lieutenant Morned von Bruesewitz, who demanded an instant apology. The workman, who was not aware that he had given offence, declined whereupon the lieutenant drew his sword, attempted to run the workman through the body, but was stopped just in time by the landlord. Then the workman tried to escape, followed by the officer, who over-took the fleeing man when the latter's way was barred by a locked door. The lieuten ant, who was intoxicated, no sooner reached the workman at the door than he ran him through the back and killed him. No proceedings have yet been taken against the officer, whose punishment anyway is likely to be nominal, on the ground that he vindicated his honor. The affair has excited the utniest indignation.

A case similar to that of Lieutenant von Bruesewitz who, as detailed above, killed a workman who had accidentally annoyed him by running the man through the back with his sword, occurred recently at Man-heim, and the Liberal members of the city council there are petitioning the govern-ment to forbid officers and private soldiers from parading the streets with deadly weapons.

His majesty has pardoned Captain Rott-berg, who killed a merchant named Lehnkering in a duel in Duisberg, after the culprit had served five months out of his two years' sentence.

The Tariff Conference.

The Russo-German tariff conference will open shortly at St. Petersburg, and it is believed that a settlement of the differences will be reached before the end of the year. Russia's important concessions will be the lowering of freight rates on Russian railroad lines and a more liberal interpretation of the treaty of 1893, which has lately been literally construed to the detriment of German manufacturers. Germany, on her part, will cease the excessively stringent hygienic supervision of Russian cattle, meat, cereals, etc. These stringent regulations have almost destroyed the Russian meat import trade.

The government is preparing a bill to fix a graduated scale of taxation for all firms doing an annual retail business of 100,000 marks and upward, excepting those dealing solely in agricultural products. The diet has already rejected a similar bill, but the Agrarians believe it can be passed through the reichstag.

Mr. George Keenan, the United States consul at Bremen, will give an official banquet on Oct. 28, the centenary of the establishment of the consulate at that port. The senate of Bremen, Mr. Uhl, the members of the United States embassy here and a number of American consult will be present.

Twenty-six American women have ma-triculated for the new term of the Berlin

university.

The United States embassador, Mr. Edwin F. Uhl, has recovered from his attack of rheumatism and gave a farewell dinner resterday to Lieutenant Charles E. Vreeland, the United States naval attache.

Manitoba's School Question.

OTTAWA, Oct. 19 .- The cabinet has had conference with the members of the Manitoba ministry on the separate school question. The terms of settlement, it is said, are as follows: Manitoba is to retain her national schools. They will not be disturbed. Some concessions have been made to provide for religious instruction in the schools after school hours, and where Catholic children predominate Catholic teachers will be employed, but all teachers must have certificates of qualification, and the schools will be under government in-

Halfback Dibble Insane.

NORTH ADAMS, Mass., Oct. 19.-C. W. Dibble, aged 22 years, Williams, 1900, and the phenomenal halfback of the football team, became suddenly insane yesterday. His ankle was sprained in the game of Oct. 10, and since then he has resided with relatives in this city. He has complained of a headache since the Harvard game of Oct. 3. His physician thinks he is suffering from an abcess on the brain and that his recovery is doubtful.

The Cuban Revolution.

It is now twenty months since the rebellion broke out on the Island of Cuba. Starting with but a handful of men, the rebellion has reached all the dignity of a revolution, and now, in addition to having possession of two-thirds of the Island, has two distinct armies, neither of which General Weyler, with all his immense army, dares to seek and

Desperate efforts were recently made by General Weyler to dislodge and disperse the force of General Maceo, resulting only in a series of disastrous battles, leaving Maceo entire master of the situation. In short, it is now cleary demonstrated by the uniform failure of the Spanish troops to destroy the insurgent armies, that what began as a rebellion is now a revolution, and that Cuba can never be restored to the domination of Spain.

If this were an ordinary war, conducted on the principles of civilized warfare, there would be no need for interposition from any of the leading nations of the world, but it has long since degenerated into a war of barbarism, of devastation of property and inhuman butchery of both soldiers and non-combatants. In no conflict of the e-ntury has there been such fiendish barbarism exhibited as marks the record of the Cuban insurrection, and for which Spain is chiefly responsible to the world.

It may now be accepted as settled be youd dispute, that Spain cannet conquer and again govern Cubs, and yet Spain is sending vast numbers of fresh troops to the field only to be decimated by disease and to be killed or maimed in the savage warfare that prevails. It is demonstrated that neither Gomez cor Maceo can be successfully attacked by sel the power that Spain can send there and with scores of thousands of lives already sacrificed, millions of property destroyed and no prospect whatever of conquering the rebellion, it is the imperative duty of civilized nations like the United States, France and England, to interpose and halt this blot ugon the civilization of the age. We do not want Cuba, nor do any of the other nations, but every consideration of individual, national and international justice demands that the hand of Spain should be stayed and that this fiendish watfare should cease.

The now reasonably assured election of McKinley will bring with it the verdict of the American people in favor of a more aggressive attitude in support of the Cuban insurgents. Spain should see the handwriting on the wall, and, while it is yet within her power to retire from the contest without hopeless dishenor and bankruptcy, she should open the way for the peaceful surrender of an island that she can no longer govern. It is inexorable fate that Cuba shall be free from the grasp of Spain, and continued warfare on the partoff the Spanish Government is simply wanten murder.

Skies Brightening.

As the time draws nigh for McKinley's election the financial and business skies brighten.

September statistics of our foreign commerce beat the record. The exgort for the month, surpassed those of any September in our history. They muzeunted to \$55,000,000, which is nearay \$26,000,000 more than for September of last year, and \$2,000,000 more than an the September of the phenomenal year of 1891, when the demand for American breadstuffs carried our total REBURI exports for the only time up to a billion of dollars.

The remarkable feature of this year's showing is that the increase is not in one month alone nor in breadstuffs only. Indeed, there was less wheat exported last month than in September, IBM, the largest percentage of gain being in manufactured products, The Ectal merchandise exports for the nine

months ending with September amount to \$666,000,000, or \$108,000,000 more than in the same nine months of last year, while the imports were but \$522,-000,000, or \$79,000,000 less than last year.

With an excess of exports of merchandise amounting to \$144,000,000, to which must be added \$38,000,000 in silver, it is not surprising that the net exports of \$44,000,000 in gold in the nine months of 1895 have turned this year to an excess of \$9,000,000 in gold imported, with the stream still flowing



Suggestions that Help in Selecting Fashionable Garments.

The eternal question of how we shall be clothed comes rapidly to the front with interrogation points galore now that pale tints are fast losing their charm; and what is going to be the prevailing fashion is the subject of vital importance to the daughter of Eve. Each one is temporarily waiting to be instructed anew in the art of dress as applied to the latest fashions, but as yet there are no very radical changes in sight. Purple and red are both colors that will put in an appearance this season. Another feature of styles is that the seams will all be defined in the cloth or tailor-made gowns either by stitchings or broad stitched strappings. Fur boas are much shorter

THE POLITICAL ARENA

Chairman Hanna Wants a Profuse Display of Stars and Stripes.

HE SUGGESTS A "FLAG DAY."

A Request That All Who Intend to Vote the Republican Ticket Hang Out Old Glory on Oct. 31-An Important

Conference With Watson.

CHICAGO, Oct. 19.—Chairman Hanna of the Republican national committee has suggested a "flag day" in the campaign. He believes in the efficiency of the display of the stars and stripes and today promul-gated the following as a suggestion to a good citizen:

The American flag has been in the pres ent campaign the emblem or insignia of national honor. Its influence has been for great good in the cause of a good people.
Its display in many places has been potent
in the advancement of the country's battle
for the maintenance of its honor at home and abroad. I therefore suggest that on Saturday, Oct. 31, all who intend to vote on Nov. 3 for the preservation of our na-tional honor, for sound money and the advancement of our people's interests and general prosperity, display the national col-ors at their homes, their places of business and wherever they may be seen, in order that voters whose hearts are for their country may be strengthened in their purpose and those who are undetermined may the more patriotically and intelligently conclude how best to perform their duty as citizens.

It is further stated at the headquarters of the Republican national committee that state, county and city committees and clubs encourage the display of the na-tional flag on the last Saturday in the campaign in every part of the country, especially on residences, and have flags and bunting on sale at convenient places for farmers and others who live in out of the way places.

Massachusetts Democrats.

Boston, Oct. 19.—The state ballot law ommissioners have decided against Hon. George Fred Williams and his followers, and declared the state convention held in Faneuil hall by the regular state organization of the Democratic party as the legal one. The nominees of the Fancuil hall convention will accordingly be placed on the official ballot. Although Mr. Williams was against the state committee, the convention held by the latter placed him on the head of the ticket, and the decision will not affect his name on the ballot unless he withdraws, which seems possible.

In fact the nominees of both the conventions held by Mr. Williams' followers at Music hall and the one at Faneuil hall named the same ticket with one or two exceptions, so that the contest before the commission was solely for the control of the state organization.

The meeting of the Democratic state central committee to name the successors to the "Gold" members, who resigned some time ago, developed such a flerce out-burst of feeling between the two factions that fist fights were narrowly averted, and the meeting adjourned in confusion without reaching any decision.

To Win Over Watson.

ATLANTA, Oct. 19.-It is confidently asserted that an important political conference is on the carpet here and that the par-ticipants will be Thomas Watson, the Populist vice presidential candidate, and Chairman Jones of the Democratic party or one or more of his trusted lieutenants. It is said that an understanding has been arrived at that is satisfactory to Mr. Wat-son, and that all indications now are that in a short time Mr. Watson will be stump-ing the state of Kansas for William J. It is not known whether or not Mr. Watson has in any way changed his position on the question of fusion, but it can be safely predicted that some arrangements satisfactory to Mr. Watso made, or if not satisfactory, at least such as he will tolerate, and give his active cooperation in defeating McKinley. In case the conference results in a union of forces Mr. Watson's letter of acceptance to Marion Butler will be suppressed.

May Be Trouble In Chicago.

CHICAGO, Oct. 19. - The Democratic silver managers declare no permit is necessary for their parade on Oct. 31, and hence they are determined to parade without one. A decision to this effect was reached by the managers last night after hearing legal opinion on the point involved. Chief of Police Badenoch does not show any sign of receding from the position he took on Friday when the Democratic leaders asked him to give their parade preference over the McKinley workingmen's clubs parade announced for the same night, Oct. 31.

"I do not intend that any parade shall take place without a permit," he said. "It is plain on the face of it that in the present excited state of the public mind two parades cannot go over the same ground with a brief space between them and leave us safe in the consciousness that trouble will not result."

The Vote In Georgia.

CHICAGO, Oct. 19.—A dispatch has been received at Democratic national headquarters from Atlanta, addressed to a member of the national committee and of the Georgia state central committee, saying that the official count of the vote in the late state election in Georgia showed that Atkinson for governor had 36,100 plurality. The remainder of the state ticket was elected by an average of 52,300. The Democratic majority two years ago was 24,161, showing a Democratic gain of 28,119 over the vote of 1894. The 52,300 shows the regular state ticket majority, while Atkinson ran behind the balance of the state ticket for local reasons.

Hoar Attacks Fairchild.

BOSTON, Oct. 19.—In his speech before the Norfolk club Saturday Senator Hoar made a sensation by denouncing ex-Secretary Fairchild, who spoke the night before at the Reform club, and said that his (Fairchild's) revival of the old charge that President Grant packed the supreme court of the United States in order to get a reversal of the legal tender decision in 1873 was as vile a falsehood as ever came up from the campaign stump, and that he considered it an attack upon the honor of his brother, the late Judge F. Rockwood

Massachu its Populist.

Boston, Oct. 16.—The Populist party in this state will have a ticket on the c d-cial ballot after all. When their list of signatures to their nomination papers v as filed at the state house, it seemed to be 19 names short of the legal number required. Investigation showed that a number of legal names had been thrown out by mistake, enough to affect the result. Revisions made by election boards in three cities showed that there were 1,011 names signed, 11 more than sufficient under the

Altgeld In New York.

NEW YORK, Oct. 19 .- The reception given to Governor Altgeld of Illinois by the German Democrats of this city was one of the most remarkable demonstrations of the campaign here. Cooper Union was crowded to the doors and thousands were massed in the streets outside. Governor Altgeld spoke two hours in the hall and then made a short address in the open air. At both meetings he received a tumultuous ovation.

Did Not Indorse McKinley.

WASHINGTON, Oct. 19.—The national officers of the Union Veteran legion deny that in secret session they passed resolutions indorsing McKinley and Hobart. His parents wished him to become a business man and he was allowed to get a position in a drug store here. The boy was a model clerk.

He acquired the cigarette habit, but at first nothing was thought of it. Finally he became such an inveterate smoker that his parents became alarmed. Six months ago it was evident that the habit was impairing him physically and mentally. All efforts to break off the terrible habit proved vain. The family physician tried every known remedy, but Henry could not give up the deadly cigarette.

From a robust country boy he had become a mere skeleton. A few weeks ago he manifested symptoms of insanity. At the earnest solicitation of the physician his parents consented to have him removed to the Trenton insane asylum in hope of benefiting him. Yesterday he was taken there.

If, however, you enter any one of the exchange shops in Tokio, Yokohama, Kobe or Nagasaki, and hand over a \$10 Japanese gold piece, or an American \$10 gold piece, the dealer will return to you without hesitation and as a matter of business, not ten silver dollars, but \$19.50 in silver. If you hand him ten silver dollars and ask for gold he returns to you about \$5 in gold. In spite of the ratio of 16 to 1 established by law, the dealing is put entirely on the commercial ratio, and no one disputes it.

The Japanese who use foreign prod-ucts see the difference when they are compelled to pay 60 cents per pound for coffee and 75 cents per pound for American butter.

Many industrious and honest workmen believe that a government has the power to and can control the ratio between the metals. But when they clearly comprehend that the great Japanese nation cannot do it, it opens their eyes. Moreover, Japan is almost entirely independent of foreign nations, so far as imports are concerned. The people live on the home markets, and export much more than they import.-Correspondence of the New York Post.

Still more grave for the bishop's peace of mind if the story be true, she entered the Catholic communion a year ago secretly, and not until two weeks ago did she muster enough courage to tell her fam-

So, while the Right Rev. Henry C. Potfer, hishop of the Protestant Episcopal di-opese of New York, has been making bit-ter attacks on the recent encyclical letter of the pope, one of his own family has become a devout believer in the infallibility

of the Roman pontiff.
Florence Thompson, "Flossie" was the bishop's pet name for her, is the youngest child of Mrs. Launt Thompson, who, before marriage, was Maria Potter, the bish-

At the time of her marriage 25 years ago Launt Thompson was called a rising young sculptor. He continued to advance in his profession until he was among the foremost of American sculptors. The pursuit of his art took him to Florence, where he made his home until his death five years

Conscience Her Guide.

His widow chose to remain there with her three children. They have a beautiful house in Florence, where they entertain extensively. They are received in the best of English and American society.

Florence Thompson is now a beautiful

girl of 18. She has inherited from her mother the brains of the Potters and from her father great artistic talent. When Bishop Potter has gone abroad, his sister's home invariably has been the objective point of his visit, and of the children Florence was the dearest to him.

Moving in the society of an Italian city, it was to be expected that the young girl should have many friends and acquaintances in Catholic families. Ecclesiastic of the Roman church, however, were excluded carefully from Mrs. Thompson's

list of friends.

What perplexes her family most is the question of who influenced her to change her belief. While the girl had been reared in the bosom of the Episcopal church, three of her uncles being clergymen in that denomination, she herself says that she long had been in doubt as to the true

That she was impelled to the change of faith by her own conscience was the only explanation she gave her mother when she confessed to her two weeks ago that she had been a Catholic for a year...

May Go Into a Convent.

The young woman remains firm in her determination in spite of all the pressure that has been brought to bear to get her to return to the faith of her fathers.

It is even hinted that she may join some religious organization rather than endure the unpleasant home life that may result

from her change in faith.

As soon as Mrs. Thompson learned of her daughter's conversion, in great agony of mind the wrote to her brother, the bishop, for advice. He, too, so says the story, was perturbed by this act of treason to the family traditions, and was hurt not a little to think that his niece had not gone to him for counsel before taking the

decisive step.

Not alone about the young woman's action are the Potter family worried. Lanceilotto Thompson, Florence's brother, has given them another shock by becoming a naturalized Italian citizen. He has announced his intention of devoting his life to educational work among the poorer

HENRY E. ABBEY'S FUNERAL.

The Services Will Be Private and the Interment at Northampton, Mass.

NEW YORK, Oct. 19. - John B. Schoeffel, for many years the business associate and personal friend of Mr. Abbey, is in charge of the funeral arrangements. He said last night: "The services will be private, and will take place at the church of the Paulist Fathers at 9 o'clock Tuesday morning. The body will be taken from the church to the Grand Central depot for interment at Northampton, Mass., where Mr. Ab-bey's first wife (nee Kate Kingsley) was buried, as was also his son Henry, died two years ago at the age of 14. Only immediate relatives will accompany the remains to the place of burial.

Mr. Abbey died a Roman Catholic, he having been baptized and received into the Roman Catholic faith two hours before his death. Father McMillan of the Paulist church performed the baptismal ceremony, and at the same time almost administered the rites of extreme unction. The conversion was brought about by the fact that the dead man's son, Henry, was a devout Roman Catholic in his lifetime, and as Mr. Abbey was devotedly attached to his son, he has often said he would fol-low the boy's example and die a Roman Catholic. Mr. Abbey did not lose con-sciousness up to the hour of his death, and was fully aware of all that was passing around him.

George L. Reeves, attorney for the Met-ropolitan Opera House corporation, stated last night that Mr. Abbey's death will not work any change in the prospectus of the Opera House for the coming season. It is not intended to nominate a successor to Mr. Abbey in the directorship at present, as the remaining members of the firm will be able to carry out all the plans outlined.

"Substantially all the conditions," said Mr. Reeves, "of the plan of agreement entered into by the creditors will be carried out. By the plan mentioned the indebtedness of the firm is to be paid, 40 per cent in preferred stock and 60 per cent in notes. This anticipates the payment of 100 cents on the dollar."

THE WAR IN CUBA.

Arrest of Three Alleged Delegates From

the Insurgent Junta In New York. HAVANA, Oct. 19.—The police of this city have arrested two white men and a mulatto, said to be delegates from the insurgent Junta in New York. They are also charged with conspiring to blow up buildings by the use of dynamite in order to afford an opportunity to create a panic and plunder the city. One of their accomplices is said to be implicated in the explosion at the governor general's palace in April last, but there are said to be 32 men engaged in the plot, some of them being in foreign countries and others already in

the African prisons of Spain.
In an engagement which has just taken place between the Spanish troops under General Aguilera and the insurgents under Delgado the latter lost over 100 killed, among them being Dr. Luis Delgado.

The report that Celestino Bencomo, the insurgent governor, has been killed in a skirmish at Purial, province of Santa Clara, is confirmed.

In a Cuban Jail.

WASHINGTON, Oct. 19.-The state department has been urged to find and if possible extend aid to an American citizen supposed to be lying in a Cuban jail. Nov. 28 last year, Matthew Kersey, a young man from Alexandria, Va., shipped on the steamer Mascotte from Baltimore for It was generally understood that it was his intention to form one of a party of filibusters. His friends waited in vain for any news of his movements until recently, when they heard from a person just returned from Cuba that Kersey was lying wounded in a Spainsh jail.

Henry D. Clayton Removed.

WASHINGTON, Oct. 19.—Attorney General Harmon sent the following telegram to Henry D. Clayton, United States attorney for the middle district of Alabama, at Montgomery: "For reasons appearing in our correspondence the president has toy removed you from States attorney, which you now hold. You will govern yourself accordingly. Answer to your letter mailed today." Clayton is a candidate for congress, and this telegram is the outcome of a brief cor-respondence between him and the attorney general relative to his course in view of the well known rule of the department, which makes such candidacy inconsistent with the holding of his position of United States attorney. Mr. Clayton is a sonin-law of Senator Pugh of Alabama.

A New Railroad War.

CHICAGO, Oct. 19 .- The Joint Traffic association has declared a joint boycott against the Clover Leaf, and all roads in the association have been ordered to cease all business with it after Oct. 22. None of its tickets will be accepted for transpor-tation over any of the Joint Traffic association roads after that date. The reason for the boycott is declared to be the action of the Clover Leaf in cutting rates and giving sleeping car and chair privileges to the holders of second class tickets.

The Famine In India.

LONDON, Oct. 19. - The famine in northern India, which now appears to be inevitable, causes the greatest anxiety here, and it is recognized that the import of American wheat is likely to be the prime factor of the situation. Prices in the affected districts have risen considerably, and the Californian wheat en route is sold in advance at higher prices than the native wheat, indicating the conviction that prices will have risen still higher by the time the imports arrive.

Suicide Dehaan's Body.

TORONTO, Oct. 19.—The body of Jacob Dehaan, the Cornell university student who, under the name of H. Nanta, committed suicide at the Queen's hotel on Sept. 23, has been placed in a vault in St. James' cemetery, where it will remain for an indefinite period, in the expectation that deceased's brother, Dr. Dehaan of the Johns Hopkins university of Baltimore will take charge of it.

Held Up the Whole Town.

GUTHRIE, O. T., Oct. 19.—At 9 o'clock last night a band of six unknown desperadoes rode into Carney, 20 miles east of here, and held up the whole town, robbing 12 stores and the postoffice. The bandits secured several thousand dollars. A posse of about 100 citizens was organized as soon as possible and left in pursuit of the

Colonel William B. Mann Dead.

PHILADELPHIA, Oct. 19.—Colonel William B. Mann, who has been prothonotary of Philadelphia for more than 20 years died last night at his home in this city aged 80 years. He was district attorney of Philadelphia from 1851 until 1875. During all these years he was the recognized Republican leader of this city.

DYCHE ON ALASKA.

The Professor Says It Will Be a Good Country In the Future.

SEATTLE, Wash., Oct. 19.—Professor L. L. Dyche of Kansas returned from Alaska on the City of Topeka and left last night by way of California for his home. Professor Dyche went to Cook's inlet and especially in search of natural history specimens. He ascended to the source o Knick river with an organized expedition which was a success, although the obstacles to be overcome were appalling. The native boatman, stripped stark, and with

ropes pulled the boat up the turbulent river. Professor Dyche secured specimens of a mountain sheep, 12 immense moose heads, carriboo, sea otter, birds and other small animals. On July 17 Professor Dyche saw eight inches of snow fall and on Aug. 11 six inches fell. He saw three on Aug. 11 six inches fell. He saw three smoking mountains and experienced an earthquake such as a man could not re-main standing during. He found large coal ledges, but the coal was so soft that it could be whittled with a knife.

Professor Dyche said: "That country is

FRANCE AND ENGLAND.

They May Have a Little Squabble Over

Their Interests In Marocco. LONDON, Oct. 19.—The outrage upon a French merchant ship by Moorish pirates has attracted attention, as it is feared in certain circles that France will do what Great Britain would undoubtedly do under the circumstances, seize the opportunity to increase her influence in Marocco. Two French warships have been dispatched to support the minister of France, who has presented an energetic note on the subject to the Moorish government.

The Globe thereupon says: "It is worth while keeping an eye upon the French in Marocco. For years past they have been intriguing there and maybe they have bar-gained for a free hand in Marocco as the share of the advantages of the Franco-Russo entente."

In the meanwhile the news has been received that a British felucca has arrived at Gibraltar, and reports that she has been pillaged of her entire cargo by Riff pirates. This, it will be observed, is an opportune incident, and one which should not fail to give Great Britain an excellent opportunity to see that her own interests in Ma rocco are not neglected.

Treasurer Walker a Defaulter.

AUGUSTA, Ga., Oct. 19.—A shortage of Berrien Walker, treasurer of the Port Royal and Augusta railroad under the recent receivership, has leaked out. He is \$28,717 short and is vow in Canada or Europe. He got leave of absence some time ago, and when he falled to report back sus-ption was excited. An inspection of the books discovered the embezzlement. Walker had a bond with the American Surety company for \$10,000, and the receiver, who is under \$120,000 bonds, is responsible for \$18,517. Mrs. Walker left a day or two ago for New York, presumably to join her husband. Detectives are following her.

A Famous Chess Player Dead.

NEW YORK, Oct. 19.—W. H. K. Pollock, the celebrated chess player and chess editor of the Baltimore News, died at Bristol, England, on Oct. 5. He was 37 years of age, and had resided for many years in this country. Pollock first came to America as one of the British representatives at the sixth American chess congress. His playing was brilliant at that time, and since then he has figured in many of the great chess matches, both na tional and international, among the latter the Hastings tournament of last year.

The Lord Li Rumor.

WASHINGTON, Oct. 19.—The Chinese legation here has no information concerning the report from San Francisco that Lord Li will succeed Yang Yu as minister to Washington. The present minister has served about four years, which is the usual term in the Chinese service, but it has been expected that he would be reappoint Lord Li has served as secretary to the legation at London and as minister to Ja pan. His assignment to the United States doubtless would be a mark of special favor.

WEBSTER, Mass., Oct. 19. - William M.
