OF A VOLUNTEER OFFICER IN THE BY CAPTAIN W. C. STAPLES.

CHAPTER VI.

[To be continued.] We had two good chronometers on board, and according to an old navy regulation had to rate them ourselves. Two young ensigns, just graduated from the naval academy, had been ordered to the ship, and Captain Parker ordered them to help me with this duty. We first went to the tall flag staff in the navy yard as the latitude and longitude were determined at that point, but found so much difficulty in using the artificial horizon on account of the tremor of the ground made by passing teams, that I went to the ordnance officer of the navy yard and stated the

Each ship had a station assigned her, or a beat of a mile, or perhaps more, according to the number of ships. The ship would then slowly steam up and down on her sible that each ship could be kept on her own beat in the night, but it was seldom they got over the line on the next vessel's station. The watch officers got so used to keeping the ships in their position that t was an unusual occurrence when they got over their limit of ground. On one occasion the "Shenandoah," Captain Ridgely, who was then senior officer on the station, got down on our cruising ground. It was a very dark and thick night, and we were standing to the southward. The first intimation we had of her approach was that she crashed into our stern, firing off the port-fire attached to our life-buoy, smashing one of our boats and damaging our upper works considerably. After she had backed off clear of us her executive officer hailed us and wanted to know what ship we were, how much damage, etc. Captain Ridgely, who had got on deck, then took a hand. He said the first thing to us: "You are off your station. Your are on our station, sir." Captain Parker was sik at the time, and I was acting as executive officer. I answered and said I thought not, and that we were on our station, and about

the middle of it at that. He hailed back : "Go on your station at once, sir." I answered and said, "Very well, sir;" then turning, I hailed the officer of the forecastle and asked, "Is that starboard anchor ready, sir?" The answer was "All ready." Then I gave the order: "Stand the starboard anchor." Then I turned towards the "Shenandoah," hailed her and said: "You will find us here on our station in the morning, sir." Sure enough in the morning we were about in the middle of our cruising ground. I suppose if I had been in the regular service I would not have answered as I did, but I was determined that neither the other officers or myself should be blamed for the faults on board of the flag ship. 

Mr. Hyatt Returns. The Hon. James W. Hyatt returned to Norwalk to-day, (Tuesday), from Washington, D. C. He is happy as a lark, but-oh! so close mouthed! He expressed himself as perfectly at ease as to the matter in connection with which he has come in for such extensive notoriety and discussion, and says Barnum is also serene. He would not talk about his conferences with the officials in Washington, however, nor deign a hint as to the result of his visit. He does say, though, that he spent a very pleasant hour in the company of President Cleveland, whom he enthusiastically pronounces a genial, companionable, pleasant fellow. He was pestered to distraction by persistent and omni-present newspaper men, who came in droves to interview him, and it was probably to his Washington visit and experience that his present caution and reticence in expressing himself are due.

Oliver Hoyt. Oliver Hoyt, Stamford's wealthy, philanthropic and best known citizen, died Thursday afternoon at his home, from injuries received in falling from his carriage while driving a fractious team, in company with his wife last week Monday, Mrs. Hoyt being also injured, but not seriously. The injuries of deceased, were fracture of the collar bone, and internal hurts which resulted in peritonitis and caused his death. His sons from New York were telegraphed and reached home in time to see him pass peacefully away. By the bedside were the family of Mr.

Hoyt, and two of his brothers, William and Mark. His remaining three brothers, Joseph B., Lyman and Harvey, were absent, not suspecting that the end would so scon come. Rev. Dr. James M. Buckley, editor of the Christan Advocate, was informed while aboard of a train, that Mr. Hoyt was not expected to live. He had not suspected that his condition was so serious. Dr. Buckley got off the train at Stamford and hastened to Mr. Hoyt's bedside, which he reached only a short time before he breathed his last. Gathered in the room were Rev. C. H. Buck, pastor of the M. E. church, Rev. Dr. Beach, President of the Wesleyan Univerversity and others.

Oliver Hoyt was born in Stamford on August 23, 1823, at his father's homestead on Noroton Hill, and received his early education in the school of his native town. At an early age he mastered the details of the tanning business, and entered upon the wholesale leather trade in Frankfort street, New York, in 1844, with his brother William, under the firm name of W. & O. Hoyt & Co. In 1849 the present firm of Hoyt Brothers was organized and took up its quarters in Gold street, where it has since remained. The firm's business is one of the most extensive of its kind in the city, and for sound commercial reputation the firm has no superior.

In banking and insurance Mr. Hoyt had since 1854, and has also served as a director of the Citizens Bank of Stamford since its organization. He was for many years connected in the same capacity with the Home Fire Insurance Company and the Phœnix Fire Insurance Company. In 1872 he was one of the Presidential electors for Grant, of whom he was a warm personal friend.

In politics he was identified with the Republican party, but did not accept any official position until 1877, when he was elected to the Senate of Connecticut from his own district. During part of his term of service he officiated as president pro tem. of the Senate, and also served on several important committees. The nomination for Governor of the State was tendered to him in 1879, but he declined. He had been a member of the Union League Club since 1870. General Grant, who was very fond of Mr. Hoyt, urged him to accept a place in his cabinet, and would have given him any position under the government but Mr. Hoyt resolutely declined any and all

offers.
The funeral services were held Monday afternoon at 2 o'clock at the Methodist church, of which deceased was for many years a member. Rev. Dr. J. M. Buckley, editor of the Christian Advocate, officiated, with Dr. Tiffany, of New York, Rev. M. W. Prince, of Brooklyn, and Rev. C. A. Buck, the home pastor, as associates.



STRANGE SCENES IN THE ANCIENT CITY OF BENARES.

Worshipers Bathing Together in the Sacred Waters of the Ganges-The Bathing Ghats-The Funeral Pyre-The

About 500 miles from its mouth on the left ink of the Ganges, the great sacred river of the Hindu people, to propitiate which only a few years ago mothers were wont to offer up babes, is the city of idols and the home of idolatry, Benares. It is to the Hindu what Mecca is to the Mohammedan, and a pilgrimage to it sometime during his life is the cessary journey of every true Indian pagan. Though there are no historical records to prove it, it is generally conceded that it is one of the, if not the most ancient city in the world, and that even when Rome was found-ing Benares was centuries old.

It is most peculiarly native in its streets, its buildings and its inhabitants, and, of all places in India, it is the place to see the aboriginal habits, customs and people. It num-bers its temples in the thousands, but its shrines are so many that no attempt is made to number them. The sacred monkey runs up and down the walls and over the altars of he temple of Durga Kund and the sacred bulls and cows wander about that of Anna-pura and feed on the garlands that the worshipers cast before them. Just outside the city is the spot made sacred by Buddha's e, and the tanks in which he bathed self, his garments, and his religious vessels, said to have been protected from the contion of man by fiery dragons. Benares is the religious seat of India, and might not inappropriately be called the capital of

BENARES' BATHING GHATS. But notwithstanding its many temples and shrines with their wonderful carvings, its little narrow streets and lofty buildings, its curious bazaars, by far the most interesting part of Benares are the bathing ghats as seen from a boat sailing up and down the sacred Ganges. Here one can spend hours and not tire, for there is a panorama as changing as a loscope, and whose pictures are as brilliant as an artist's imagination can paint them, for every day a large proportion of the inhabitants, high caste and low, go down to the river to bathe in and to worship the divine stream as it goes rolling on its way to the ocean, and the banks lined and the water illed with men, women and children are a

sight never to be forgotten. Here an old, gray haired man feebly washes his shrunken legs and arms in the cleansing and divine water. At his side stands a young Hindu matron, whose wet garment clings to her body and show perfectly her well formed limbs. A Hindu dandy, almost naked, sits only a few feet away on the bank combing his long, oily locks and admiring himself in a little mirror, which he holds in one hand. A powerful, athletic looking man stands not far away swinging with all his might a pair of primitive Indian clubs, while a poor old hag comes out of the cold water and exposes her rithered breast to the warm rays of the sun. Little boys and girls run into the water, splash about, and then run out again and roll their wet bodies in the dust or lie down upon the warm stone steps that lead down to the water. On the top step sits motionless a chubby infant whose mother has washed him and set him up there to dry. A DARK HUED APHRODITE.

A young girl walks trippingly down to the edge of the water and daintly puts her well shaped foot, the toes of which are perhaps covered, though not adorned with rings, into the water as though to feel its temperature, and then suddenly draws it out as if it turned out to be a little cold. But at last she plunges boldly in, and that wonderful river that has witnessed more sacrifices or murders than any other body of water in the world reves her beneath its surface, above which a second later she emerges like a young mermaid and, like the dark hued Aphrodite. shakes the drops of water from her hair. a stretcher a dead body, with only a cloth seen distinctly the outlines of the corpse. They pile up wood, place the corpse upon it,

words light the funeral pyre, while the friends and relatives of the dead sit around and watch scrows.

The science of cutting, fitting and trimming the body as it burns in the open air. The wood drops down and one sees a leg half con-sumed or an arm burned in two. But the attendants pile on more wood and the burning and the watching go on. When all has been consumed the last few ashes are cast into the river. Down to the water comes a high caste Brahmin woman clad in brilliant garments and attended by numerous servants, for all alike must bathe in the sacred stream. At intervals along the bank, on raised platforms, sit the priests, by far the most intelli-gent looking of the great throng. And when heads of the devotees with peculiar markings, accept their offerings and encourage them in their idolatrous practices. Off they go to some favorite temple to worship some idol

and make way for the new comers who wish to bathe in the sanctified stream. And the divine river goes on in its course as it has done for centuries, receiving the devotions of the faithful, who wash themselves in its waters, and perhaps rejoicing that a higher civilization has pu' a stop to a practice that made it the unc ascious cause of many a mother's anguist and worship.—Cawapore

The Easter Island Images.
Lieut. Stone, who secured the prehistoric stone image from Easter island for the thsonian institution while attached to the Mohican, stated to a reporter that the image, which is now on its way here, is about 8 feet high, 4 feet wide and 3 feet thick. It is roughly carved or hewed. A head of another image was also secured, and some of the offlcers obtained by purchase other curiosities, which could not be obtained elsewhere, which the Smithsonian will probably take off their hands. The images, he said, are scattered all over the island, although many of them have een thrown from their pedestals and broken. It was customary for the natives to erect them over the cemeteries. They would bury their dead in cells with stone walls on three sides and with an inclined wall of earth in the rear. They would cover over the burial cells and form a top of flagstones to the platform, on which would be placed from three to a dozen images overlooking the sea, according to the size of the platform.

The images were made from conglomerate stone in the side of a crater and hewn with stone axes, and by cutting through a single stratum the image could be easily separated from the next stratum and then moved on an incline and erected. The images are of different sizes, the largest one being about 70 feet long, but this was never removed and lies in its bed in the side of the crater where the work was commenced. The statue secured by the Mohican was found about two miles from the shore. It took about eighty men two days to bring it down on rollers. Lieut. Stone said the present inhabitants know nothing about the images or the fresco decorations of the houses, but they intuitively bury their dead in close proximity to these statutes.—Washington Star.

Good News for the Britishers. Two young men left Chicago a few weeks since to go into business in London, England. They intend starting in the world's metropo lis an American lunchery like those of the Kohlsaats and others in Chicago-places wherein the lunchers sit on high stools in front of big counters and eat sandwiches, bot cakes, pies, pastry, pork and beans, etc., all clean, wholesome and chean quickly clean, wholesome and cheap, quickly served and presenting the attractiveness of an almest endless variety. The young men in-tend making their London lunchery as thoroughly American as possible, with mince pie, cider, pumpkin pie, pork and beans, buckwheat cakes, oyster pies and other dishes dis-tinctively Yankegish. They have a capital of only \$2,500 between them, but expect to reap a rich harvest from their efforts to show the Londoners a few tricks in the lunching line. Chicago, by the way, was the pioneer in this model form of lunchery, and to this day carries on the business in a state of perother cities.—Chicago Herald.

A Very Young Merchant. Some odd facts are occasionally found just beneath a most commonplace surface. Happening in a large hat and cap establishment wholesale—the other day, I inquired for the proprietor. A boy about 11 years old was pointed out to me. "But I want to see the proprietor," I said. "I am the proprietor of store-what can I do for you?" exclaimed the lad. And, sure enough, investigation proved that he was the actual owner of the establishment, and nominally the head of the firm. His father had owned the store, but, having other business as well and not wishing to carry them both in his own name, presented the hat and cap establishment to his 11 year old son and placed the boy in charge. Of course the father still exercises general control, but the legal head of the firm, signor of checks, keeper of the combination of the safe and man of authority is the son, undoubtedly the youngest wholesale merchant n Chicago.—Chicago Herald.





teeth and buried itself high up in his right cheek. It was one of the prettiest shots I saw during the whole war, and the volunteer, al-though seriously wounded, seemed to think it about the finest piece of work it had ever been his pleasure to witness. "The bullet was cut out by a surgeon, as as soon as the patient recovered from the shock which he experienced we melted the piece of lead and cast four of these dimes. The volunteer kept one, another went to his brother, the surgeon kept the third, and I was so fortunate as to become the possessor of the other. So you see this little piece of rebel lead broke a whisky bottle and a human jaw, knocked out seven teeth, and traveled over

600 yards to bathe itself in liquor and gore. Six months after this incident we learned


